

**BOARD OF APPEALS**

Resolution adopted on March 9, 2015

**Established:**

Mobile County Commission created the Board of Appeals by Resolution adopted in the March 9, 2015 Minutes, Agenda Item #53/26E. The Mobile County Commission appointed Mobile County Building Official to administer adopted building codes, and the Mobile County Flood Plain Administrator to administer the Mobile County Flood Damage Prevention Ordinance. They are ex officio members of the Board and have no vote on any matter that should come before the Board.

**Purpose:**

The Board serves as an administrative review Board from the decisions of the Mobile County Building Official and the Mobile County Flood Plain Administrator and to hear and decide on appeals from the same.

**Board Appointments:**

Mobile County Commission appoints Board members. The Board has (7) members which includes one (1) engineer, one (1) architect, and three (3) members at large from the construction industry in addition to two (2) alternates.
