Code of Alabama, Title 38: Public Welfare, Section 38-2-7

Established:

Public Welfare Laws of the State of Alabama, Section 38-2-7, County boards of human resources is created in each county.

Purpose:

To point up unmet needs in the County, to advise concerning economic conditions in the County which might affect the welfare program, to assist informing the citizens of the public welfare program, to cooperate with other agencies, individuals and organizations in the community in the development of facilities designed for human betterment, and to advise concerning changes which would make for a more effective and efficient public welfare program.

Board Appointments:

The Board consists of a total of seven (7) members, not less than two (2) shall be women, selected by the County Commission from the citizenship of the County on the basis of their recognized interest in the public welfare.

The City Council or other governing body of the City shall have equal authority with the County Commission in selecting membership.

County appointments should be mailed to the City Clerk requesting Mobile City Council to concur the appointment or reappointment. The letter of appointment cannot be mailed until the County has received a resolution concurring the appointment or reappointment. Copy of appointment or reappointment letters should be mailed to Rose Johnson.
