Seven member board created pursuant to Section 38-2-7 of the Code of Alabama, addendum on '38-2-7 (1990). Not less than two of the members shall be women. Selected by County Commission from citizenship of county on basis of recognized interest in public welfare, provided that in counties in which there are cities having a population of 60,000 or more, according to last federal census, the City Commission or other governing body of the city shall have equal authority with the County Commission in selecting the membership of the county board of public welfare.

The Department of Human Resources is a state agency and is budgeted in the state budget, but receives some money from Mobile County and other municipalities, as well as some private donations.

Persons who are not to serve: No person holding elective public office, no person who is a candidate for election to public office, no person who is an employee of Department of Human Resources, and no person who is related by consanguinity or affinity within the fourth degree or nearer under the civil law to any such officer or employee shall be a member of such county board of human resources.
