ESTABLISHED:

Mobile County Water, Sewer and Fire Protection Authority, a public corporation organized and existing under Article 1 of Code of Alabama 1975, Section 11-88-1, et. seq. Resolution was adopted by Mobile County Commission on October 10, 1995.

PURPOSE:

Resolution adopted by Mobile County Commission on August 27, 1990, Amendment Seven, Paragraph Eight (8): to provide water, sewer and fire protection services in the service area of the corporation and operate as a public water and sewer system and as a public fire protection facility, all as defined in the Act.

MEMBERS:

Resolution adopted by Mobile County Commission on August 27, 1990, Amendment One, the second sentence of Paragraph One (1):

- **Must be over the age of twenty-one (21) years, a resident of and property owner of real property in the service area and a duly qualified elector of Mobile County.**

Resolution of September 29, 1994, approved by Mobile County Commission on October 11, 1994, Amendment Eleven, Paragraph Seven (7) C: the Authority increased members of the Board of Directors from three (3) to five (5).

Board of Directors consists of five (5) members.

TERMS: Six (6) Years
