The South Alabama Regional Planning Commission's money comes from the member governments (each pays a pro rata share of the South Alabama Regional Planning Commission's local dues). South Alabama Regional Planning Commission uses these local dues for seed money to get State and Federal grants. Total budget ranges from \$4.5 to \$5.0 million (FY-97 budget is \$4.8 million) of which 5% or approximately \$240,000 comes from local member governments. All funds are used to support programs that directly benefit member governments and their citizens.
