BY-LAWS

**Established:**

The Mobile County Commission authorized the creation of the Advisory Council of the Senior Companion Program of Mobile County by appointing its members in the October 14, 1980 Minutes.

**Purpose:**

To assist and advise the Senior Companion Program sponsor and staff on matters concerning planning, community support, financial support, project policies and operation issues and to conduct a quarterly and annual appraisal of the program.

**Board Appointments:**

Advisory Council shall consist of not less than 25 members or exceed more than 30 members who shall be broadly representatives of the community and have a positive interest in older persons.

One-fourth of the Council members must be or represent low income person's age sixty (60) or over and must include at least one (1) Senior Companion as a member.

The Nominating Committee has the responsibility of recommending candidates for membership.

**Term:**

Three (3) years.
