\* According to Bill Melton, P.E., Environmental Director, this Board was never re-enacted when all the Board Members either died or resigned, so there is no longer a Solid Waste Management Advisory Board. (See Memo in file dated August 18, 2010 from April Holifield)

This is an 11 member board plus an advisor. Created by Act No. 84-819.

Purpose of Board: To review permit application forms and recommend revisions thereof consistent with terms of bill, make recommendations for revision of bill, make recommendations regarding rates, charges or fees.

Per Act No. 84-819 one member shall be a member of the County Commission of Mobile County, Ala, one shall be the Solid Waste Coordinator, two shall be appointed by the Senators of the Mobile County Legislative Delegation, two shall be appointed by the Representatives of the Mobile County Legislative Delegation, one at large shall be appointed by all other appointees, one shall be appointed by the Sheriff of Mobile County, one shall be appointed by the County Commissioner of District 1, one shall be appointed by the County Commissioner of District 2, and one shall be appointed by the County Commissioner of District 3. All members shall reside in the unincorporated area of Mobile County.

Terms are four years. The director or his duly appointed designee shall be a permanent member of the Advisory Board.
