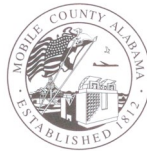


# RULES & REGULATIONS

- NO Speeding! Speed limit is Posted throughout park;
- NO Alcohol Allowed;**
- NO Drugs of any kind allowed;
- NO Firearms or Fireworks allowed;
- NO Pets allowed in any building;
- ALL Pets must be kept on a leash;
- NO Clothes lines;
- Park on prepared camp pads or driveways;
- NO open fires, use a grill or fire ring, keep grill off of our picnic tables;
- NO rowdy or dangerous behavior;
- Campers are responsible for visitors and their behavior, Visitors must register and receive a pass, Visitors must leave at 10 PM;
- QUIET HOURS start @ 10 PM - respect your neighbors;
- NO additional structures or appliances to be placed out side; keep all possessions on YOUR campsite; No 4-wheeler's allowed,
- NO tents allowed on Pop-up or RV Sites;
- NO Littering, use a garbage can, keep site NEAT & CLEAN;
- DO NOT pour grease into any sewer, drain, toilet or sink and do not change the oil in your vehicle in the park;
- NO leaky water/sewer line connections;
- NO harming of Wildlife animals or vegetation;
- DO NOT cut, damage or drive nails into trees or vegetation;
- DO NOT hang lanterns directly against trees;
- Minors must be accompanied by an adult at all times;

### GOING NORTH ON I-65

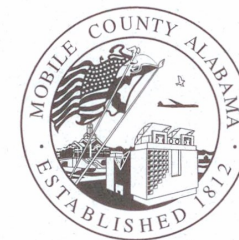
TAKE EXIT 13, TURN LEFT ONTO INDUSTRIAL

TURN LEFT ONTO SHELTON BEACH ROAD (HWY  
213 South); TURN LEFT AT YELLOW CAUTION  
LIGHT ONTO WHISTLER STREET; TURN LEFT ON-  
TO ALDOCK ROAD, PARK IS STRAIGHT AHEAD

### GOING SOUTH ON I-65

TAKE EXIT 13, KEEP STRAIGHT ACROSS INDUSTRI-  
AL PARKWAY (HWY 158)  
ONTO SHELTON BEACH ROAD (HWY 213 SOUTH);  
TURN LEFT AT YELLOW CAUTION LIGHT ONTO  
WHISTLER STREET; TURN LEFT ONTO ALDOCK  
ROAD, PARK IS STRAIGHT AHEAD

## LEASING RULES & OCCUPANCY LIMIT

CHECK-IN 2:00 PM

CHECK-OUT 11:00 AM

- Reserve by Phone and/or Walk-in's are welcome during business hours 7AM– 5PM ONLY;
- There is a \$40 CASH Deposit Required for ALL camping types upon Check-in. It is refundable after your site has been inspected for damage by park personnel only;
- Refunds for sites are determined by Parks Wildlife Manager only and may take up to 30 days for a response;
- Basic RV Fee includes up to 4 persons per site. \$2.50 per extra person daily, 8 persons and 3 vehicles maximum per site. Basic Tent Fee includes 4 persons per tent, 2 tent maximum per tent site;
- Tents are NOT allowed beside an RV or on an RV site;
- Site selection is determined upon availability and by personnel only. You can not request a specific site;
- All RV Trailers/RV Campers must appear to be in good condition at all times. No plywood or loose electrical wires allowed on or against the trailer;
- Once the duration of a maximum stay (30 or 90 DAYS) has been met, the RV/Trailer must leave the premises for 30 DAYS and you may reserve a site with us two weeks after departure;
- Tents must leave the premises for three weeks and you may reserve a site with us two weeks after departure.
- Mobile County Parks are for Recreational Use Only, Long Term Camping is prohibited;
- Changing the name on the card in order to stay longer will not be permitted. This allows for others to camp at Chickasabogue Park as well;
- If any rules are broken by the camper and an eviction is given, you are no longer welcome to camp any Mobile County Parks for one year unless specified;
- No pets are allowed inside the public buildings;
- **NO ALCOHOL ALLOWED**
- It is the responsibility of the camper to read all rules and regulations in this brochure before signing the Registration Card. Signing the Registration Card means you agree to all terms.

\*\* Eviction will result in the forfeiture of any fees paid and termination of future camping rights.\*\*
