**The following is the verbatim transcription of the comments made:**

Commissioner Carl said, "good morning, it feels strange standing on this side." He said, "real quick I wanted to go through my soccer project." Commissioner Carl said "I wanted to address some of the issues on my soccer project that we actually looked at of the thirty (30) sites that were interviewed or were looked at before I got here, a couple of statements that need to be reviewed. On the I-10/I-65

site which is the site that we heard from last time, it says in the notes it was going to be some access issues, it said here, you're going to have to go west on Government and I-65 you must have to take a left, a hard left turn to the east, go by Waffle House, a hotel, several businesses, a church, a school before heading south along the interstate and Halls Mill Road. All of this will need to be repaved being the Service Road and Halls Mill Road. The only option you will actually have is to send people through Satchel Paige which right now is not an option. So there is some real problems with just access to that property."

Commissioner Hudson said "Commissioner Ludgood, my impression was that this presentation was about the McDonald Road property."

Commissioner Carl said "it is, I'm getting there."

Commissioner Hudson said "if you are giving a presentation on the parcel of property that I am recommending then I think that I haven't seen this information you are presenting before. All I know Commissioner is that you have attached numbers and costs that have not been determined yet, there is no final cost and what you got here in terms of mitigation cost is not correct, this is not accurate information and I would really appreciate it if you are going to give a presentation sticking to the merits of your own parcel of property that you are recommending. I mean the information, the facts will come out, I don't think they have to be presented by you, at least as far as the property that I'm recommending."

Commissioner Carl said "thank you, now may I resume?"

Commissioner Hudson said "absolutely."

Commissioner Carl said "good, I appreciate that. From the newsletter there were several questions that were actually raised. The property site that I'm looking at is on McDonald Road, its roughly about three and a half miles south of I-10, some of the questions were the value of property. The value of property, mine is a dollar a year for ninety-nine years. The one we are looking at I-10/I-65 is roughly about four point five million for purchase of property. The acreage available I-65/I-10 seventy-one acres of property, thirty-nine acres of wetlands, a total of one hundred ten acres. With ours its eighty acres that we were guaranteed, and up to four hundred that we have access to, we have plenty of room to grow on this particular site. This site where we have it drawn right now, there are thirteen soccer fields presently drawn on the location with the expansion of baseball and softball fields, will be four of each. We have parking for fourteen hundred forty cars which is important with soccer fields, we have lots of soccer moms and dads. Some of the other issues that we were addressing here, wetlands issue, we don't know the cost and that is true, I'm not going to argue that, I try to put a fair cost on it."

Commissioner Hudson motioned her head right to left.

Commissioner Carl said "well, you say that. I talked to several of the people in our Environmental Department, they gave me a rough idea, without going there and looking at it they could not tell me exactly. So you could plug any number you want to in it whether it be a million dollars or a half million dollars, two hundred fifty thousand it really does not matter, it still wetlands. Instead with McDonald property it is high and it is dry, zero wetlands, zero mitigation involved. Proximity to the hotel and restaurant area in this own statement once again that came from the sports group it says that we are, although seemingly far out, we are just five miles from the interstate, Tillman's Corner, hotel, restaurants, sixteen miles from downtown. So we are not talking about that far out, we make it sound like it's in Mississippi and in reality it is not. The five year growth, this is the important part of any project is where is it going to go into the future and the future with Mobile County is going all west. If you look at the projections, this did come from a federal website, they are looking for all the growth of Mobile County to be in West Mobile. Central Mobile will decrease, obviously it's going to be businesses built where there are homes it's going to cause a decrease of people with the McDonald Road project which you and I looked at last week in Semmes, when it gets through you will actually have access from on McDonald Road, McDonald Road will run from the soccer complex just south of it, it will run all the way to the other side of Semmes, if I'm not mistaken. So that's going to be a main artery for bringing traffic in and out of West Mobile, you will see a decrease in the people that are using it now. You are going to see an increase overall, but there will be a decrease in the people wanting to use Airport Boulevard, Cottage Hill Road, so McDonald Road plays right into what we are trying to do with the soccer complex on McDonald Road. So with that said that is what I had to present."

President Ludgood said "as of the last vote we will have two studies that are being done and when we get those results back then we will begin to look at, we may have some things we can compare at that point."

Commissioner Hudson said "I have a question of the attorney, because this McDonald Road property is owned by the School Board the County does not have title, it is not under lease, there is no right-of-way agreement, what legal authority do we have to enter into a contract that allows a contractor on that property to perform this civil engineering study when we have no agreement in place, do we have legal authority to do that?"

Jay Ross, County Attorney said "well, I guess that will be up to the School Board to give us that approval."

Commissioner Hudson asked "but is this contingent on approval of the School Board?"

Mr. Ross said "when we did the approval with Hargrove for the I-65/I-10 site, we reached out to the owners of that property, White-Spunner Berg, they gave us permission in writing to do that."

Commissioner Hudson said "which was on the agenda at the same time the engineering study was presented."

Mr. Ross said "it was and if the School Board wants we can reach out to them and get it for this unless."

President Ludgood said "that is what we will have to do."

Mr. Ross said "right, we would have to get their permission."

Commissioner Hudson said "it is null and void without that permission."

Mr. Ross said "the Commission can clearly approve the contract and if we can get some permission in writing from the School Board it should work out, secondary approval."

Commissioner Hudson said "I just wanted to comment Commissioner Ludgood. So obviously, Commissioner Carl reads my newsletters, that's a good thing."

Commissioner Carl said "it's good, yeah."

Commissioner Hudson said "however, as I said the land value that he is presenting here as well as mitigation cost on wetlands is not accurate, we have not negotiated any final cost on the land and also the mitigation cost, since the site work was redesigned to try to avoid wetland areas. Dr. Vittor, whom we've been working with, Environmental Consultant, indicates to us the cost would not be significant, it will be likely not more than one hundred thousand dollars based on the last design, and that was just an off handed comment he gave to me because as I said, until we get civil engineering work, until we get some final figures we don't know exactly what the costs are. I will not sit in this seat and talk about the cost of your project without having any facts before me. These aren't facts Commissioner, this is just supposition and I don't know how it was cobbled together, but you know I just, its disappointing, it truly is. I am willing for the recommendation that I've made that working with a committee of people over the last year to stand on its own merits and I think that it will. I think location is the key component here, you cannot take twenty-two thousand dollars in a civil engineering study and make a poor location a good location and that is the simple fact of the matter, but that being said if that is what you are inclined to do and move forward then I guess that is the direction we will take."

Commissioner Carl said "you called it a poor location, what makes it a poor location?"

Commissioner Hudson said "I think if you read my newsletter you'll understand and you can take all that."

Commissioner Carl said "I just addressed everyone of them, they are false, they are things you created."

August 12, 2013

Commissioner Hudson said "I don't agree and I think in general we had a hotelier the head of the Hotels Association."

Commissioner Carl said "Downtown Hotel Group."

Commissioner Hudson said "who came to our last meeting and indicated to us that if you are expecting hotels to pop up out there in that area when we are not even filling the hotels we've got. He tells me that you have to have a threshold of at least sixty-seven percent annual occupancy for hotels to consider moving to a new area that way. He said right now we are at fifty-five percent, he said we are not there, that will not happen in his opinion,"

Commissioner Carl said "so you are willing to spend twelve million dollars based on."

Commissioner Hudson said "no, there you go throwing numbers out, the numbers are not correct people. Let's get some facts, let's get some accurate numbers because it is changing anywhere from nine million to twelve million depending on any given conversation.

Commissioner Carl said "Oh Lord, have mercy."

Commissioner Hudson said "so let's get the facts and compare the merits, and then let's be a good sport and do it the right way."

Commissioner Carl said "a good sport, I think it was a stacked audience the last time we had this, it caught me blind sided I had no idea that was coming, so let's talk about sport here if you want to."

Commissioner Hudson asked "was there anything that anybody got up and said that was not factual or misrepresenting anything?"

Commissioner Carl said "show me I'm wrong."

Commissioner Hudson said "this is going to come down to."

Commissioner Carl said "Connie, I have spent my own personal money and developed properties, I have done it with my own money and there is one thing you don't know when going into a project, what is the site work going to cost, it's never cheaper, it always cost more. That is the one uncertain part because you know the cost of a building, you know the cost of everything else, but to actually develop that piece of property and when it sits in a swamp and that is a swamp."

Commissioner Hudson said "that is not a swamp. The majority of wetlands on that property will be a natural habitat area, that is how it is drawn and those of you who would like the true facts on this, I would suggest that you contact Dr. Vittor. He is an expert and he's got the information, he's studied the area and he's the one we are relying on, the expert."

Commissioner Carl said "thank you."
