The Mobile County Commission met in regular session in the Government Plaza Auditorium, in the City of Mobile, Alabama, on Monday, August 11, 2014, at 10:00 A. M. The following members of the Commission were present: Connie Hudson, President, Merceria Ludgood and Jerry L. Carl, Members. Also present were John F. Pafenbach, County Administrator/Clerk of the Commission, Jay Ross, County Attorney, and Joe W. Ruffer, County Engineer. President Hudson chaired the meeting.

#### INVOCATION

The invocation was given by Ron Pierce, Chaplain, Mobile County Sheriff's Department.

#### **The following is a synopsis of the comments made:**

Danny Corte, Executive Director, Mobile Sports Authority, addressed the Commission and said the Mobile Sports Authority was a 501(c)(4) nonprofit organization. He said it was created to pursue, support and attract regional, national and international sporting events and related business opportunities to Mobile, Alabama. Mr. Corte said the mission is to bring a positive economic impact to Mobile County, the City of Mobile and the region. He said they manage logistics before, during and after events to maximize the publicity for filling every seat. Mr. Corte said in FY2014, they attracted nineteen (19) sporting events to the Mobile area that generated a positive economic impact of \$15 million dollars. He said the sports events were a color run, college football, adult rugby, a marathon and a half marathon, youth gymnastics, power lifting, auto racing, youth bowling, track and field, mixed martial arts, senior softball, boat racing, body building and fitness, and pole vaulting. Mr. Corte said approximately eleven (11) sporting events would be in Mobile for FY2015, which could generate an economic impact of \$60 million dollars over the next seven (7) years. He said sports tourism is growing at a phenomenal rate, and he thanked the Commission for their continued support.

Commissioner Carl asked how much was the Mobile Sports Authority total budget?

Mr. Corte said the Mobile Sports Authority has three (3) budgets: a General Office Budget in the amount of one hundred fifty-thousand dollars (\$150,000.00), a Bid Grant Fund Budget in the amount of two hundred sixty-five thousand dollars (\$265,000.00), and an Annual Budget in the amount of one hundred eighty-thousand dollars (\$180,000.00) through the Mobile Area Tennis Association, Inc. for the Mobile Tennis Center.

President Hudson thanked Mr. Corte on behalf of the Commission for all his efforts and successes.

**The following is a synopsis of the comments made:**

Kara Lankford, 26920 Pollard Road, Daphne, Alabama, addressed the Commission on Agenda Item #14/5E. She said she was opposed to the Commission waiving sections of the Mobile County Subdivision Regulations to allow Frank Childress to subdivide his property on a private dirt road. Ms. Lankford said the Mobile County Engineering Department reviewed the plat and determined Mr. Childress' property did not meet the subdivision regulations. She said Mr. Childress already has electrical services turned on in his barn and his camper. Ms. Lankford said Matthew Barclift, County Engineer III, told her Mr. Childress could have connected electrical services to his trailer home through his barn, but his barn failed the electrical inspection. She said a representative of Alabama Power Company told her, Mr. Childress was denied electrical service to his trailer home because the wiring was outdated in his barn. Ms. Lankford said she feared the probability of multiple trailer homes on Mr. Childress property and further development of future owners. She said the Ann Bedsole Law was established to protect citizens who lived in areas of Mobile County where there were no zoning laws. Ms. Lankford said a variance to the subdivision regulations should be granted only in extreme circumstances. She said if Mr. Childress updated the wiring in his barn, it would not alter the community or his property. Ms. Lankford requested the Commission to uphold the current Mobile County Subdivision Regulations and deny Mr. Childress' application for a waiver.

Toni Lankford, 10970 Straub Road, Grand Bay, Alabama, addressed the Commission on Agenda Item #14/5E. She said laws were like cement that hold our society together. Ms. Lankford said the main reason citizens elect people to public office was because they trust them to uphold the law. She said variances erode the law and cause division among neighbors. Ms. Lankford said the County Engineering Department was trying to uphold those laws and the Commission should too. She said the subdivision regulations should not selectively be enforced. Ms. Lankford said the Commissioners should not be persuaded by pity, poverty or

favoritism. She said Mr. Childress knew the situation about the property before he purchased it. Ms. Lankford said laws should not be twisted to satisfy someone's wants, and a decision should not be on emotions. She said the Commission should base its decision on the subdivision regulations, and the County Engineering Department has determined that the Frank Childress Subdivision does not meet those regulations. Ms. Lankford asked what the purpose of having a law was if it could change because of a hardship and she asked what defined a hardship? Ms. Lankford said Rose Straub would attest that Mr. Childress knew he could not put a dwelling on the property before he purchased it. She said a few years after Mr. Childress purchased his property he met a woman who was ill, and she moved in with him, she said that was when he began to experience a hardship. Ms. Lankford said Mr. Childress' daughter lives in his barn, she asked if he would present that as a hardship to the Commission so he could add a future trailer home on his property that would also need electrical services? She said people always say the right thing to get what they want and then they get amnesia down the road. Ms. Lankford said the law becomes useless when it is changed to satisfy someone's wants. She said she had nothing personal against Mr. Childress, but she greatly feared it would not be his last request. Ms. Lankford said she hoped the Commission denies his application to waive the subdivision regulations.

DeAnne Spann, 11150 Lloyd Lane, Grand Bay, Alabama, addressed the Commission on Agenda Item #14/5E. She said at the Commission meeting, July 28, 2014, Commissioner Jerry L. Carl told the people present at that meeting that he would contact them. Ms. Spann said Commissioner Carl did not contact her, but she saw him at Frank Childress' residence the day after the Commission meeting. She said she called Commissioner Carl's Office and left a message for him to call her. Ms. Spann said Commissioner Carl returned her call later that day and she asked him to explain why the plat of the Frank Childress Subdivision did not meet the Mobile County Subdivision Regulations? She said Commissioner Carl's response was "I don't know." Ms. Spann said Commissioner Carl told her, "Mr. Childress agreed out of the kindness of his heart to give us a letter stating he will not establish a trailer park on his property." She said Mr. Childress' letter of agreement would not protect their community. Ms. Spann asked why a judge would decide against the Commission, if they approved to waive the subdivision regulations for Mr. Childress. She said a new owner of the Frank Childress Subdivision may not feel obligated to the agreement made by Mr. Childress. Ms. Spann said the residents in her community would be forced to hire an attorney and incur the legal expense. She said as she was relating the facts to Commissioner Carl, she felt he had no desire to listen to her concerns. Ms. Spann said in an abrupt manner Commissioner Carl told her, "I am warning you, do not stir things up out there, have a nice day," she said then he hung up the phone. Ms. Spann said she was not sure what Commissioner Carl meant from his warning, but she said for her it was obvious that Commissioner Carl had already formed a biased opinion. She said she holds the County

Engineers and Commissioner Carl at fault for the division among her neighbors over this situation. Ms. Spann said she never had any dealings with Commissioner Carl on any level before this situation. She said she was not against Mr. Childress, she was against a variance to the subdivision regulations that would alter their community forever. Ms. Spann said the Frank Childress Subdivision does not qualify to be subdivided according to the Mobile County Subdivision Regulations. She said laws were established to protect property owners and taxpayers in Mobile County against devaluation of their property and the burden of road maintenance. Ms. Spann said the access road to Mr. Childress' property is a private dirt road and Section 7.1 of the Mobile County Subdivision Regulations states, "No subdivision with unpaved roads, whether private or public, will be permitted. All such Private Road Subdivisions must be paved." She said Mr. Childress' barn failed an electrical inspection and that is the ultimate reason he is prevented from connecting electrical services to his trailer home. Ms. Spann said it was more cost effective and a lot easier for Mr. Childress to rewire his barn to meet the building code. She said Section 1.41 of the Mobile County Subdivision Regulations states, "Land to be subdivided shall be of such character that it can be used safely for building purposes without danger to health or peril from fire." Ms. Spann said Mr. Childress' barn's failure to pass an electrical inspection should be a clear reason for the Commission to deny his application for a waiver of the subdivision regulations. She requested the Commission to deny the waiver and uphold the Mobile County Subdivision Regulations.

Rose Straub, 11075 Straub Road, Grand Bay, Alabama, addressed the Commission on Agenda Item #14/5E. She said to grant a waiver for the Frank Childress Subdivision would greatly affect the value of their properties in her community. She said her property was on the west side, the south side and the back side of Mr. Childress' property and her concern was the trailer home on his property. Ms. Straub said she and her husband, approximately fifteen (15) or twenty (20) years ago, were in the process of purchasing property on a private dirt road in the same community from their in-laws. She said a trailer home was on the property and the bank told them the trailer home depreciated the value of the property. Ms. Straub said they own another property in the community that had belonged to her father-in-law who gave the County the right-of-way to prevent a situation like the one they are experiencing now. She said she was not begrudging Mr. Childress, she was only looking out for the community. Ms. Straub said she and her husband were the only remaining family members who owned property in the community and they hope to pass it on to their children in the future. She said if Mr. Childress was granted a waiver to subdivide his property on a private dirt road anyone could do anything on that property down the road. Ms. Straub said there were two (2) beautiful homes in the back of her property; one was on 15 acres and the other was on 10 acres. She said she gave them a 30-foot right-of-way that they have paved with gravel and maintain

it without any problems whatsoever. Ms. Straub said certain areas of their community were deteriorating because of trailer homes and a certain resident who has decided to allow vagrants to live on his property. She said she only wants to protect the future of her community and does not hold any animosity against Mr. Childress. Ms. Straub said she was opposed to the Commission making a concession for something that would carry on indefinitely.

Commissioner Carl said he did not recall warning Ms. Spann, but he brought their telephone conversation to an abrupt halt because he was not in a position to judge people or their family members. He said he told Ms. Spann three (3) times that he did not want to hear about the children, and he did not want to get into the personal side of the situation. Commissioner Carl said Mr. Childress' property was originally not approved because of the size. He said he walked through the community and talked with several neighbors. Commissioner Carl said he had addressed their biggest concern which was the letter Mr. Childress personally decided to do. He said Mr. Childress' letter would state that he would put only a single family dwelling on his property. Commissioner Carl said Mr. Childress signed the letter, but he has not seen it and the attorney was handling it. He said he tried to discuss it with Ms. Spann, but her conversation was about the stakes in the road.

Ms. Spann said absolutely. She said she was against those stakes being in that road.

Commissioner Carl said Mr. Childress has agreed to take the stakes out of the road.

Ms. Spann said the stakes in that road have been removed.

Commissioner Carl said those were the two (2) issues, and he has addressed both of them. He said he could not get involved in the personal side of it.

Ms. Spann said she did not know what Commissioner Carl was speaking of when he said she wanted to talk about the children.

President Hudson told Ms. Spann it was Commissioner Carl's opportunity to respond. She asked Ms. Spann to take her seat, so the Commission could move ahead.

Commissioner Carl said the community was beautiful and Mr. Childress' barn was fascinating, he said it was a three (3) stall old horse barn and was gorgeous. Commissioner Carl said he had tried to appease everyone in that community with what he has done, and that was how he would make his decision.

President Hudson said she understands their concern about a letter having the force of law in future generations. She said at the Commission conference, August 7, 2014, she had asked the County Attorney about adding conditions to any waivers or variances that allowed Mr. Childress to move ahead with his subdivision. President Hudson said when conditions are added to a waiver those conditions remained as a force of law regardless of how many generations follow Mr. Childress. She said those conditions would still remain in effect, which is only one (1) dwelling could be on Mr. Childress' subdivided property. President Hudson said conditions added to the waiver have more of a force of law than a letter because the letter would be a civil lawsuit, but the conditions added to the waiver were part of its restrictions. She said the County Attorney told her the law would allow it.

Ms. Straub said Mr. Childress' property was 4.2 acres; she asked what would stop him from subdividing his property again? She suggested that the Commission allow electrical services to Mr. Childress' trailer home and leave the property as it is. Ms. Straub said she feared further development on his property.

Commissioner Carl said further development on Mr. Childress' property would require permits for septic tanks and electrical services. He said they could not add additional septic tanks without going through the Mobile County Board of Health, and then the County Commission must approve the subdivision.

Jay Ross, County Attorney, said if the Commission granted the one-time waiver it would only be for a single family residence. He said future development and future subdivisions on that parcel would have to meet the current Mobile County Subdivision Regulations.

President Hudson asked if County approval was required?

Mr. Ross said a person could not automatically continue to subdivide the property based on this waiver. He said the permit was for a 1,000 gallon septic tank system designed for a single family parcel. Mr. Ross said it was clear that if the Commission decided to grant the waiver it does not open the door for future subdivisions without meeting the Mobile County Subdivision Regulations as they were at that time.

Commissioner Ludgood asked if the County's subdivision documents were recorded?

Mr. Ross said yes.

Commissioner Ludgood asked if the County's subdivision documents run with the land just like a deed?

Mr. Ross said yes.

Commissioner Ludgood said any limitations that are put in that document any subsequent owner is on notice by virtue of the County's subdivision documents.

Mr. Ross said until the owner meets the subdivision regulations and receives a permit from the County.

Commissioner Ludgood asked if the Commission granted the waiver was it specifically to Mr. Childress as the owner and not to the property?

Mr. Ross said it would be granted to Mr. Childress as the owner of the property.

Commissioner Ludgood asked if it would carry over to a new owner?

Mr. Ross said he had not seen the document, but it was told to him that it would. He said Mr. Childress through someone else was going to record some type of a restrictive covenant that would run with the land to keep it as a single family residence. Mr. Ross said there were no zoning laws in that area, but if the Commission was to approve the application based on the comments at the Commission conference on Thursday, August 7, 2014, it would run as long as Mr. Childress was the owner and a new owner would have to deal with it at that time.

President Hudson said it was very important for them to get an answer to that legal question. She said the Commission wants to ensure that in the future, if Mr. Childress sells the property that the same conditions apply in the future as they apply with the granting of this waiver. President Hudson said until the Commission could assure the people of it; she was not sure if the Commission could move forward.

Mr. Ross said he was waiting to see the restrictive covenant language.

Commissioner Carl asked if it included the children?

Mr. Ross said yes, and any subsequent owners.

President Hudson asked when he would have this information?

Mr. Ross said he should receive it today, and it would be a condition on the waiver if the County granted it.

President Hudson asked Mr. Ross if his recommendation was to wait until it was all in place?

Mr. Ross said the Commission could approve it upon the condition that the waiver includes a covenant that runs with the land.

President Hudson asked if the covenant would run with the land regardless of ownership in the future?

Mr. Ross said yes. He said the condition would subject the approval or variance upon those two (2) factors. Mr. Ross said a speaker at last week's Commission conference has withdrawn their objections based on it being a single family residence. He said he told that speaker a letter was insufficient. Mr. Ross said that speaker told him Mr. Childress would hire an attorney that would prepare a declaration. He said the Commission could hold the item over until those two (2) things are done.

Ms. Straub said covenants were not enforceable and a signed letter would not obligate a future owner of Mr. Childress' property. She said all who did not like the rules should go through the Alabama State Legislature and have them amended or changed.

President Hudson recommended the Commission hold the item over until the Legal staff has all of the information requested.

Commissioner Carl recommended the Commission go ahead and vote today based on the information they already have on the two (2) concerns he has addressed.

President Hudson asked Commissioner Ludgood if she had a preference?

Commissioner Ludgood said she was not prepared to vote today. She said she asked at the last meeting about the septic tank and she also thought at that time that Mr. Childress had no other way to get power, but now she was hearing today, he has a way to get power.

Commissioner Carl said Mr. Childress would not be able to run power from his barn to his trailer home.

President Hudson asked what the status was on Mr. Childress connecting electrical services to his trailer home?

Richard A. Mitchell, Deputy Public Works Director, said Mr. Childress could not obtain a permit because he was not the legal owner on record for that property.

Commissioner Carl asked for an explanation.

Mr. Mitchell said Mr. Childress purchased a piece of property that had not been subdivided correctly according to the Mobile County Subdivision Regulations. He said the County could not issue a permit to Mr. Childress. Mr. Mitchell said to make the property legal on record Mr. Childress requested a waiver of the subdivision

regulations to allow his property to show on record as a single lot subdivision.

Commissioner Carl asked if electrical services could be connected through Mr. Childress' barn to his trailer home?

Mr. Mitchell said if Alabama Power Company has disconnected Mr. Childress' electrical service from his barn, he would need a permit from the County that showed his property was legal on record.

Commissioner Carl said the Mobile County Health Department would have to grant a permit for a septic tank system.

Mr. Mitchell said he has the permit if the Commissioners wanted to see it.

Commissioner Carl said it was a 1,000 gallon septic tank system, and it was for a 3-bedroom 2-bathroom dwelling.

Commissioner Ludgood said typically when the Commission has waived subdivision regulations it has not been this kind of situation. She said for her to feel comfortable voting to give Mr. Childress a waiver she needed to make sure they can lock it down to Mr. Childress to run with the land and everybody else who comes behind him is on notice they still have a problem with this 4.2 acres site. Commissioner Ludgood said just because he got away with it does not cure the missing land and to her the best way to do it was to make sure the documents were in hand. She said it could be done with legal documents where the Commission could have assurances. Commissioner Ludgood said she would need to see those documents before she would vote on this agenda item.

President Hudson said she concurred. She said the Commission would hold the item over until the next meeting. President Hudson said it was appropriate to make sure all of the legal documents were in hand before voting on this agenda item.

- B. If we didn't take away time in Change Order #1 why should we allow extra time for add-on #2?
