MOBILE COUNTY COMMISSION

The Mobile County Commission met in regular session in the Government Plaza Auditorium, in the City of Mobile, Alabama, on Monday, June 24, 2013, at 10:00 A. M. The following members of the Commission were present: Merceria Ludgood, President and Connie Hudson, Member. Commissioner Jerry L. Carl, Member, was absent. Also present were John F. Pafenbach, County Administrator/Clerk of the Commission, Jay Ross, County Attorney, and W. Bryan Kegley II, Assistant County Engineer. President Ludgood chaired the meeting.

INVOCATION

The invocation was given by Pastor Wes Davis, Associate Pastor of Mount Hebron Church Ministries, Mobile, Alabama.

The following is a synopsis of the comments made:

President Ludgood said there were several distinguished guests at the meeting and Commissioner Hudson would introduce the first group.

Commissioner Hudson said she was very happy to have a group of Distinguished Young Women at the meeting today. She said events for the Distinguished Young Women preliminary competition would be held Thursday, June 27, 2013 and Friday, June 28, 2013, and their national finals Saturday, June 29, 2013. Commissioner Hudson invited Stephanie Bradford, Communications Director, Distinguished Young Women Program, to the podium.

Ms. Bradford thanked the Commission and introduced the following members of the Distinguished Young Women Program: Joy Grodnick, President, Board of Directors; Kathy Lauda, Chaperon, 2012 National Winner; and Christina Maxwell, 2012 National Winner of Asheville, North Carolina.

Maxwell addressed the Commission and said it was wonderful to be in Mobile, Alabama, it has become her second home. She thanked the Commissioners for their incredible, generous and faithful support. She said her thankfulness echoes all of the 140,000 state representatives who have participated in the program over the last fifty-six (56) years. Ms. Maxwell said Mobile County was an integral part of each of their life stories and at the same time Distinguished Young Women was a part of Mobile's story. She said Mobile was a place that serves as a launch pad which empowers young women to carry out their callings. Ms. Maxwell said the program truly fulfills a unique need unlike no other. She said young women oftentimes think

they could never measure up to the world's standards, but the Distinguished Young Women Program reassures them that they are enough. Ms. Maxwell said there were no prerequisites to participate in the program; the size of your home, the income of your family or the job titles of your parents do not matter. She said Distinguished Young Women were celebrated and rewarded for their unique talents and gifts, and challenged to grow in areas where they thought they were a lost cause. Ms. Maxwell said the Distinguished Young Women Program has a very powerful vision and a legacy that has endured fifty-six (56) years of change, political strife and economic trials. She said two-thirds of new businesses do not survive past eighteen (18) months, yet this program has endured the test of time with values that are truly timeless with an emphasis on leadership, talent and commitment to provide deserving young women with scholarship funds to pursue a higher education. Ms. Maxwell said for every dollar invested in the Distinguished Young Women Program Mobile County receives a return that was far beyond any dollar amount. She said every year the Distinguished Young Women National Finals brings an economic impact of over \$2 million into Mobile County. Ms. Maxwell said the Distinguished Young Women Program has become a nationally recognized icon and an integral part of Mobile County like the Azalea Trail Maids, the Mardi Gras parades and soon to be Airbus. She said most significantly the Distinguished Young Women Program brings young women to Mobile County who will become the movers and shakers of the world. Ms. Maxwell said Mobile County was a stepping stone for young women in the program who in turn serve as billboards by carrying their stories about Mobile, Alabama, into the world. Ms. Maxwell said many young women have come through this program, not only on a national level, but on statewide and local levels. She said she was truly amazed of the accomplishments obtained by Teresa Elders of New Jersey, who currently serves as a Lieutenant Commander of the U. S. Navy; Honorable Marilyn Stebner Kite, Wyoming's first woman Supreme Court Justice; Sarah Choi of California, Operations Associate, Google Television and YouTube; Christine Houle of Michigan, an intern for Congressman John Dingell; and Dr. Regina Benjamin of Mobile, Alabama, Surgeon General of the United States. Ms. Maxwell said she was so grateful to be one of the women empowered by this program. She said the scholarship funds she received allowed her to pursue a degree in musical theater and she has recently completed her first year at her dream school, the University of Michigan, which has one of the best musical theater programs in this country. Ms. Maxwell said she had a blast of life changing experiences as the 2012 Ambassador of Distinguished Young Women; she performed at American Idol Scotty McCreery Concert, she enjoyed two return trips to Mobile County for Veterans Day Celebration and the GoDaddy.com Bowl Game. Ms. Maxwell said she recently took a trip to Washington, D. C. where she met with some of our nation's leaders; House Speaker John Boehner, Congressman Jo Bonner and Senator Richard Burr. She said she was eternally grateful and would always be proud of her ties to the City of Mobile and Mobile County. Ms. Maxwell said in her closing she would recite one of her favorite quotes from theologian Howard Thurman, "Don't ask

yourself what the world needs. Ask yourself what makes you come alive and then go do it. Because what the world needs is people who have come alive." Ms. Maxwell said on behalf of all the young women who have participated in this program and on behalf of herself, she thanks the Commission for helping them to come alive.

Commissioner Hudson thanked Ms. Maxwell and said it is always a wonderful pleasure to have Distinguished Young Women visit Mobile, Alabama.

The following is a synopsis of the comments made:

The Commission presented a resolution to the following members of the Southwest Alabama Workforce Development Council (SAWDC): Sam Covert, Area Manager, Alabama Power and SAWDC Chairman; Laura Chandler, Executive Director; Darwin Bolden, Project Coordinator; Paul Hodges, Industry Coordinator/Case Manager; and Sherry Wade, Industry Coordinator/Case Manager.

President Ludgood said the Southwest Alabama Workforce Development Council (SAWDC), which serves eight (8) counties in Southwest Alabama has established a delivery model for moving low skilled workers into career opportunities in the maritime industry, earning an accomplishment which has netted the group the honor of receiving the 2013 National Fund for Workforce Solutions Partners Council Award for Exemplary Industry Partnership by the National Fund for Workforce Solutions (NFWS). She said the Southwest Alabama Workforce Development Council (SAWDC) received the award for creating industry partnerships that deliver services to address industry skill gaps and competencies which lead to industry recognized credentials and promote career advance for low skilled workers. President Ludgood said the Southwest Alabama Workforce Development Council (SAWDC), established in 2008, was a business driven and business led nonprofit organization established to provide a direct link to the workforce needs of business and industry. She said the Southwest Alabama Workforce Development Council (SAWDC) has focused their attention on four (4) industry clusters: aviation, maritime, industrial construction and manufacturing, and healthcare which were chosen due to the high demand and high growth prospects for those industries within the area. President Ludgood said the Southwest Alabama Workforce Development

Council (SAWDC) was commended for building impacted industry partnerships which has proven them deserving of this national honor.

The Commission congratulates the Southwest Alabama Workforce Development Council (SAWDC) for receiving this auspicious honor; we further thank the group for the invaluable contributions they have made to development of the workforce throughout Mobile County.

Mr. Covert said the award was an example of how their partnerships and collaborations have distinguished Mobile County in the region and around the country. He said his staff was the ones who made it happen and they have done exemplary work.

Charles Hyland, Director, Mobile Area Water & Sewer System (MAWSS), addressed the Commission concerning a situation in the Big Creek Lake watershed. Mr. Hyland introduced Commissioner Tommy Tyrrell, MAWSS Board Member, and Barbara Shaw, MAWSS Public Relations Director. He said Plains Southcap LLC wants to put a crude oil pipeline through the watershed which would be extremely close to Big Creek Lake which is the source of the drinking water for Mobile, Prichard and other communities in Mobile County, as well as Spanish Fort in Baldwin County. Mr. Hyland said the Alabama Public Service Commission in January, 2012, granted Plains Southcap LLC a Certificate of Industrial Development stating in Alabama Public Service Commission's opinion the proposed pipeline would be in the furtherance of industrial development in Alabama and Plains Southcap LLC may file a condemnation to obtain the right to lay the pipeline. He said the pipeline proposed was to run from the Ten Mile Terminal in Eight Mile, Alabama, through the watershed to a refinery in Pascagoula, Mississippi. Mr. Hyland said the existing route crosses Hamilton Creek which is one of the main feeder streams into Big Creek Lake and at certain points it parallels the Creek. He said the pipeline would cross over four (4) miles of the watershed and come within 3,000 feet of the lake. Mr. Hyland said an accident or spill of crude oil in this environmentally sensitive area could do irreparable harm to the drinking water supply. He said they learned of this route when Plains Southcap LLC contacted the Mobile Area Water & Sewer System (MAWSS) as a landowner for an easement and at that time they advised Plains Southcap LLC the pipeline should not go through the watershed that drains into the community drinking water supply. He said Mobile Area Water & Sewer System (MAWSS) was currently gathering information about the pipeline and the possible risk it may pose to the drinking water. Mr. Hyland said they hope the Commission will support their efforts to determine the potential risk the pipeline may pose to our community, and if their investigation leads to the

conclusion the risk was too great, the Commission will help persuade Plains Southcap LLC it would be in the best interest of the community to relocate the pipeline outside of the watershed. He presented a slide showing the possible location and route of the pipeline. Mr. Hyland said it would come from some terminals in Eight Mile, Alabama, running southwesterly across the watershed into Mississippi. He said that area comes very close to Big Creek Lake and parallel to Hamilton Creek which is its main feeder. Mr. Hyland thanked the Commission for allowing him to share this information and said he looks forward to working with them in the future.

Commissioner Hudson thanked Mr. Hyland and said they have met on this recently to determine a recourse to have this route realigned. She said when it was first presented to them there was not a disclosure about the impact it would have on the Big Creek Lake watershed. Commissioner Hudson said they had no idea it was in the vicinity of the watershed. She said the Alabama Public Service Commission, when it was approved, did not have any communication or notification with them. Commissioner Hudson said in the agreement that the County has with Plains Southcap LLC, it has caveats that directly deal with activities detrimental to local government. She said even when the best intentions and safety precautions are in place, there are always risks. Commissioner Hudson said they have tried very hard to protect the drinking water supply and they do not want it to be at risk. She said they have some leverage, Plains Southcap LLC was still in the phase of acquiring rights-of-way and land. Commissioner Hudson recommended Jay Ross, County Attorney, and the Engineering Department facilitate a meeting with Plains Southcap LLC and Mobile Area Water & Sewer System (MAWSS) to discuss a possible realignment. She said they were not against a pipeline, but were concerned about its proximity and the risk it poses to our water supply at the watershed. Commissioner Hudson asked Mr. Hyland if he was agreeable with that course of action?

Mr. Hyland said yes.

Commissioner Hudson asked Mr. Ross if he could set up a meeting?

Mr. Ross said yes.

Commissioner Hudson said they would schedule the meeting as soon as possible.

The following is a synopsis of the comments made:

Danny Corte, Executive Director, Mobile Bay Sports Authority d/b/a Mobile Sports Authority, addressed the Commission and said he was very proud to host, for a third consecutive year, the USA Boxing Junior Olympic National

Championships in Mobile, Alabama, at the Mobile Arthur R. Outlaw Convention Center, June 26, 2013 through June 29, 2013. He said approximately two hundred (200) boy and girl boxers from all over the nation between the ages of fifteen (15) and sixteen (16) years old plus their families, trainers and coaches would be in town, an estimated eight hundred (800) to one thousand (1,000) visitors. Mr. Corte said this event was a joint effort with the Mobile Convention and Visitors Bureau (MCVB). He named a few upcoming events: 3v3 Live Soccer Tournament, Saturday, July 27, 2013, at the University of South Alabama Intramural Fields and the Color Run, Saturday, October 12, 2013, at the Mobile Civic Center, which was an untimed, noncompetitive 5k registered runners event during which participants are doused with colored corn starch as they traverse the course. Mr. Corte thanked the Commission for their continued support.

Commissioner Hudson said it was great news. She thanked Mr. Corte for all his work and said keep the events coming to Mobile, Alabama.
