MOBILE COUNTY COMMISSION

The Mobile County Commission met in regular session in the Government Plaza Auditorium, in the City of Mobile, Alabama, on Monday, March 24, 2014, at 10:00 A. M. The following members of the Commission were present: Connie Hudson, President, Merceria Ludgood and Jerry L. Carl, Members. Also present were John F. Pafenbach, County Administrator/Clerk of the Commission, Jay Ross, County Attorney, and Kimberly N. Sanderson, Design Engineering Manager. President Hudson chaired the meeting.

PRESENT RESOLUTION/THE RAPE CRISIS
CENTER/PROCLAIM APRIL AS SEXUAL
ASSAULT AWARENESS MONTH

The following is a synopsis of the comments made:

President Hudson presented a resolution to Jan Preslar, Division Manager, and Shawna Mayo-Yokley, Program Coordinator, the Rape Crisis Center. She said the Rape Crisis Center has provided comfort and support to sexual assault victims in the community for years, bringing awareness and education to the masses while offering high quality assistance to those in need. President Hudson said the Rape Crisis Center provides twenty-four (24) hour support to sexual assault victims and their families through direct services, prevention education and professional training to all citizens of Mobile County. She said the Rape Crisis Center provides community education and prevention programs for youth and the community on sexual assault and bullying issues. President Hudson said during the year 2013, the Rape Crisis Center staff presented four hundred eighty-nine (489) programs to over twelve thousand (12,000) students and individuals in Mobile County. She said the Rape Crisis Center serves a cross section of people of various races, socio-economic and educational levels. President Hudson said in the year 2013, the Rape Crisis Center accompanied two hundred eighty-three (283) victims to USA Children's & Women's hospital for a forensic collection kit; office visits; received two hundred forty-one (241) crisis phone calls; provided follow up and individual counseling; law enforcement and court advocacy; clothing and transportation; dolls and bears to child victims. She said the Rape Crisis Center will recognize the Month of April as Sexual Assault Awareness Month in Mobile County.

President Hudson said the Commission proclaims the month of April as Sexual Assault Awareness Month in Mobile County and she calls on all citizens to join them in commending the Rape Crisis Center for the services they provide to the community.

Ms. Preslar thanked the Commissioners for their continued support of the Rape Crisis Center.

PRESENT RESOLUTION/DESIGNATE COUNTY
ROUTE 39 AS BILL MENTON MEMORIAL HIGHWAY

The following is a synopsis of the comments made:

Commissioner Carl presented a resolution as a tribute to the memory of the late Bill Menton of Irvington, Alabama. He said Mr. Menton was a dedicated public servant who served as a Mobile County Commissioner from 1988 to 1992, and earlier as a state senator representing Mobile County's District 35. He said Mr. Menton, a graduate of Spring Hill College, was an outstanding athlete and a member of four (4) Halls of Fame; two (2) are the Spring Hill College Badger Hall of Fame and the Mobile Sports Hall of Fame. Commissioner Carl said Mr. Menton coached at Spring Hill College and also helped establish Little League Baseball in Mobile, in addition to serving as General Manager of the Mobile Tarpons minor league football team and Assistant General Manager of the Mobile A's minor league baseball team. He said Mr. Menton was a devout Roman Catholic, a faithful member of St. Margaret Catholic Church in Bayou la Batre and was bestowed the honor of Knight of St. Gregory by Pope John Paul II. Commissioner Carl said Mr. Menton served as a Mobile County Juvenile Probation Officer, helped establish a Juvenile Division for the Mobile County Sheriff's Office and served with distinction as Police Chief of Bayou la Batre, as a Crime Prevention Officer for Mobile County public schools, and as Executive Director of the Alabama Fraternal Order of Police. Commissioner Carl said Mr. Menton is survived by his beloved wife of sixty-five (65) years, Carmen Santana Menton, eight (8) children, six (6) grandchildren and four (4) great grandchildren. He said Mr. Menton was widely respected for his commitment and exceptional abilities as he worked to benefit his fellow citizens and had a positive impact on the lives of countless young people and while his presence will be missed, his legacy of public service will endure for generations.

Commissioner Carl said in recognition of Mr. Menton's service to Mobile County and the citizens, the Commission designates County Route 39 as Bill Menton Memorial Highway and authorizes the placement of signs, so indicating such designation.

PRESENT RESOLUTION/MAURY FRIEDLANDER

The following is a synopsis of the comments made:

President Hudson said Maury Friedlander was a well-known and beloved member of this community who devoted more than fifty (50) years of his life to the betterment of Mobile County, Alabama. She said it is with great sadness we acknowledge his passing on Thursday, March 6, 2014, and his lasting legacy was his commitment to helping his fellow man and giving unconditionally to others. President Hudson said we recognize the love and commitment Mr. Friedlander had to his family, church and community. She said his everlasting presence will be left in the hearts and minds of those who loved, respected and admired him. President Hudson said Mr. Friedlander earned his law degree from the University of Alabama and an undergraduate degree in business from the University of Michigan. She said Mr. Friedlander was a partner with Marr & Friedlander and served with distinction as an attorney for the Mobile County Commission from 1969 to 1985. She said in addition, Mr. Friedlander provided legal assistance to the Mobile County Racing Commission, the Dauphin Island Water, Sewer & Fire Protection Authority, the Industrial Development Authority of Mobile County, the Mobile County Communications District and also served as Municipal Judge for the City of Mobile from 1966 to 1969. President Hudson said Mr. Friedlander was married to Mary Ann Friedlander for thirty-two (32) years and was the father of Harryl Amy Friedlander, Beth Friedlander Vorwaller and Michael B. Friedlander, all of whom will cherish his memory. She said Mr. Friedlander left a legacy of giving to others in need throughout the community, whether individuals or groups; in particular, for the special needs population of Mobile County, including creation of the Alabama Family Trust to protect the inheritance and distribution of funds for people with mental and physical disabilities; he founded L'Arch Mobile, led Mobile ARC and served Mulherin Custodial Home, all of which helped the disabled; he also served generously his faith home of Springhill Avenue Temple. She said Mr. Friedlander, in his leisure time, distinguished himself as an avid gin rummy player who won several Las Vegas tournaments, a hobby that grew out of his ability with numbers and an outstanding memory.

President Hudson said by devoting his life to helping others, Mr. Friedlander truly earned the respect of many residents of Mobile County and the State of Alabama.

The Commission wishes to respectfully offer our deepest heartfelt condolences to the family of the late Maury Friedlander during this time of bereavement and we further acknowledge his many contributions and commitment to serve Mobile County with the signing of this resolution.

The following is a synopsis of the comments made:

Terri Grodsky, Retired Senior Volunteer Program (RSVP), and Belinda Metzger, Senior Companion Program (SCP). Ms. Grodsky addressed the Commission and said they represent the Retired Senior Volunteer Program (RSVP), the Senior Companion Program (SCP) and the Foster Grandparent Program (FGP). She said the volunteers working in those programs are over fifty-five (55) years old and feel lucky to be sponsored by the Mobile County Commission. Ms. Grodsky said President Barack Obama's proposed 2015 budget would eliminate two-thirds (2/3) of all retired senior volunteer programs across the Country. She said the Retired Senior Volunteer Program (RSVP) in Mobile, Alabama, has helped over ninety-two (92) nonprofit agencies. Ms. Grodsky said the Senior Companion Program (SCP) and the Foster Grandparent Program (FGP) would become part of a totally redesigned AmeriCorps Program that would drastically reduce their presence in Mobile County. She said the hours of service performed by volunteers at the Senior Companion Program (SCP) and the Foster Grandparent Program (FGP) would decrease from one thousand forty-four (1,044) hours each year to four hundred fifty (450) hours, resulting in fewer hours for volunteers at the Senior Companion Program (SCP) to care for the frail elderly in their homes and fewer hours for volunteers at the Foster Grandparent Program (FGP) to mentor and nurture fewer special needs children. Ms. Grodsky said they hope the Commission can help them save the senior services programs.

President Hudson said the ramifications of those proposed budget reductions is dire news. She said the senior services programs are critical for citizens in the community. President Hudson said our Country faces huge deficit issues, but senior services programs directly impact lives and she hopes they will find a way to save them.

Commissioner Carl asked how much will the loss be in dollar amounts for those senior programs?

Ms. Grodsky said she does not have the dollar amounts available right now, but she would provide those figures to him later.

March 24, 2014

Commissioner Ludgood said she was willing to write a letter to Alabama's Members of Congress to ask them to weigh-in on our behalf. She said in the process of balancing the Country's budget, it sometimes adversely affects the most vulnerable population. Commissioner Ludgood said those programs are very important not only to the volunteers, but also critical for many families who could go on with their lives because they can depend on a volunteer to come to their home to take care of a family member. She said she would be happy to participate in various events, for example, a petition drive to raise public awareness. Commissioner Ludgood said the ones who use the services know it best, but if the rest of the public understood who would be affected they would rally around it. She said she is willing to do that and to make sure Alabama's Congressional Delegation understands what it means for our community. Commissioner Ludgood said the dollar amounts Commissioner Carl requested would help them know who would be affected and to what degree. She said it would be a real tragedy if senior volunteer services were ended.

President Hudson said their offices are willing to make sure Alabama's Congressional Delegation knows the impact it will be on our area.

Ms. Metzger said the U. S. Congress, senators and representatives from the State of Alabama have a wish list of programs they want to save, and she wants the senior volunteer programs to get on that wish list.

Commissioner Ludgood said it would be helpful to have vignettes included with their letters about the difference made in the lives of families because of the services provided by senior volunteers in those programs. She said the vignettes would humanize their concerns to be seen as real people and not just as numbers.

Nayyer Mahdi, Grants Director, said they have finally received the 2014 allocations. She said the Community Development Block Grant (CDBG) funds were reduced \$75,293.00, approximately five percent (5%): 2013 the Community Development Block Grant (CDBG) funds received were \$1,652,536.00 and in 2014 the funds received were \$1,577,243.00. She said the HOME funds were increased approximately three percent (3%): 2013 the HOME funds received were \$519,116.00 and in 2014 the funds received were \$534,992.00. Ms. Mahdi said the Emergency Solutions Grant (ESG) funds were increased \$15,980.00, approximately thirteen percent (13%): 2013 the Emergency Solutions Grant (ESG) funds were \$118,270.00 and in 2014 the funds received were \$134,250.00. She said they had not received 2014 allocations when they prepared the 2014 budget which had a deadline of February 21, 2014, so they budgeted a 10% reduction for 2014 allocations from the allocations received in 2013. Ms. Mahdi said they also included a contingency in the Action Plan, that if funds were increased, they would have an across the board increase in all of the allocations they had budgeted. She said April 15, 2014, is the deadline for the U. S. Department of Housing and Urban Development (HUD) to receive their 2014 Year Five Action Plan. Ms. Mahdi said her request for the Commission to adopt the Action Plan would be on the agenda for the April 14, 2014 meeting. She said their startup date is June 1, 2014 and if they need to readjust a couple of things they can do a formal amendment after they have received their funding, and then ask the U. S. Department of Housing and Urban Development (HUD) for an adjustment to their projects.

President Hudson asked Ms. Mahdi if an amendment will be done on April 14, 2014 to increase those line items?

Ms. Mahdi said an amendment was not needed because they have a contingency included in their Action Plan. She said her request would be for the Commission to adopt the new figures and after June 1, 2014, when they have received release of funds from the U. S. Department of Housing and Urban Development (HUD), if needed, they would ask for an adjustment on their projects.
