The Mobile County Commission met in regular session in the Government Plaza Auditorium, in the City of Mobile, Alabama, on Monday, May 13, 2013, at 10:00 A. M. The following members of the Commission were present: Merceria Ludgood, President, Connie Hudson and Jerry L. Carl, Members. Also present were Glenn L. Hodge, Deputy Administrator, Jay Ross, County Attorney, and W. Bryan Kegley II, Assistant County Engineer. President Ludgood chaired the meeting.

INVOCATION

The invocation was given by Pastor Michael Weatherly of Faith Baptist Church, 2801 Knollwood Drive, Mobile, Alabama 36693.

PRESENT RESOLUTION/PROCLAIM WEEK OF MAY 6, 2013 THROUGH MAY 10, 2013 AS SENIOR CORPS WEEK IN MOBILE COUNTY

The following is a synopsis of the comments made:

The Commission presented a resolution to Terri Grodsky, Retired Senior Volunteer Program, Belinda Metzger, Senior Campaign Program (SCP) and Toni Robinson, Foster Grandparent Program (FGP).

President Ludgood said older Americans bring a lifetime of skills and experience as parents, workers and citizens that can be tapped to meet challenges in our communities. She said for more than four (4) decades the three (3) programs of Senior Corps - Retired Senior Volunteer Program (RSVP), Senior Companion Program (SCP) and the Foster Grandparent Program (FGP) have proven to be a highly effective way to engage Americans ages fifty-five (55) and older in meeting national and community needs. President Ludgood said each year Senior Corps provides opportunities for nearly 330,000 older Americans across the nation to serve their communities. She said Senior Corps volunteers last year provided more than 96.2 million hours of service, helping to improve the lives of our most vulnerable citizens, strengthen our educational system, protect our environment, provide independent living services and contribute to our public safety. President Ludgood said Senior Corps volunteers build capacity for organizations and communities by serving through more than 65,000 non-profit, community, educational and faith-based community groups nationwide. She said at a time of mounting social needs and

growing interest in service by older Americans, there is an unprecedented opportunity to harness the talents of fifty-five (55) plus volunteers to address community challenges. President Ludgood said service by older Americans helps volunteers by keeping them active, healthy and engaged, helps our communities by solving local problems and helps our nation by saving taxpayer

dollars, reducing health care costs and strengthening our democracy. She said the Senior Corps Week is an opportunity to thank Senior Corps' volunteers for their service and recognize their positive impact and value to our communities and nation.

The Commission designates May 6, 2013 through May 10, 2013 as Senior Corps Week in Mobile County, Alabama, and urges all residents to recognize Senior Corps' volunteers and programs for their valuable impact on our communities.

President Ludgood thanked them all and said they make a tremendous difference in the lives of the people they serve.

Ms. Grodsky thanked the Commission for their continued support and said they were one of the luckiest cities in Alabama to have all three (3) Senior Corps' programs.

PRESENT RESOLUTION/PROCLAIM
MAY 21, 2013 AS EXCELSIOR
BAND DAY IN MOBILE COUNTY

The following is a synopsis of the comments made:

The Commission presented a resolution to the Excelsior Band, who have marched through the streets of downtown Mobile for more than one hundred (100) years playing joyful and electric jazz in countless Mardi Gras parades and now the group will be recognized by the Alabama State Council on the Arts' 2013 Folk Heritage Award.

President Ludgood said the Alabama Folk Heritage Award was established to recognize master folk artists who have made outstanding contributions to the arts in Alabama, and the Excelsior Band will be presented the honor at the 2013 "Celebration of the Arts" awards ceremony to be held May 21, 2013, at the Alabama Shakespeare Festival in Montgomery. She said the Excelsior Band, founded by John A. Pope to celebrate the birth of his son, John C. Pope in Mobile, Alabama, November 23, 1883, has a very rich history. President Ludgood said the band performs regularly along the Gulf Coast and is recognized for providing the traditional tunes associated with the carnival season. She said the Excelsior Band, a ten piece marching brass band that consists of three (3) trumpets, three (3) saxophones, one (1) trombone, a tuba, bass drum and snare drum, has also captivated audiences at weddings, receptions, jazz funerals and conventions. President Ludgood said members of the Excelsior Band come from diverse occupational backgrounds and all are famous in the Mobile area for their many years of musical contributions throughout the city.

President Ludgood said the Commission proclaims May 21, 2013, as Excelsior Band Day in Mobile County, Alabama, and congratulated them on this auspicious honor and thanked the band for delighting so many with their music. She said their contributions to the arts were immeasurable.

President Ludgood said this award is granted to master folk artists that have made outstanding contributions to the arts in this community. She said since its inception, the band has been an important part of the cultural life of the community for the entire time.

Hosea London, Excelsior Band Leader and Manager, thanked the Commission and said after Mardi Gras season, the band plays all over the place, from the Grand Hotel to the Battle House Renaissance Hotel to somebody's backyard. The following is a synopsis of the comments made:

The Commission presented a resolution to George W. She said he has held memberships in professional affiliations, including Association of Public-Safety Communications Officials (APCO), National Emergency Number Association (NENA), Board of Directors Alabama NENA and Vice President of Alabama Association of 911 Districts (AAND). President Ludgood said Mr. Williams, an honorably discharged soldier of the United States Air Force, has been recognized for his dedication and hard work, he steadily excelled in taking on responsibilities and was best known for setting the level of professionalism at the 911 Center and for his many contributions toward its advancement. She said Mr. Williams has earned the respect and gratitude of his colleagues, co-workers and the public, for his willingness to help others and his adherence to the highest standards of ethical conduct, his dedication and conscientious service is immeasurable.

The Commission wishes to join with the Mobile County Communications District Board and the 911 Center staff in commending Mr. Williams on his many years of public service and extend their heartfelt best wishes to him for continued peace, happiness and blessings for years to come.

President Ludgood said the 911 Center handles non-emergency calls and when she went on a tour of the center Mr. Williams was

like a parent with a new baby. She said he was so proud of all the work that was accomplished and she was impressed with what she saw. President Ludgood thanked Mr. Williams for the advancements he has helped make in the 911 Center.

Mr. Williams said the 911 Center is a great asset to the citizens in Mobile County and several accomplishments have been made during the last seventeen (17) to twenty (20) years. He said he was very proud of the 911 Center and he appreciates receiving recognition from the Commission, it is a honor.

The following is a synopsis of the comments made:

Eileen Corkern, Representative of the Azalea City Cat Coalition and Alley Cat Allies, addressed the Commission about a recommendation to decrease the holding time of feral cats so they could be exterminated quicker. She said killing the cats sooner does not resolve the overpopulation problem and there were alternative humane methods for controlling the population of feral cats. Ms. Corkern said many large cities across the United States were pursuing Trap-Neuter-Return (TNR) programs to reduce their overpopulation of feral cats. She said it was very expensive to euthanize a cat, it cost approximately \$150.00 to \$160.00 according to the information reported by the Best Friends Animal Sanctuary. Ms. Corkern said the Azalea City Cat Coalition was one of the first organizations in Mobile County to offer Trap-Neuter-Return (TNR) programs. She said the Azalea City Cat Coalition charge a fee of only \$60.00 to spay and neuter a cat and unlike dogs, cats could have three (3) litters a year, so in five (5) years a mother and her babies could have up to five hundred thousand (500,000) kittens. Ms. Corkern said they would like to have the opportunity to work with the Mobile County Animal Shelter in resolving the overpopulation issue of feral cats.

Commissioner Hudson thanked Ms. Corkern for her input and asked if she had been in contact with the Mobile County Animal Shelter (MCAS) Advisory Board.

Ms. Corkern said No.

Commissioner Hudson said Dr. Jeni Knizley, Chairman of the Mobile County Animal Shelter (MCAS) Advisory Board explained to the Commission that holding feral cats in cages for longer than three (3) days was inhumane. She requested Ms. Corkern to make an appointment with Dr. Knizley to discuss the information she has shared with the Commission.

President Ludgood said she received some information from Cynthia Hammer, a constituent, on Trap-Neuter-Return programs which she found very informative. She said she has forwarded the information to Donna Jones, General Services Director, to discuss with the advisory board.

Commissioner Carl said he worked a couple of hours with Dr. Freeman of Albany, Georgia, who told him that they were using the cats in Albany, Georgia, to keep the rodents down. He said the feral cats were spayed, neutered and one of their ears were clipped, so when they catch them the second time they automatically turned them loose.

Subsequent traffic control devices deemed necessary by the COUNTY in keeping with applicable statutes and other requirements of the STATE to promote the safe and efficient utilization of the highway under the authority of *Title 32, Chapter 5, Code of Alabama 1975*, and in all other applicable laws of Alabama, shall be subject to the approval of the STATE and of the FHWA, and the COUNTY further agrees that it will enforce traffic and control the same under the provisions of *Title 32, Chapter 5, Code of Alabama 1975*, and other applicable laws of Alabama.

BE IT FURTHER RESOLVED by this Commission that the COUNTY agrees to perform all maintenance on all newly constructed, relocated, or improved roads, crossroads, and service roads, that

are a part of the project, are within the jurisdiction of the COUNTY, and which are not designated as State or Federal Highways.

It is understood and agreed that no changes in this Resolution shall be made in the future without having obtained prior approval of the FHWA.
