MOBILE COUNTY COMMISSION

The Mobile County Commission met in regular session in the Government Plaza Auditorium, in the City of Mobile, Alabama, on Tuesday, May 28, 2013, at 10:00 A. M. The following members of the Commission were present: Merceria Ludgood, President, Connie Hudson and Jerry L. Carl, Members. Also present were John F. Pafenbach, County Administrator/Clerk of the Commission, Jay Ross, County Attorney, and W. Bryan Kegley II, Assistant County Engineer. President Ludgood chaired the meeting.

INVOCATION

The invocation was given by Reverend Rocky Pugh, Pastor of Emmanuel Baptist Church, 5601 Zeigler Boulevard, Mobile, Alabama 36608.

PRESENT RESOLUTION/PROCLAIM MAY, 2013 AS NATIONAL TEEN PREVENTION PREGNANCY MONTH

The following is a synopsis of the comments made:

The Commission presented a resolution to Jamale Daniels and Brittany Ransom, participants of the Mobile Teen Center, a project of the Mobile County Health Department, designed to educate teenagers with the knowledge and skills to prevent pregnancies through community engagement and public awareness.

President Ludgood said more than 700,000 teenagers become pregnant each year and despite progress over the last decade, nearly three (3) in ten (10) teenagers in the United States become pregnant, the highest teen pregnancy rate among comparable countries. She said teen pregnancy was closely linked to a number of critical social issues such as poverty, educational attainment and involvement in the criminal justice and child welfare systems. President Ludgood said teen childbearing costs United States taxpayers \$10.9 billion each year, most of which was due to costs associated with negative consequences for the children of teen mothers, including increased costs for health care, foster care, incarceration and lost tax revenue. She said a child was nine (9) times more likely to grow up in poverty if he or she was born to unmarried teen parents who have not yet completed high school; and nearly all teens and adults say that reducing teen pregnancy was a very effective way to reduce the high school dropout rate and improve academic achievement. President Ludgood said seventy-four percent (74%) of adults and a multitude of teens wish teens were getting more information about both abstinence and contraception, rather than either/or; and seven (7) in ten (10) adults agree there should be more community efforts to reduce teen pregnancy. She said the Commission proclaims May, 2013, as National Teen Prevention Pregnancy Month and by raising awareness about the importance of this critical issue, promoting parent-child communication and investing in programs that have

been proven to reduce teen pregnancy.

PRESENT RESOLUTION/DR. BARRY LEE BOOTH/ADVOCATE OF VETERANS

The following is a synopsis of the comments made:

The Commission presented a resolution to Dr. Barry Lee Booth, a dedicated, devoted advocate of veterans, who is a well-known and respected member of our community.

Commissioner Hudson said Dr. Booth has helped with the establishment of a Vietnam Veterans Memorial at the USS Alabama Battleship Park and most notably assisted with the Honor Flight South Alabama Program which flies World War II (WWII) veterans to Washington, D.C. to visit the memorial. She said Dr. Booth was a native of Charleston, West Virginia, who has practiced dentistry in the community of Spanish Fort, Alabama, in the same location for more than forty-four (44) years; he has continuously given of his time and talents to help others over the years which has included traveling throughout Vietnam, Central America, parts of South America, Jamaica and Cuba as a dental volunteer, often providing the only dental care available in those areas.

Commissioner Hudson said Dr. Booth has also rendered his services closer to home, which include volunteering after the September 11, 2001 terrorist attacks, by working at St. Paul's Church at the World Trade Center, and subsequently spending several years volunteering as a dentist at Naval Air Station, Pensacola, Florida, and after Hurricane Katrina, he and his devoted staff delivered much needed supplies to New Orleans, Louisiana; Pass Christian, Mississippi; Ocean Springs, Mississippi; Pearlington, Mississippi; Slidell, Louisiana; and Bayou La Batre, Alabama; she said they have also provided dental care at the United States Department of Defense emergency mobile hospital in Gulfport, Mississippi. Commissioner Hudson said Dr. Booth was a decorated officer honorably discharged from the United States Navy in July, 1969, a member of the Vietnam Veterans of America Chapter 864, Sons of the American Revolution Galvez Chapter, the Veterans of Foreign Wars and a life member of the American Legion Post 199; and, was appointed to the USS Alabama Battleship Commission in 2005, by Governor Bob Riley. Commissioner Hudson said Dr. Booth was the owner of Shiloh Nature Preserve which surrounds historic Saluda Hill Cemetery near Spanish Fort, made part of the Preserve available to the Baldwin County Commission, which unanimously supported Dr. Booth's effort to establish a veterans' cemetery; he has earned the respect and gratitude of many veterans and the public, for his willingness to help others and his adherence to the highest standards of ethical conduct, his dedication and conscientious service are immeasurable.

The Commission salutes Dr. Booth on his many years of support to veterans; and commends his service not only to the United States, but to our community and we extend our heartfelt best wishes to

him for continued peace, happiness and blessings for years to come.

Dr. Booth thanked the Commission for their kind remarks. He said the Honor Flight South Alabama Program was not established by an individual, but it was a communal project made up of talented individuals with different interests. He said they were all devoted, passionate and dedicated to the honorable and noble cause of the Honor Flight South Alabama Program. Dr. Booth said they held hands together, everybody carried water from the same spot in their heart and they carried it to the same destination which was the Honor Flight South Alabama Project. He said there was no way it would have been unsuccessful and he was so fortunate to have worked with the team and volunteers through the entire mission, because at the end of the day they all shared equally the sense of accomplishment by the Honor Flight South Alabama Program being so successful.

Dr. Booth introduced Colonel Harry Morgan, a World War II veteran, who also served in the Korean War and the Vietnam War. He said Colonel Morgan has been shot down in combat four (4) times. Dr. Booth said he was grateful that Colonel Morgan came on board and promoted the Honor Flight South Alabama Program when it was in its infancy.

A team member of the Honor Flight South Alabama Program said it was an honor for him to present to the Commission the last United States Flag flown on the Honor Flight South Alabama. He said it was an American Service Flag representing the five (5) branches of the military.

Another team member of the Honor Flight South Alabama Program invited World War II veterans to the podium: Berney Gash, Red Bus Captain; Colonel Bill Calendar, White Bus Captain; Mega Marshall, Blue Bus Captain; Orby Fuller, Gold Bus Captain; and Ann Eubanks, Springhill Medical, who was in charge of medical support for their flights.

Dr. Booth said Margaret Coley, Choreographer, Honor Flight South Alabama Program, started the Pennies for Patriots program. He said five (5) gallon jugs were delivered to Mobile County and Baldwin County schools for the students to drop their coins in. He said they visited St. Elmo Elementary School, Irvington, Alabama, which was a Title I School, eighty percent (80%) of the students were living below the poverty level. He said in the jugs were white strips of paper mixed in with the coins and he asked the principal about it. Dr. Booth said the principal told him those white strips were earning learning certificates given to students for their various achievements which could be used to buy snacks. He said those students had no pennies to put in the jugs, but wanted to participate in the Honor Flight Pennies for Patriots Program so they put their earning learning certificates in those jugs. Dr. Booth said it was heartwarming that those students having no coins to give, gave their earning learning certificates to help the Honor Flight South Alabama Program.

Darryl Daugherty, Representative, Mobile Area Disc Golf Association (MADGA), addressed the Commission and said at Chickasabogue Park approximately six hundred (600) people play that course each year. He said he was made aware through a flyer handed out at the park that money would be spent for improvements and his organization would like to receive some of those funds, if possible, to improve the course. Mr. Daugherty said his organization has hosted an annual tournament at the park for over twenty-six (26) years. He said the members of his organization have installed all the courses at the park at their own expense. Mr. Daugherty said his organization was not classified as nonprofit and does not reap nonprofit benefits and they could use the funds to help them improve the course. He said previously Chickasabogue Park was under the Road & Bridge Department and it appeared they did not care about the park, for example, they use to have seasonal passes; \$20.00 for individuals, \$33.00 for families. Mr. Daugherty said fifteen (15) of those seasonal passes came up missing from the office causing the disc golfers to pay out of their pockets. Mr. Daugherty said they have approximately two hundred (200) people who play at Chickasabogue Park on a weekly basis and he personally plays at the park two hundred (200) times a year, with his family fifty (50) times a year. Mr. Daugherty said a \$1.00 entry fee was not much, but each time a person comes and goes it cost. He said in the last six (6) years his organization has paid approximately \$150,000.00 to install the disc catchers, concrete T-Pads, course improvements and hosting tournaments. Mr. Daugherty said any money they could get to help them improve their portion of the park would be greatly appreciated. He thanked the Commission for their time.

President Ludgood said the change in management of Chickasabogue Park did not make a difference, people do care.

Mr. Daugherty said he apologizes, he did not mean any

disrespect.

President Ludgood said they have not had an opportunity to have a meeting to know what was wanted at the park. She requested Mr. Daugherty to give the Commission a list of the improvements his organization would like to have for disc golfing.

Mr. Daugherty said they could meet with someone at the park once or twice a year to discuss it, but they do not know who to contact.

President Ludgood asked Mr. Daugherty for his telephone number.

Mr. Daugherty said his telephone number was 251-786-1036.

President Ludgood said someone would be in contact with him to schedule a meeting.

Mr. Daugherty said they would love to have someone working with them to improve the park for the community, even if they do not receive any funds.

President Ludgood thanked Mr. Daugherty for his interest and support of Chickasabogue Park.

Paul Brouillette, President, Southern Alabama Mountain Bike Association (SAMBA), addressed the Commission and said his organization was formed in late, 2012, as Tax Exempt 501(c)(3) Nonprofit which currently has seventy (70) members from Pensacola, Florida to New Orleans, Louisiana. He said it became an International Mountain Bike Association (IMBA) Chapter in March, 2013, and has logged over two hundred (200) hours of trail maintenance at Chickasabogue Park.

Mr. Brouillette said they promote education on responsible off-road bicycling and advocate for quality trail systems that were both easily accessible and environmentally sensitive, as well as promote an active lifestyle that would give back to the community. He said they would like to have a beginners level mountain bike trail at Chickasabogue Park for families with small children to enjoy.

President Ludgood referred Mr. Brouillette to Cathy Burden, Grants Administrator; and said Ms. Burden was the person putting a package together for a grant application to the State of Alabama requesting funds for improvements to Chickasabogue Park. President Ludgood thanked

Mr. Brouillette for his input.
