The following is a synopsis of the comments made:

President Hudson said unfortunate and unnecessary publicity had surrounded the presidency rotation. She said she would respect and acquiesce to the majority decision of the Commission. President Hudson said Commissioner Carl would make an excellent president and he has the skills to do it, but it would be a new role for him. She said it would take time for Commissioner Carl to learn the responsibilities, to become acquainted with the protocols and what the job entails. President Hudson said she has served in government going on twelve (12) years, in two (2) different roles and from her experience it is difficult to walk into a brand new situation and start as the president or chairperson. She said when she was elected to the Commission, Commissioner Ludgood was the president and if it had not been for Commissioner Ludgood continuing the role as president for well over a year, she herself would not have been nearly as prepared to step into the presidency. President Hudson said the ado reported in the newspapers about a power struggle for the presidency because of the Gulf Coast Recovery Council was nonsense. She said the President of the Commission represents the entire Commission as a member of the Gulf Coast Recovery Council. President Hudson said they were in the process of forming bylaws for the committee and it was not a secret that she wanted to see the work she has done through its fundamental phase. She said they did not have a

November 14, 2012

settlement from BP PLC yet and they did not know when it would happen. President Hudson said over the next four (4) years the rotation of the presidency would give each Commissioner an opportunity to be a member of the Gulf Coast Recovery Council. She said she recommends the Commission to change the formation of the rotation to begin with District 2 for the sake of continuity, the next sixteen (16) months would rotate to Commissioner Carl, District 3 and then Commissioner Ludgood, District 1. President Hudson said it was in the best interest of the County for the Commission to accept her recommendation.

Commissioner Carl moved that the Commission continue the same formation process as the prior Commission and rotate the presidency term every sixteen (16) months, beginning with District 3, followed by Commissioner Ludgood, District 1 and then Commissioner Hudson, District 2.

Commissioner Ludgood said she would not second Commissioner Carl's motion because the rotation of presidency has not always been done in numerical order and the media has planted the seed that the presidency should begin its rotation with District 3. She said it has never worked out that way because of the complexities involved in the composition of the Commission. Commissioner Ludgood said there have been times when there were no Commissioners for District 1 and District 2, so the order of formation had gone askew on rotating the presidency. She said it was nothing magical about President Hudson being number two in the rotation. Commissioner Ludgood said when President Hudson was elected there was a vacancy in District 2 and it would have rotated to former Commissioner Stephen Nodine only because he wanted to be President of the Commission during an election cycle. She said if you study the Commission rotation formation history it would show it has not been done in numerical order.

Motion failed for lack of a second.

Commissioner Ludgood moved that the president term begin today and end November, 2016, commencing rotation of the presidency with District 1, then District 2 and the last one in the rotation would be District 3.

President Hudson asked if Commissioner Ludgood's motion was to begin the presidency rotation cycle with District 1 and then it would rotate to District 2?

Commissioner Ludgood said yes and District 3 would be the last one to rotate.

John Pafenbach, County Administrator, said the Commission also needs to elect a vice-president for each term.

Commissioner Ludgood moved that the vice-president for District 1 presidency would be District 2 and the vice-president for District 3 presidency would be District 1.

President Hudson asked if the vice-presidency would rotate
