The Welcome Center will be inspected prior to releasing the unit for rental to your group or party, and its condition duly noted. By affixing your signature to this agreement, you thereby assume all responsibility for the area, clean-up, and protection of the Welcome Center and its contents, and agree to pay for any damage occurring during this period.

Renter will also be responsible for a \$250.00 deposit to accompany and finalize this reservation if rental of kitchen is included. Rental without the kitchen includes a \$50.00 deposit fee to accompany and finalize this reservation. Rental Fee is due two weeks before the date of event. Renter assumes all assumption of risk and will not hold Mobile County or River Delta liable for any risk, actions or events that may occur during renter's contract agreement. Renter furthermore agrees to abide by all the rules and regulations governing the use of Mobile County's River Delta.

**NOTE:** The deposit guarantees the reservation. The deposit fee is given back after the event if there is no damage to the facility, this includes stains in the carpet or on the walls, broken chairs or tables. **The deposit fee is not refundable if there is any alcohol at your event.** Mobile County does not allow any alcohol on its premises. A three weeks' notice of a cancellation is required for any remaining portions of rental fee to be refundable if paid in advance.

River Delta further reserves the right, at any time during occupancy, if any of the above agreements are not met, to require the Welcome Center to be vacated.
