- 1E RECOMMEND approving right-of-way and/or easement agreement for Tract 2 in the amount of \$1,500.00 for MCP-304-16/CIP-2015-014, Sunset Road Bridge Replacement.
- 2E RECOMMEND adopting a resolution authorizing request of the Engineering and Public Works Department to dispose of certain items from fixed assets inventory list, declare as surplus property, and authorize items to be disposed of by lawful means.
- 3E RECOMMEND approving agreement for relocation of telephone cable facilities in conflict with proposed roadway improvements with CenturyLink, for Project MCR-2016-305, Nelson Road, Glaze Road, and Rainey Drive. This agreement allows twenty (20) working days to complete the relocation activities.
- 4E RECOMMEND approving reimbursable agreement for installation of waterline facilities within County right-of-way for facilities in conflict with MCP-304-16/CIP-2015-014, Sunset Road Bridge Replacement. The total estimated cost to be reimbursed to Mobile County is \$63,254.00.
- 5E RECOMMEND approving right-of-way and/or easement agreement for Tract 11 in the amount of \$53,550.00 for Project MCR-2014-012(B), Dawes Road - Widening, Resurfacing, and Striping.
- 6E RECOMMEND assigning contract for professional engineering and bridge inspection services for MCP-004-20, County Wide Bridge Inspection Services, to Volkert, Inc.
- 7E RECOMMEND approving preliminary and final plat of JT Estates. (3 lots, Natchez Highway, District 2)

- 8E CONSIDER waiving Section 4.23 of the Mobile County Subdivision Regulations (requiring right-of-way dedication) and Section 7.1 of the Mobile County Subdivision Regulations (allowing subdivision of property along unpaved private roads), and approving preliminary and final plat of Escape On The Bay. (3 lots, Dauphin Island Parkway, District 3)
- This subdivision is partially along an existing private drive which does not appear on the County road inventory as an existing private road. All lots have direct access along Dauphin Island Parkway.
- The Engineering Department has no objection to the granting of this waiver.
- 9E RECOMMEND adopting a resolution and accepting an agreement with Alabama Power to provide additional power for street light improvements at one (1) intersection.
- 10E RECOMMEND authorizing to advertise and receive bids for Project MCR-2018-109, Glenway Drive - Grade, Drain, Base and Pave (GDBP)
- 11E RECOMMEND approve assigning Neel-Schaffer Inc. the Contract for Professional Engineering Services for Project CIP-2019-002B, Mobile County Soccer Complex, Phase Two.
- 12E RECOMMEND approving annual renewal of Bentley SELECT Program for Power InRoads, Microstation and InRoads Survey CAD Software and Support. The total cost is \$11,907.07, for Engineering and Public Works Department.
