pertaining to the "Petition for Private Road Dirt Road Maintenance" for Pineview Avenue. Upon review of the 1984 aerial photographs this road was platted but did not exist as an open roadway, therefore the petition does not qualify for acceptance.

- 4E CONSIDER accepting the report from the County Engineer pertaining to the "Petition for Private Road Dirt Road Maintenance" for Mausap Road. Upon review of the 1984 aerial photographs this private road existed as what appears to be a narrow (8' to 10' wide in several areas) driveway serving several residences, with patches of grass between the wheel paths, indicating that the driveway was not a wellused roadway, therefore the petition does not qualify for acceptance.
