- 2. The Commission shall hold a combined conference and regular meeting on November 30, 2020 at 10:00 a.m. in the Auditorium of Mobile Government Plaza.
- 3. Beginning on the second Monday in December, i.e., December 14, 2020, the Commission shall hold its regular meetings as \*attached on the second and fourth Mondays of each month at 10:00 a.m. in the Auditorium of Mobile Government Plaza. The Commission reserves the right and shall have the authority to recess a regularly-scheduled meeting and reconvene at a time and place announced by the Commission.
- 4. Also, beginning on December 10, 2020, the Commission shall hold conferences as \*attached on the Thursday next preceding each regular meeting in the Assembly Room (Multi-Purpose Room), or the Auditorium, of Mobile Government Plaza, as may be designated from time to time.
- 5. In the event a conference or regular meeting day falls on a legal public holiday, the regular meeting shall be held on the following business day, unless the Commission exercises its authority pursuant to Section 11-3-8(c), Code of Alabama (1975), to meet on any day of the following week or at another time and issues a notice of the alternative time at least five (5) days prior to the meeting.
