2) APPROVE assigning contract for professional

engineering services for MCP-007-23, Regionwide Transportation Operations Program Congestion Management, to Kimley-Horn and Associates, Inc., requested by the

Engineering and Public Works Department.

3) APPROVE the transfer of maintenance duties from the

County of Mobile to the City of Creola for the segment of Lister Lane (CR #6489) from Old Highway 43 eastward to the end of maintenance. Length of roadway is approximately 1,400 feet. Lister Lane was reportedly paved by the City of Creola, and the Mayor of Creola has requested that the County of Mobile relinquish maintenance, requested by the Engineering and Public

Works Department.

4) APPROVE Contract Amendment #2 with McCrory and

Williams, Inc. for Projects STPMB-4918(251), MCP-49-091-19, and MCR-2018-002, Additional Lanes on Airport Boulevard (CR-56), to add additional engineering and design services for revisions to environmental documents.
