- 4) APPROVE the application for federal assistance (100% funding) for the Jeremiah A. Denton Airport (FY 2022) in the amount of \$22,000.00. This application requests available reimbursement for related operations, personnel, cleaning, sanitization, janitorial services, and combating the spread of pathogens at the Jeremiah A. Denton Airport, Mobile County project number CCP-003-20.
- 5) APPROVE Hold Harmless/Indemnity Agreement FY 2021-2022, for the use of County equipment from the following:
- City of Prichard
- 6) APPROVE preliminary and final plat of Jordan Estates. (4 lots, Ramsey Road, District 3)
- AND
- preliminary and final plat of Nora Jones Subdivision. (2 lots, Henry Davis Road, District 1)
- 7) APPROVE Resolution concurring with the Alabama Department of Transportation (ALDOT) closing a segment of Walter Tanner Road to accommodate the construction of US Hwy 98 (SR-158) from the Mississippi state line to 0.5 mile east of Glenwood Road. In cooperation with ALDOT, Mobile County will construct temporary turnarounds on the north and south ends of the road closure, and install appropriate signage, which will remain in place until ALDOT constructs permanent turnarounds as part of its construction project.
- 8) APPROVE awarding the bid for Project MCP-003-18, Cemetery Road Drainage Improvements, to HCL Contracting, LLC, for their low bid of \$140,578.86.

- 9)     **AUTHORIZE**       to advertise and receive bids for Project RA49-02-21 / MCP-013-20, Sand Ridge Road Full Depth Reclamation.
