MOBILE COUNTY COMMISSION

The Mobile County Commission met in regular session in the Mobile Government Plaza Auditorium, in the City of Mobile, Alabama on Tuesday, December 27, 2022, at 9:30 a.m. The following members of the Commission were present: Connie Hudson, President, and Merceria Ludgood, Member. Randall Dueitt, Member, was absent. Also present were E. Edwin Kerr, Deputy County Administrator/Clerk of the Commission, Jay Ross, County Attorney, and W. Bryan Kegley II, County Engineer. President Hudson chaired the meeting.

INVOCATION

The invocation was given by Pastor Christopher L. Williams Sr., Yorktown Missionary Baptist Church (Africatown), 851 East Street, Mobile, Alabama 36610.

President Connie Hudson: Thank you, Pastor Williams. We appreciate you being here today. We have a number of retirees that we will acknowledge, but we are going to wait until the end of the Commission Meeting. We're still waiting for some of them to arrive. We'll move ahead this morning. Sharee Broussard, Public Affairs Director, do we have any speakers?

Sharee Broussard, Public Affairs Director: Yes, ma'am. We have several people signed up to speak this morning. We have two (2) gentlemen from Great Southern Wood Preserving, Inc. and YellaWood about Agenda Items #9 and #10. They said they were available.

Jay Ross, County Attorney: They can speak now. They just wanted to address the Commission generally, or they can wait until the item comes up, whichever is the preference of the Commission.

President Connie Hudson: Why don't we go ahead and have them speak now?

Jay Ross: Okay. Great.

Keith Rane, Great Southern Wood Preserving, Inc., addressed the Commission and expressed his excitement about the proposed designation of an industrial park.

President Hudson: Wonderful. Thank you so much for being here today. We're happy to have you. We wish you the very best. We're all about expanding and growing. We think this is a wonderful opportunity. Good luck with that.

Sharee Broussard, Public Affairs Director: We have three (3) individuals signed up to speak about Agenda Item #16, the resolution for medical marijuana.

President Connie Hudson: Okay.

Sharee Broussard: All three (3) have been instructed on their time limit, instructions on speaking into the microphone, and identifying themselves. The first is Shelley Powell.

President Hudson: Okay. Good morning.

Shelley Powell, 9719 Scott Dairy Loop Road South, Mobile, Alabama 36695: I live in the County and vote for the County Commission. I am speaking in opposition to medical marijuana dispensaries in Mobile County. I love what you said about we're all about expanding and growing. I hope we expand and grow well and healthy. I do not want to live near one of those medical marijuana dispensaries. I do not want to have to move to get away from one. I want the children and the families in my community to thrive and be healthy. Drugs are destroying families. I want law enforcement not to be burdened with one (1) more thing. I want to deter crime in my community. I don't want to normalize the use of marijuana. I do not want children and teens to believe it's okay to use marijuana. Vaping is a real big problem for young people. Everywhere you go, you see vape shops, so it looks okay to vape. I don't want to encourage driving while under the influence. I'm not against medical marijuana. I realize it's legal, and people need to have access. I would prefer them to go somewhere else to get it, not in my area of Mobile County. I want to encourage the Commission to opt out at this time. I'd like to wait and see how this plays out in other communities when they opt in. We have ones near us that have. We may not like the results, and it might be wise to see what those are. If we opt in too early, there might be no going back. I just thought it would be wise to see what

it looks like in our community without us having it. Please don't believe the lie that because other communities are opting in around us that it means it's a good thing for us. I speak in opposition to these medical marijuana dispensaries at this time. Let's grow and expand healthily. Thanks so much.

President Hudson: Thank you, Ms. Powell.

Sharee Broussard: Thank you, Ms. Powell.

Sharee Broussard: Our next speaker on the same subject is Ms. Sharon Argiro.

President Hudson: Good morning, Ms. Argiro.

Sharon Argiro, 1007 Wesley Avenue, Mobile, Alabama

36609: Good morning. Ladies of the County Commission, for months, you have been receiving information on the negative effects of marijuana in the physical health, mental health, and legal arenas. As you know, certain cities have approved medical marijuana dispensaries in South Alabama recently, despite all of the information made available to elected officials regarding the negative effects of marijuana proliferation. Perhaps the open letter presented or printed in the December 21, 2022 issue of the Lagniappe newspaper shows a key to how this approval could occur despite the facts. The author has lobbied persistently on behalf of marijuana dispensaries in South Alabama. In his letter, he referred to medical cannabis benefits documented extensively. After reading his Lagniappe newspaper letter, I looked for it but was not able to find such documentation. I did easily find articles such as the following disseminated by PubMed Central of the National Institutes of Health. This 2019 study of People Living with Human Immunodeficiency Virus (PLWH) obtained most of the study samples from the University of Alabama at Birmingham (UAB), right here in Alabama. The conclusions of the study negated the myths that recreational or medical marijuana relieves pain or reduces the use of opioid pain medication. In conclusion, we did not find evidence that marijuana used in People Living with Human Immunodeficiency Virus (PLWH) was associated with improved pain outcomes or changes in opioid prescriptions. This suggests that caution is warranted when counseling People Living with Human Immunodeficiency Virus (PLWH) about the potential benefits of recreational or medical marijuana. Further studies, including prospective trials of medical marijuana and large observational studies, are needed to understand what impact, if any, marijuana use can have on pain in People Living with Human Immunodeficiency Virus (PLWH). All of the work I was able to find done by the University

of Alabama at Birmingham (UAB) on marijuana use and Epidiolex, a marijuana derivative drug approved by the United States Food and Drug Administration (FDA) available by prescription and obtainable through a pharmacy. It appears that Carly's Law funded the University of Alabama at Birmingham (UAB) research project that showed Epidiolex was safe and effective in treating seizures in some cases. It should be noted that the medical marijuana the author of the Lagniappe newspaper article plans to sell is not Epidiolex, which the United States Food and Drug Administration (FDA) approved through research to be safe and effective for the treatment of the disease. The author's medical marijuana has no currently accepted medicinal use in treatment in the United States and lacks safety data for the products under medical supervision. The University of Alabama at Birmingham (UAB) marijuana research was funded by the State of Alabama Department of Commerce. Several pharmaceutical companies support the researcher who did the research. One must assess any possible conflict of interest in assessing any research. Elected officials should also assess any conflict of interest lobbyists may have. Does their claim to advocate for some beloved group include the prospect of tremendous financial gain for themselves? The same claims the author made in the Lagniappe newspaper article may be those made to elected officials by various lobbyists or medical marijuana proliferation. This may explain the lack of protection some elected officials give their cities in South Alabama. At this point, any limitation on accessibility to the products, such as not allowing dispensaries in unincorporated areas of Mobile County, would be helpful. Thank you.

President Hudson: Thank you, Ms. Argiro.

Sharee Broussard: Our final speaker on the same subject is Ms. Janet Stillings.

President Hudson: Good morning, Ms. Stillings.

Janet Stillings, 805 Willow Springs Drive, Mobile, Alabama 36695: Good morning. Here is a list of medical organizations against dispensaries of marijuana:

In summary, I do not want Mobile County to have any part in the marijuana industry. Our community is for God, families, good schools, and honorable businesses. I want you to vote no on this approval today. Thank you.

President Hudson: Thank you very much, Ms. Stillings.

Sharee Broussard: There are no more speakers, ma'am.

President Hudson: No more speakers? I think at this time because the last three (3) speakers have brought up a topic that I think has been discussed at great length publicly. I think this is certainly of concern to some members of the community, if not most members of the community, on how a medical marijuana dispensary would be operated should it open within the unincorporated areas or even within the municipal areas. Of course, we feel the same as you. I mean, we certainly want a healthy and safe community for our families to live in, just like everybody else. We want to make sure that in making decisions, we are able to separate fact from conjecture. The only way we knew to do that was to task our County Attorney to read the law and study the law as it was passed by the State of Alabama Legislature in 2021, allowing medical cannabis dispensaries and reporting back to us with information so that we could make decisions based on facts that we received. At this time, I would ask Jay Ross, County Attorney, would you please maybe speak to some of the concerns that have been presented here today and what regulations the law requires should these dispensaries be opened within our unincorporated areas?

Jay Ross, County Attorney: I will do my best, Commissioner. As the Commission knows, the State of Alabama Legislature passed this Act and created the Alabama Medical Cannabis Commission in 2021. It is a very highly regulated industry from growing all the way through the channels until the dispensary at the retail level to patients who have been diagnosed with certain illnesses as

set forth by the State of Alabama statute and prescribed by medical doctors who have created a curriculum provided by the Alabama Medical Cannabis Commission that regulates how much and how often. The only thing the local governments can control under this Act is whether they agree to have dispensaries in their jurisdiction. As the County Commission well knows, the City of Mobile, the City of Semmes, and the City of Bayou La Batre have already been approved by city ordinances approvals to sell and allow dispensaries to be located in their jurisdictions. As the County Commission is very well aware, this only allows for dispensaries, if any, in the unincorporated areas of the County. As the statute very clearly says, it cannot pop up at every corner. They have to be more than 1,000 square feet from a school or daycare or similar facility. They can't advertise much of what they're doing inside that facility. You cannot step foot on the premises if you're under the age of nineteen (19) years old. If you're over the age of nineteen (19) years old, you can only go into the premises if you have been certified by the Alabama Medical Cannabis Commission and have a proper prescription issued by a medical doctor licensed in the State of Alabama. Unlike the Cannabidiol (CBD) oils and other things that you see that do pop up on every corner, this is not like that. It will not be available to the general public. It will only be available by prescription. There are serious penalties if a medical dispensary sells outside of statutory requirements. There's a lot of regulation. The State of Alabama will manage it. Local and County government has little opportunity to do anything other than opt in. As the Commission knows, if we don't opt in, then you're going to have to opt out. To opt in, you have to agree to allow it to occur within the unincorporated areas of Mobile County. I think there will be less than thirty (30) dispensaries statewide. Integrated growers will have some. Four (4) dispensary licenses will be issued by the State of Alabama. Each dispensary, I think, can have three (3). The number of them is very limited. There's no belief or expectation that automatically if you approve this, that one (1) will occur in the County. It could be in one of the cities. We don't get to control where that occurs. I will mention that the statute is very specific. It says passage of this Act does not open the door or prelude for non-prescription use of medical grade marijuana in the State of Alabama. The last thing I'll say is the statute describes how this product can be distributed. It's a pill. It's a tablet. It's a patch. It's a suppository. It's not what we understand as a type that can be smoked at all. That's a little overview of it. If I can be more detailed, I'd be happy if that's what the Commission asks for.

President Hudson: So unless you have a permit that is issued by the Alabama Medical Cannabis Commission that has been certified by your doctor for a certain and specific type of medical condition, you could not enter the premises?

Jay Ross: That's correct. Unless you're a certified caregiver for that person with that serious medical condition, or you can buy it yourself for a certain limit, you can't even go on the premises, period. If you're under the age of nineteen (19) years old, you can't go on it at all.

President Hudson: And it has to fit one (1) of these qualifying conditions?

Jay Ross: Correct.

President Hudson: So it has to fit one (1) of these categories?

- Autism Spectrum Disorder
- Cancer-related chronic pain
- Crohn's Disease
- Depression
- Human Immunodeficiency Virus (HIV) or Acquired Immunodeficiency Syndrome (AIDS)
- Parkinson's Disease
- Persistent nausea
- Post-Traumatic Stress Disorder (PTSD)
- Sickle Cell Anemia
- Spasticity with Multiple Sclerosis or spinal injury
- Terminal illness
- Tourette's Syndrome
- Any other condition causing chronic pain

Jay Ross: That is correct. It has to fit one (1) of those categories. Again, if the doctor prescribes it outside of that, he or she is subject to their own set of professional troubles as well as what the Alabama Medical Cannabis Commission can do.

President Hudson: What will the enforcement end? Will the State of Alabama provide enforcement?

Jay Ross: The State of Alabama provides enforcement through the Alabama Medical Cannabis Commission, including revocation of their license, civil penalties, and criminal if need be. It's a cost to have the permit. To even have a dispensary, it costs thirty thousand dollars (\$30,000.00) a year. It's highly regulated, high levels of insurance, and high levels of security with both video, electronic perimeter, and a guard on the premises. It will not be

your Cannabidiol (CBD) oils that you can buy at the convenience store, not at all.

President Hudson: The concern about it falling into the hands of youth, you think that is not going to happen based on the regulations in place.

Jay Ross: It looks like they have done everything they can do to prevent that. It's like any other prescription that one buys from a pharmacist based on a prescription-only basis.

President Hudson: I see. Okay.

Commissioner Merceria Ludgood: You said it's dispensed as a pill, a patch, or a suppository?

Jay Ross: Some oils and creams are in the statute too, but it won't be the leaf we commonly know. It cannot be smoked. You can't even use it on the premises if you are allowed to go on the premises to buy it.

President Hudson: Do you have any other questions?

Commissioner Ludgood: No.

President Hudson: Okay. Thank you.

Jay Ross: Yes, ma'am.

WHEREAS, Act 2021-450 states that a dispensary licensee or integrated facility licensee may not operate a dispensing site in an unincorporated area of the county unless the county commission has authorized, by resolution, the operation of dispensing sites within its boundaries; and

WHEREAS, Act 2021-450 states that a program providing for the administration of cannabis derivatives for medical use in this state will not only benefit patients by providing relief from pain and other debilitating symptoms but will also provide opportunities for patients with debilitating conditions to function and have a better quality of life and provide employment and business opportunities for farmers; and

WHEREAS, Act 2021-450 further provides that the Medical Cannabis Commission may approve locations for state testing laboratories; and


