MOBILE COUNTY COMMISSION

The Mobile County Commission met in regular session (Combined Conference/Meeting) in the Mobile Government Plaza Auditorium, in the City of Mobile, Alabama on Thursday, February 9, 2023, at 10:00 a,m. The following members of the Commission were present: Connie Hudson, President, Randall Dueitt and Merceria Ludgood, Members. Also present were Glenn L. Hodge, County Administrator/Clerk of the Commission, Jay Ross, County Attorney, and W. Bryan Kegley II, County Engineer. President Hudson chaired the meeting.

INVOCATION

The invocation was given by Commissioner Merceria Ludgood, District 1.

President Connie Hudson: Do we have anyone signed in to speak this morning?

Sharee LeBlanc Broussard, Public Affairs and Community Services Director: Yes, ma'am. We have two (2) people signed in to speak this morning.

President Hudson: Ms. Gustavson, welcome. We're glad to have you this morning. We thought we recognized her.

Nell Gustavson, Alabama Kidney Foundation: We have a big fundraiser on March 11, 2023. It's our Annual Kidney Walk. Rhonda Gulledge is our Patient Chair and the reason she is our Patient Chair is I'll let her tell you.

Rhonda Gulledge, Design Engineering Manager: I donated my kidney to my best friend in 2019.

President Hudson: Wow.

Nell Gustavson: She is a true hero.

President Hudson: She deserves that.

Nell Gustavson: I am a recipient, so I know exactly what it feels like to need someone. I'm not going to bore you with a lot of statistics. Becky Connolly and I have been before you before and told you about the twelve thousand (12,000) Alabamians that must receive dialysis treatments at least three (3) days a week, every week. There are currently four hundred thousand (400,000) Alabamians with chronic kidney diseases; chances are, you know somebody. You know me, for instance. What I'm here to do today is to thank you for your support and your past support, but to also try to get you engaged and the departments involved in joining us in the Annual Kidney Walk.

President Hudson: That's a great idea. It's a worthy endeavor. We are so happy to be able to partner with you. We appreciate the heroes who have stepped forward and given that part of themselves to help a fellow human being. God bless you, and God bless the work that you do. We're just happy to be supportive and a part of it. I'm sure we can come up with some kind of competition. Everybody loves a good competition. Thank you again for being here.

Rhonda Gulledge: Thank y'all again for the support last year. When I had my surgery, my department and y'all were very supportive. Y'all stepped up. Thank you so much.

President Hudson: Thank you, Rhonda.

Becky Connolly, Alabama Kidney Foundation: I just wanted to add something because I just can't seem to shut up and sit down like I'm supposed to. I want to thank y'all because you are the leaders of our area. People look up to you. Your support means so much to us. There are now fourteen thousand (14,000) Alabamians with kidney disease, and we have three (3) new dialysis clinics locally that have been put up over the last year or so. Our need for transportation is up twenty percent (20%). Our need for daily living needs, utilities, and things like that, was up thirty percent (30%) in January. We don't know where this year is going, but we appreciate your support and invite you to the Annual Kidney Walk. Y'all have a big sign, and we would love to honor y'all because it means so much for the people to see our leaders support our efforts.

President Hudson: Give us that date again so everybody
can hear.

Becky Connolly: March 11, 2023. It is bright and early in the morning. You can come at 9:00 a.m. when we begin the walk. It only lasts for about an hour and a half. There are bounce houses for the kids, face painting, balloons, food, and a disk jockey (DJ), so you can do the Cupid Shuffle. I would also love to invite one of y'all to do the invocation. I honestly think that would be a great way to highlight the beginning, and it would mean the world to us to have you or all of you there.

President Hudson: Where will everyone meet?

Becky Connolly: It's at UMS-Wright Preparatory School.

President Hudson: Okay.

Becky Connolly: The disk jockey (DJ) booth is where the Annual Kidney Walk will begin, and we will open it up with our Patient Chair, Rhonda Gulledge.

President Hudson: Can you register on the site or register in advance?

Becky Connolly: Registering in advance is better, but we're a non-profit. We'll take it no matter what you got. We're there with our hands out because we believe in what we

do. We are community-based. We are patient-centered. That money stays here in the Mobile area to help our local people.

President Hudson: March 11th at what time again?

Becky Connolly: March 11th at 9:00 a.m. Be there or be square.

President Hudson: Alright.

Becky Connolly: It's going to be great.

Commissioner Merceria Ludgood: I'm sorry. I'll be in the City of Citronelle for the one hundredth (100th) anniversary of Ace Hardware.

Becky Connolly: They deserve you. They are blessed to have you. Either one of you, we would love it if you came. Thank y'all.

President Hudson: Thank you. Have a great afternoon.

Sharee LeBlanc Broussard, Public Affairs and Community
Services Director: We have one (1) more person signed up, but
she wasn't sure if she would speak. I'll call her. Nancy
Nygren. She wanted to ask questions about Agenda Item #58,
Compel Estates. She has decided to pass.

President Connie Hudson: Okay. Alright. Very good.

Jay Ross, County Attorney: Commissioners, if I may make one (1) clarification. It's a one hundred eighty (180) days original term with two (2) extensions that could make it last up to one (1) year. After the entity does its due diligence and still wants to proceed, we'll be back with the Commission to approve a purchase price based on fair market value, whatever the incentives are. That's basically what we're talking about. David Rodgers, Vice President Mobile Area Chamber of Commerce, is here just in case there are any questions. He's at the top row with Kayla Byrne, Project Manager, Mobile Area Chamber of Commerce.

President Connie Hudson: Okay. Any questions?

Jay Ross: This is essentially all the lands; the actual acreage may change based on the survey. They say all of the lands are within our ownership.

President Hudson: After this one hundred forty-six (146) acres, we'll have nothing left?

Jay Ross: There will be some lagoon ponds and remnant parcels that we probably can't give away. When they lose the bid because I support the Girls' Softball League at West Mobile County Park, it costs the County money. I dedicate money from my district funds to help pay for their umpires. I guess out of all that, I really want noted that this is not a County policy. This is an Alabama State bid law that we have to abide by, and that's why the concessions are bid at these parks.

President Connie Hudson: I wanted to mention that Bid #115-22, Semmes Community Center and Park, rescinds the bid for grounds maintenance.
