MOBILE COUNTY COMMISSION

The Mobile County Commission met in regular session in the Mobile Government Plaza Auditorium in the City of Mobile, Alabama, on Monday, April 24, 2023, at 10:00 a.m. The following members of the Commission were present: Connie Hudson, President, Randall Dueitt and Merceria Ludgood, Members. Also present were Glenn L. Hodge, County Administrator/Clerk of the Commission, Jay Ross, County Attorney, and W. Bryan Kegley II, County Engineer. President Hudson chaired the meeting.

INVOCATION

The invocation was given by Chaplain Phillip Snodgrass, Mobile County Sheriff's Office.

Commission President Connie Hudson: I see we have in attendance this morning Mobile County License Commissioner Nick Matranga. Happy to have you, Commissioner, as always.

We have a resolution to present this morning, but first, before we do that, Commissioner Dueitt would like to make some introductions.

PRESENT RESOLUTION/PROCLAIM
NATIONAL CRIME VICTIMS' RIGHTS WEEK/
APRIL 23, 2023 THROUGH APRIL 29, 2023

WHEREAS, the Mobile County Commission proclaims April 23, 2023 through April 29, 2023, as National Crime Victims' Rights Week in Mobile County; and

WHEREAS, the term "victim" is more than just a label and has legal standing and protections that go along with it; crime victims' rights acts passed here in Alabama and at the federal level guarantee victims the right to meaningfully participate and use their voice in the criminal justice process; and

WHEREAS, victim service providers, advocates, law enforcement officers, attorneys, and other allied professionals can help survivors find justice by enforcing these rights; and

WHEREAS, by elevating the voices of survivors makes certain they are heard and seen and creates a path to forging and sustaining community trust; while engaging survivors, creates responses and services that are credible, meaningful, and centered on individual needs; and

WHEREAS, survivors' lived experiences can serve as a catalyst for implementing innovative programs, shifting existing programs in new directions, and changing policies or practices that prevent survivors from accessing services or pursuing justice; and

WHEREAS, Lifelines Counseling Services, along with the Mobile County District Attorney's Office, Mobile County Sheriff's Office, and other partners, are dedicated to amplifying the voices of survivors and creating an

environment where survivors have the confidence that they will be heard, believed, and supported by providing counseling and advocacy;

NOW, THEREFORE, LET IT BE RESOLVED, that the Mobile County Commission supports victim services and criminal justice response that assists all victims of crime during Crime Victims' Rights Week and throughout the year; furthermore, we express our sincere gratitude and appreciation for those community members, victim service providers, and criminal justice professionals who are committed to improving our response to all victims of crime so that they may find relevant assistance, support, justice, and peace.


