MOBILE COUNTY COMMISSION

The Mobile County Commission met in regular session in the Government Plaza Auditorium, in the City of Mobile, Alabama on Monday, August 22, 2022, at 10:00 a.m. The following members of the Commission were present: Connie Hudson, President, Randall Dueitt and Merceria Ludgood, Members. Also present were Glenn L. Hodge, County Administrator/Clerk of the Commission, Jay Ross, County Attorney, and W. Bryan Kegley II, County Engineer. President Hudson chaired the meeting.

INVOCATION

The invocation was given by Reverend Eric Zubler, Christ Church Cathedral, 115 South Conception Street, Mobile, Alabama 36602.

PRESENTATION/ RETIREES/SEPTEMBER 2022

President Connie Hudson: This morning, we are going to acknowledge and honor some of our retirees for the month of September 2022. We have four (4) listed, and three (3) are in attendance today. If those of you who are here, please come down and join us; we have a certificate and a lapel pin for you. I think that's seventy-seven (77) years of service combined. It seems like every month; we have so much experience walking out the door. I guess that's the circle of life here. We just want the opportunity to let you know how very much we appreciate you and your service to the citizens of Mobile County. We have a certificate for each of you. The certificate reads:

Upon your retirement, the Mobile County Commission presents this certificate and wishes to express its sincere thanks and gratitude for your years of dedicated service. Your wisdom and commitment to excellence have long inspired all of us and will be remembered for many years to come. We wish you good health, happiness, and continued success in your retirement.

Let's give them a round of applause. Saying thank you in a certificate with a pin is such a small token for all of the time and effort in the years you have given to the County. It's meaningful to us that you spent this time serving the citizens. We hope you all really enjoy your retirement. You certainly deserve it. I think we're going to get a group picture.

President Connie Hudson: Do we have some speakers
signed up today? I believe that we do.

Sharee Broussard, Public Affairs Director: We do. Three (3) speakers have signed up today, all related to Agenda Item #32, TopGolf.

President Hudson: Welcome. Please join us this
morning. We're excited to have you here.

Todd Waldo, Director, TopGolf: We're extremely excited to be here today. We're hopeful for your support today. Today marks the significant first step in bringing TopGolf to the community of Mobile. We're hopeful for your support today, but I wanted to give a brief overview. know there's been a lot of questions and a lot of excitement about TopGolf. We certainly are happy to be in front of you today to share that news. TopGolf is extremely excited to join its development partner, RealtyLink, LLC, to deliver a transformative development to the City of Mobile. Anchored by TopGolf, the 13-acre overall project is located near the intersection of Interstate 65 (I-65) and Government Boulevard will provide a world-class entertainment venue to residents and visitors alike to complement and support the greater Mobile community. TopGolf will serve as a regional entertainment destination. It also signifies a significant multi-million dollar investment in the community of Mobile. This project will strengthen the tax base and create jobs on property that has essentially been vacant for a number of years.

The TopGolf that we're proposing here is one of the first of its kind and a new venue. Some of the highlights of that include a two-story building, sixty (60) hitting bays, and it's a very family-friendly and community-focused

venue. It will include top Tracer technology, which is our latest and greatest ball tracking seen on the Professional Golfers' Association (PGA) Tour. It will also include a mini-golf and an outdoor patio. We have been looking in the Mobile, Alabama, market for a number of years. This is very significant to our growth strategy. We're very hopeful for your support today. I'm happy to answer any questions you may have. Again, we are thankful to be here and hopeful for your support.

Commissioner Randall Dueitt: I think there were some questions if you guys want to go ahead. If you don't mind, Todd Waldo, Director, TopGolf, we have met before, and you had a conversation that I would like to put out. Would you talk about the programs you guys have that you utilize at your facility with local high schools and high school golf teams?

Todd Waldo: Sure.

Commissioner Dueitt: That's important to me if you
would explain it.

Todd Waldo: Yes, sir, absolutely. Community engagement and services are the core of our business, both at the corporate and venue levels. TopGolf is a good corporate citizen and an engaged community partner. What you're referring to is the Youth Play at Ford initiative. That is the program that offers free game play to those that mentor the youth, whether it's high school or Boys and Girls Clubs, things of that sort. We'll offer free gameplay at our venue during the weekdays during specific hours. The initiative is to grow the game of golf and allow folks who have not been exposed to it to be introduced to it and take it as a hobby. It has been extremely successful since we launched the program five (5) or six (6) years ago across the country. It serves as a bedrock of the community.

Commissioner Dueitt: Thank you.

President Hudson: Commissioner Ludgood, I know you
had some questions about employment and wages.

Commissioner Merceria Ludgood: Yeah. How many jobs will be created, and what would be the average hourly wage?

Todd Waldo: We're estimating that we'll create a minimum of one hundred fifty (150) new jobs. That's all new jobs in the community at competitive wages. We offer full-time benefits for anybody who works over thirty (30) hours a week and a lot of different ranges of salaries. We'll have some full-time and some part-time. I don't have the hourly wage range for you today, but it's a competitive rate wage within the market. We've got about forty (40) to

sixty (60) full-time salary staff, as part of the venue, and then also the part-time staff. That would be a great opportunity for employment for college students and others alike.

President Hudson: Todd Waldo, Director, TopGolf, I visited the TopGolf facility in Baton Rouge, Louisiana, this past weekend. I have never been to one before, and I was curious about what was involved with it before we met today. I just wanted that background. It was a weekend, of course, but it was certainly full of people. The manager Brandon, I think is his name, told me that typically, at least on weekends, there's two (2) to three (3) hours of a wait if you don't have reservations.

Todd Waldo: It has become quite a popular destination for a lot of folks. Yes, that is not uncommon for a significant wait on the weekends. The reservation system helped streamline that process. There are other offers with the full-service restaurant and bar that make the wait a little bit more palatable for our guests as well. I'm glad you had a good time there. It's a full-service restaurant and bar with sixty (60) hitting bays to really get you immersed in the TopGolf experience with all the technology. The Baton Rouge, Louisiana menu will be at the Mobile, Alabama venue as well. I'm excited as it's the third venue we'll bring to the State of Alabama. The first is obviously in south Alabama, and it really creates a lot of opportunity for economic development and a regional destination for the community.

President Hudson: It seemed to be operating very successfully at the time I saw it. My understanding is that ours will be just slightly smaller. I think they had just a few more bays. The layout design and everything will be similar. I'm assuming it's a similar design, regardless of where they're located.

Todd Waldo: Yes, ma'am. This is a brand new prototype that's been under research and development for a number of years. We've got a couple of these that are currently under construction. None of these venues are open as of yet. This is breaking with a new prototype. We're excited about it and think the Mobile community is well suited for it.

President Hudson: Okay. Thank you so much. We are excited about this venture, investment, and partnership. We certainly wish you continued success.

Todd Waldo: Thank you.

President Hudson: John Whitson, Principal, RealtyLink, LLC, is here, and I'm not sure if you have other representatives with your organization here or not.

If you'd like to introduce anybody, you're certainly welcome to. I know David Rodgers, Vice President of Economic Development, Mobile Area Chamber of Commerce, is here today as well.

Todd Waldo: I will make brief introductions if those folks can stand.

President Hudson: Certainly.

Todd Waldo: We have Jonathan Trenski, Real Estate Manager, TopGolf, and John Whitson, Principal, RealtyLink, LLC, who I think you all met with last week. We're all excited to be here today. This marks a significant milestone in bringing TopGolf here. We're hopeful for your support.

President Hudson: Very good. Thank you very much.

Commissioner Dueitt: So that Jay Ross, County Attorney, doesn't get his feelings hurt, Alvin K. Hope II, Maynard Cooper law firm, is here too.

President Hudson: I didn't see Alvin K. Hope II. Oh,
there he is.

Commissioner Dueitt: You attorneys are very sensitive, so I want to make sure we recognize you.

President Hudson: He's our local representative, our liaison with TopGolf.

Sharee Broussard, Public Affairs Director: Our next speaker is John Whitson, Principal, RealtyLink, LLC.

President Hudson: Any further questions? Okay.
We're good.

Sharee Broussard: Our final speaker is David Rodgers, Vice President of Economic Development, Mobile Area Chamber of Commerce.

President Hudson: Okay. I know he has some facts and figures. We rely on the Mobile Area Chamber of Commerce as we make these decisions of investments.

David Rodgers, Vice President of Economic Development, Mobile Area Chamber of Commerce: Thank you very much. I also have the privilege of serving as your economic

developer at the Chamber and leading that team in the organization on the economic development front. We have had the privilege of working with John Whitson, Principal, RealtyLink, LLC, and his team at TopGolf for some time now, for at least the last twenty-four (24) months. We've been looking at this project in different iterations and finally coming home to what I feel is the best opportunity for our community today.

I want to review the economic development side of this with you guys. You've heard many different aspects of this project regarding the quality of life, having an asset in this community for talent attraction, and having something that gets people excited to do something after hours. Also, the corporate side of things with corporate events can be happening here. We're excited about that piece. I would tell you that we look at this from a number of different angles.

On the number side of things for you guys, we see this as an overall economic benefit of nearly twenty million dollars (\$20,000,000.00) over the next twenty (20) years. To put that into perspective, what we're asking you to take up today on your incentive for this company is a payback period of only two point three (2.3) years. It's a forty percent (40%) return on this investment, which we feel is extremely beneficial to this community. Our analysis takes into account new sales tax revenue and new property tax revenue in real property, furniture, and equipment, along with the jobs generated and the economic benefit of folks paying the money back into the economy.

We've heard this from a number of different iterations but make no mistake; this will give new revenue to the economy. Ultimately, we were competing on this project with three (3) states; the Florida panhandle to the Mississippi Gulf Coast. We pulled people in daily from those economies into Mobile, Alabama. We're competing against things like the casinos on the Mississippi Gulf Coast and the Blue Wahoos in Pensacola, Florida. This is new money; new revenue generated back into our economy. We talked about the quality of life. I think the last thing to kind of hit on for you guys is the diversification. We're big on diversifying the economy, tourism, and hospitality. This is a way to diversify that sector for us and Mobile, Alabama, for the economic benefit.

I want to commend all of you for your leadership, for taking this up, and having a number of meetings with us as we've looked at this. I'll commend your staff, specifically Jay Ross, County Attorney. They have helped us tremendously on some things, especially in tight timelines where we had to get some things turned around. I want to thank all of you guys. I'm happy to answer any questions, but we feel very strongly that the economic

benefit from this project far exceeds what is being asked of you today to be considered on the incentive side of things. Any questions I can answer for you guys? Thank you.

President Hudson: Thank you. I'm just excited about the synergy it will help create with the Mobile County Sportsplex.

David Rodgers: Absolutely.

President Hudson: They're in very close proximity. I
think that will certainly be a win-win situation for both.

David Rodgers: Certainly taking an arguably blighted piece of property that has not been regenerating any tax revenue back in this economy and putting that property back into service.

President Hudson: Thank you.
