The County Wide Projects (MCR-2022-000 series) are selected by the Commission for their benefit to the entire county, regardless of which county commission district they are located.

DESCRIPTION AND FUNDING FOR EACH PROJECT

Project MCR-2022-001 (South McGregor Avenue) includes the widening of an existing road section to three or more lanes from Airport Boulevard northward to Dauphin Street, a new bridge culvert over Eslava Creek, and intersection improvements for the intersection of Dauphin Street/Wimbledon Drive East at South McGregor Avenue. This project will be funded with a combination of federal funds and City of Mobile funds with a maximum reimbursement of \$1,200,000 from the 2022 Transportation Pay-As-You-Go Program. This project will supplement the South McGregor Avenue funding as defined within the MCR-2016-006 project. The administration of the design and construction of this project will be performed by the City of Mobile Engineering Department.

Project MCR-2022-002 (Mobile Aeroplex at Brookley Streets) includes constructing (GDBP) a portion of a new Terminal Roadway Loop, constructing (GDBP) intersection improvements for the intersection of Perimeter Road with the new Terminal Roadway Loop, constructing (GDBP) a new FBO Access Road, and resurfacing (RRR) a segment of Michigan Avenue from the intersection with the new FBO Access Road to the end of maintenance. This project will be funded by the Mobile Airport Authority with a maximum reimbursement from the 2022 Transportation Pay-As-You-Go Program of \$5,000,000. The administration of the design and construction of this project will be performed by the Mobile Airport Authority.

Project MCR-2022-003 (City of Mobile Streets) includes the resurfacing (RRR) of several streets or segments of streets listed herewith: Bel Air Boulevard from Cottage Hill Road to Airport Boulevard; Cottage Hill Road from Sollie Road to Bel Air Boulevard; Demetropolis Road from Executive Park Drive to Government Boulevard;

Howells Ferry Road from Cody Road North to Moffett Road (Hwy 98); Pleasant Valley Road from Cottage Hill Road to Halls Mill Road; Springhill Avenue from Broad Street to North Washington Avenue; North Washington Avenue from Dauphin Street to Adams Street; and South Washington Avenue from South Broad Street to Dauphin Street. This project will be funded with City of Mobile funds with a maximum reimbursement from the 2022 Transportation Pay-As-You-Go Program of \$6,103,000. The administration of the design and construction of this project will be performed by the City of Mobile Engineering Department.

Project MCR-2022-004 (City of Mobile Street – North McGregor Avenue) includes the reconstruction (RECON) of North McGregor Avenue from Old Shell Road to Springhill Avenue. This project will be funded with City of Mobile funds with a maximum reimbursement from the 2022 Transportation Pay-As-You-Go Program of \$400,000. The administration of the design and construction of this project will be performed by the City of Mobile Engineering Department.

Project MCR-2022-005 (Cottage Hill Road, McFarland Road, and Snow Road South) includes the widening (ADL) of the existing road sections to five or more lanes. The Cottage Hill Road widening begins 0.2 mile west of McFarland Road and continues to 0.1 mile east of Dawes Road. The McFarland Road/Snow Road South widening begins 0.2 mile south of Cottage Hill Road and continues to 0.2 mile north of Jeff Hamilton Road. This project will be funded with 2022 Transportation Pay-As-You-Go Program funds. This project will supplement the Cottage Hill Road, McFarland Road, Snow Road South funding contained within the MCR-2020-001 project. The administration of the design and construction of this project will be performed by the County Engineering Department.

Project MCR-2022-006 (Lumpkin Road) includes constructing a new roadway (GDBP) from Airport Boulevard to the intersection of Calvert Road North with Lumpkin Road; thence pave (GDBP) the existing unpaved segment of Lumpkin Road from Calvert Road North to 0.6 mile north of Calvert Road North. This project will be funded with 2022 Transportation Pay-As-You-Go Program funds. The administration of the design and construction of this project will be performed by the County Engineering Department.

Project MCR-2022-007 (Windsor Road West) includes replacing two existing bridges (BR) over tributaries to Fowl River and realigning (GDBP) the paved bridge approaches. This project will be funded with 2022 Transportation Pay-As-You-Go Program funds. The administration of the design and construction of this project will be performed by the County Engineering Department.

Project MCR-2022-008 (Foster Road) includes the paving (GDBP) of an existing unpaved County maintained road from Tanner Williams Road to Zeigler Boulevard. This project will be funded with 2022 Transportation Pay-As-You-Go Program funds. The administration of the design and construction of this project will be performed by the County Engineering Department.

Project MCR-2022-009 (Weaver Road East Realignment) includes the realignment (GDBP) of an existing section of Weaver Road East from 1.0 mile west of U.S. 43 eastward to U.S. 43. This project will be funded with 2022 Transportation Pay-As-You-Go Program funds. This project will supplement the Weaver Road East funding contained within the MCR-2018-004 project. The administration of the design and construction of this project will be performed by the County Engineering Department.

MCR-2022-010 (City of Prichard Streets) includes replacing three bridge culverts (BR) over Crystal Springs Branch. Site No. 1 will replace the bridge culvert on Old Citronelle Highway over Crystal Springs Branch. Site No. 2 will replace the bridge culvert on South Crystal Springs Road over Crystal Springs Branch. Site No. 3 will replace the bridge culvert on Sandhill Drive over Crystal Springs Branch. This project will be funded with 2022 Transportation Pay-As-You-Go Program funds. The administration of the design and construction of this project will be performed by the County Engineering Department.

DESCRIPTION AND FUNDING FOR EACH PROJECT

MCR-2022-100 Projects These projects will be constructed within the boundaries of County Commission District One and will be funded with \$12,000,000 from the Mobile County Commission 2022 Transportation Pay-As-You-Go Program. MCR-2022-101 includes the resurfacing (RRR) of several streets or segments of streets within the City of Mobile. This project will be funded by the City of Mobile with a maximum reimbursement of \$3,924,000 from the 2022 Transportation Pay-As-You-Go Program. The administration of the design and construction of this project will be performed by the City of Mobile Engineering Department. MCR-2022-102 includes the paving (GDBP) of two unpaved streets and the resurfacing (RRR) of one street located within and maintained by the City of Chickasaw. The administration of the design and construction of this project will be performed by the County Engineering Department. MCR-2022-103 includes the resurfacing (RRR) of one street located within and maintained by the City of Citronelle. The administration of the design and construction of this project will be performed by the County Engineering Department. MCR-2022-104 includes the resurfacing (RRR) of two streets located within and maintained by the City of Creola. The administration of the design and construction of this project will be performed by the County Engineering Department. MCR-2022-105 includes the resurfacing (RRR) of three streets located within and maintained by the Town of Mt. Vernon. The administration of the design and construction of this project will be performed by the County Engineering Department. MCR-2022-106 includes the paving (GDBP) of one existing unpaved road and the resurfacing (RRR) of several other paved roads located within and maintained by the City of Prichard. The administration of the design and construction of this project will be performed by the County Engineering Department. MCR-2022-107 provides partial matching funds with a maximum reimbursement of \$1,000,000 for additional lanes (ADL) on a segment of Celeste Road in the City of Saraland. The administration of the design and construction of this project will be the responsibility of the City of Saraland. MCR-2022-108 includes the resurfacing (RRR) of two streets located within and maintained by the City of Satsuma. The administration of the design and construction of this project will be performed by the County Engineering Department. MCR-2022-109 includes the paving (GDBP) of one County unpaved road and the paving (GDBP) of a portion of another County unpaved road. The administration of the design and construction of this project will be performed by the County Engineering Department. MCR-2022-200 Projects With the exception of one project, these projects will be constructed within the boundaries of County Commission District Two and will be funded with \$12,000,000 from the Mobile County Commission 2022 Transportation Pay-As-You-Go Program. MCR-2022-201 includes the resurfacing (RRR) of many streets located within and maintained by the City of Mobile. This project will be funded by the City of Mobile with a maximum reimbursement from the 2022 Transportation Pay-As-You-Go Program of \$3,400,000. The administration of the design and construction of this project will be performed by the City of Mobile Engineering Department. MCR-2022-202 includes the resurfacing (RRR) of segments of two streets located within and

maintained by the City of Semmes. The administration of the design and construction of this project will be performed by the County Engineering Department. MCR-2022-203, MCR-2022-204, MCR-2022-205, MCR-2022-206, MCR-2022-207, and MCR-2022-208 are projects that will pave (GDBP) segments of existing County maintained unpaved roads. The administration of the design and construction of these projects will be performed by the County Engineering Department. MCR-2022-209 will construct (GDBP) the remaining segment of a new entrance road to the Sportsplex located south of Halls Mill Road and east of Lees Lane within the City of Mobile. This includes the construction of a new bridge. This project will supplement the funding within the MCR-2020-203 project. The administration of the design and construction of this project will be performed by the County Engineering Department.

MCR-2022-300 Projects These projects will be constructed within the boundaries of County Commission District Three and will be funded with \$12,000,000 from the Mobile County Commission 2022 Transportation Pay-As-You-Go Program. MCR-2022-301 includes the resurfacing (RRR) of a street located within and maintained by the City of Bayou La Batre. The administration of the design and construction of this project will be performed by the County Engineering Department. MCR-2022-302 includes the resurfacing (RRR) of several streets located within and maintained by the Town of Dauphin Island. The administration of the design and construction of this project will be performed by the County Engineering Department. MCR-2022-303, MCR-2022-304, MCR-2022-305, MCR-2022-306, and MCR-2022-307 are projects that will pave (GDBP) segments of existing County maintained unpaved roads. The administration of the design and construction of these projects will be performed by the County Engineering Department. MCR-2022-308 provides partial matching funds with a maximum reimbursement of \$500,000 for resurfacing (RRR) Theodore Dawes Road and Hamilton Boulevard from 0.1 mile west of U.S. 90 to Rangeline Road. The administration of the design and construction of this project will be the responsibility of the City of Mobile Engineering Department.

- RRR:** **RESURFACING, RESTORATION, AND REHABILITATION:** This may include clearing, patching, leveling, milling, minor widening of travel lane, minor widening of the shoulder, minor alterations to vertical and horizontal alignment, resurfacing, full depth reclamation, paving of a portion of the shoulder, pavement markings, minor drainage improvements, safety improvements, traffic control installation, utility relocations as required by law, intersection improvements, right-of-way and/or easement acquisitions, and any other work necessary for the completion of the project.

A RESOLUTION CALLING A SPECIAL ELECTION

BE IT RESOLVED AND ORDERED by the Mobile County Commission (herein called
the "Commission"), as follows:

Section 1. The Commission has caused an investigation to be made of the matters
hereinafter referred to, and, as a result thereof, has determined and does hereby declare that the
following statements are true:

(a) Mobile County, Alabama (the "County") is authorized by Amendment 18
to the Constitution of Alabama of 1901, as amended and modified by subsequent
amendments to the Constitution of Alabama (the "Authorizing Amendment") (codified as
Official Recompilation of the Constitution of Alabama of 1901, Local Amendments,
Mobile County, Section 5), to issue its bonds for the construction and improvement, or
either, of hard surfaced roads, hard surfaced bridges and surface water drainage facilities,
or any thereof, in the County. In order to provide for payment of the principal of and the
interest on the said bonds and all other bonds at any time outstanding which may be payable
therefrom or constitute a charge thereon, the County is further authorized to levy and
collect a special annual ad valorem tax (herein called the "Special Bond Tax") on all taxable
property in the County at a rate not exceeding six and one-half mills on each dollar of the
valuation of such property as assessed for taxation; provided, that the total principal amount
of each series of the said bonds at any time issued, when added to the principal amount of
all then outstanding bonds theretofore issued payable from or secured by the Special Bond
Tax shall not exceed six and one-half per cent (6-1/2%) of the assessed valuation of the
taxable property in the County; and provided further, that the said bonds may be issued and
the Special Bond Tax may be levied and collected only after a majority of the qualified
electors of the County voting at an election called to be held for that purpose by the
governing body of the County shall have voted in favor of the issuance of the said bonds
and the levy of the Special Bond Tax. Prior to the holding of such election, the governing
body of the County is required in the Authorizing Amendment to cause to be prepared

engineering maps and reports respecting the proposed work on roads, bridges and drainage facilities, and to adopt a resolution containing a brief description, including the name, if any, of each proposed item of construction or improvement, a statement of the length thereof and the estimated cost thereof, and a statement of the total amount of the bonds proposed to be issued for all work of construction or improvement described in the said resolution, and shall cause the said resolution to be published in a newspaper published in the County one time not less than thirty (30) days before the election.

(b) The Commission has caused to be prepared, and there have been filed with the Commission, engineering maps and reports as required by the Authorizing Amendment, and at the meeting at which this resolution is adopted the Commission has also adopted the resolution required by the Authorizing Amendment and has ordered the said resolution to be published in a newspaper published in the County one time not less than thirty (30) days before the election hereinafter provided for. In such resolution the Commission also found that such engineering reports were accompanied by a certificate that the material proposed to be used for any road or bridge work described in such report meets the existing specifications of the Alabama Department of Transportation applicable to the same type of construction or improvement.

Section 2. A special election is hereby called to be held in the County on November 8, 2022 (which date is not less than thirty (30) days after the date of the adoption of this resolution and the first publication hereinafter ordered of the notice hereinafter set out of the said election), for the purpose of submitting to the qualified electors of the County the question of (a) whether the County shall be authorized to issue on its credit its Pay-as-You-Go Road, Bridge and Drainage Facilities Bonds, not exceeding \$69,000,000 in principal amount, in one or more series, for the purpose of raising funds for the construction and improvement, or either, of hard surfaced roads, hard surfaced bridges, and surface water drainage facilities, or any thereof, in the County, which bonds in various series shall bear interest which may be excludable from income for purposes of federal income tax or may be includable in such income, at a rate or rates to be fixed when they are sold, not exceeding twelve percent (12%) per annum, payable semiannually until their respective maturities, and shall mature and become payable in annual installments as set forth in the notice of the said election provided for in Section 3 hereof, and (b) whether the County shall be authorized to continue the annual levy of the Special Bond Tax, on all taxable property in the County, at a rate not exceeding six and one-half mills on each dollar of the assessed valuation of such property, for the purpose of paying at their respective maturities the principal of and interest on the said bonds and all other bonds which may at any time be payable out of or constitute a charge on the said special tax. The said special election shall be held between the legal hours for the holding of elections in the County and at the regularly established voting places in the several precincts and wards in the County.

Section 3. The president of the Commission and the Sheriff of the County are hereby directed to give notice of the said election by publication in the Press-Register, a newspaper published in the County, once a week for three consecutive weeks, the first publication to be made not less than thirty days prior to the date fixed for the said election, which notice shall be in substantially the following form:

Notice is hereby given that a special election of the qualified electors of Mobile County in the State of Alabama has been called and will be held in said County on November 8, 2022, at which election there will be submitted to the qualified electors of the County, for their approval or rejection, the question of whether the County shall be authorized to issue on its credit its Pay-As-You-Go Road, Bridge and Drainage Facilities Bonds, not exceeding \$69,000,000 in principal amount, in one or more series, for the purpose of raising funds for the construction and

President Connie Hudson: I want to take the opportunity to once again say a big kudos to our Engineering Department for all of their hard work. I know you're fast. How many months does it take to get all of this prepared?

W. Bryan Kegley II, County Engineer: We usually start the preliminary around the end of January. By the first of February, we are gathering the information, and getting our Public Works Department involved with the rating of the roads. Then we provide information to the Commission. We start soliciting the information from various municipalities around April. It's about five (5) to six (6) months.

President Hudson: It is handled like a well-oiled machine. I know it's not. You've had a lot of practice. We appreciate all of that effort, and you make it seem so seamless and easy. I see your crew behind you there with Kim Sanderson, Assistant County Engineer. Thank you all for everything you do. We appreciate you.

Commissioner Randall Dueitt: I'd like to say the same thing. Thank you, guys. You do a wonderful job. You and your crew, along with Richard Mitchell, Public Works Director, and Neal Howard, Deputy Public Works Director, and their crew, for helping to grade these dirt roads. Six (6) months is probably just the final preparations. I imagine you start right after the election, and it probably takes twenty-four (24) months to get the whole thing done. So we have items to look at to know what direction to go when we start approving the Pay-As-You-Go Program Projects. Thank you, guys.

Commissioner Merceria Ludgood: I don't know what it takes to produce that little book y'all give us ahead of time with the little grades on the roads. That helps me narrow down what's most important and the ones that need the most attention. That just kind of guides that. I appreciate the effort to produce that document because it is helpful. It's a lot of money, but we got a lot of needs. It helps us prioritize what's in the worst shape, then we just kind of work down there. Thank you.

President Hudson: Definitely, a team effort.

Commissioner Merceria Ludgood: Can we go back and maybe approve Agenda Item #36/Add-on #2, subject to confirmation of funding source?

President Connie Hudson: Yes. The motion will be approved contingent on the funding source being approved by the Administration. In fact, we might ought to do that. Otherwise, we'll all be sitting here on pause for a while.


