MOBILE COUNTY COMMISSION

The Mobile County Commission met in regular session in the Government Plaza Auditorium, in the City of Mobile, Alabama, on Monday, August 9, 2021, at 10:00 A. M. The following members of the Commission were present: Merceria Ludgood, President, and Randall Dueitt, Member. Connie Hudson was absent. Also present were Glenn L. Hodge, County Administrator/Clerk of the Commission, Jay Ross, County Attorney, and W. Bryan Kegley II, County Engineer. President Ludgood chaired the meeting.

INVOCATION

The invocation was given by Chaplain Phillip Snodgrass, Mobile County Sheriff's Office.

President Merceria Ludgood: We'd like to ask Melissa Creighton, Grants Manager for Family Health, to meet us down here. This morning, we are here to acknowledge the observance of National Health Center Week.

Melissa Creighton, Grants Manager for Family Health:
Thank you so much to everyone here. The Mobile County Health Department and Family Health Center celebrate National Health Center Week this week. Sharee Broussard, Public Affairs Director: Good morning, Commissioners. We have three people here to speak this morning. Paula Roberts is here to speak about Item #40, Hunters Ridge North subdivision. Judy Morris and James Morris are here to speak about Item #44, Riva Road Bridge. I will remind the speakers that you have five (5) minutes to address the Commission.

Paula Roberts, 10303 North Hunters Ridge, Mobile, Alabama 36695: Good morning. I am Paula Roberts and I am here to represent Hunters Ridge North subdivision. Our subdivision adjoins a D.R. Horton development. My neighbors who came with me today and I have lived there approximately thirty (30) years. They have cleared off the property that adjoins our subdivision. They have left two (2) retaining ponds that are filled with gross stuff right now. We were told today it will be cleared off and they will put up one (1) large retaining pond. Our concern with that is it is a magnet for our children and grandchildren to go and play in the retaining ponds. There are no fences around the subdivision. At one time, we were told D.R. Horton would put up a divider fence. As of today, they have not. We are here to ask that D.R. Horton puts up a divider fence between our property and the new property. It has decreased the value of the homes for people who live in our subdivision and also for the safety of the children and grandchildren. We feel like they should have to put up a divider or a fence around the retaining pond because it will be one large pond. That is what we are here for today; to get the word out that they have not done it. It has been cleared off for a couple of years. Nothing is being done about it. Commissioner Dueitt, I have a copy of documents to show you our subdivision is standing up and wanting our voice to be heard. We would like for something to be done about it through D.R. Horton.

Commissioner Randall Dueitt: Thank you for being here today. Who else from your neighborhood is here with you?

Paula Roberts: I have a couple of people. The current president of our Hunters Ridge Homeowners Association, Debbie Jackson and Scott Speed. His property is the one that is adjacent to the new development.

Commissioner Dueitt: We have been out several times and met with the Homeowners Association. I guess you do not legally have a Homeowners Association but it is more of a club situation. We are addressing those issues with the detention ponds in the back of the new subdivision. We have met numerous times with numerous people in the neighborhood. Maybe W. Bryan Kegley II, County Engineer or Matthew Barclift, Engineering Development Manager, can give you a little bit more information.

Paula Roberts: We were not aware of any meetings other than when former District 3 County Commissioner Jerry L. Carl called for a meeting at the church on Airport Boulevard.

Commissioner Dueitt: I personally have met and have taken several members of my staff from the Engineering and Public Works Department to meetings. There is some hold up right now on finalizing the plat. Matthew Barclift, Engineering Development Manager can probably speak to you a little more on that. We are also concerned with the issues you are having. He can address you with the additional things we have required and what is going on.

Paula Roberts: Yes. I think you came to the church with former District 3 County Commissioner Jerry L. Carl.

Matthew Barclift, Engineering Development Manager: I sure did. I absolutely was there.

Commissioner Dueitt: Let me interrupt. I apologize. I didn't organize the meetings for your neighborhood. Someone else in your neighborhood organized the meetings and called the County Commission to ask if we could attend. I put together a group of people I thought could answer the questions. I assumed they had put the information out to everyone in the neighborhood that we were having these meetings. I apologize.

Paula Roberts: Debbie Jackson, President of Hunters Ridge Homeowners Association, is our current president and she was not notified.

Commissioner Dueitt: Okay.

Paula Roberts: I was the previous president and I was not notified. I don't know who you met with from Hunters Ridge North subdivision. There is Hunters Ridge subdivision, Hunters Ridge North subdivision, Hunters Ridge Northwest subdivision, and Hunters Ridge West subdivision.

Commissioner Dueitt: The gentleman's name slips my mind on who organized all of this. All of the homeowners that live on Hunters Ridge North that is adjacent behind the property were there.

Paula Roberts: There's only two (2) houses on Hunters Ridge North that adjoins the new property. You must have met with the Hunters Ridge subdivision property owners.

Commissioner Dueitt: Okay.

Matthew Barclift, Engineering Development Manager:

The road you are thinking of is Hunters Ridge. There is a cul-de-sac street off Repoll Road. Just north of there is Hunters Ridge North subdivision. It ties into the back of the cul-de-sac and the development.

Commissioner Dueitt: Okay. Is it different Homeowners Associations?

Paula Roberts: Yes.

Matthew Barclift: Yes, and different neighborhoods not attached to what you would consider Hunters Ridge on the other streets.

Commissioner Dueitt: Okay.

Matthew Barclift: They have reconfigured the drainage.

President Merceria Ludgood: Who is they? The developers?

Matthew Barclift: The engineers for the developers.

President Ludgood: Okay.

Matthew Barclift: They have reconfigured the drainage and they have made it significantly larger. They have given us assurances they are going well above and beyond what we would normally require. As fences go, we don't have the authority to require that. Our experience has been that due to a liability issue, D.R. Horton generally puts up fences. They are about to reconstruct some of the pond. They do not want to put up a fence they are going to have to take down. They are working on it. This is a preliminary approval of the plat only to get them authorization to really get started to get these revised drawings and revised designs on the ground out there.

Commissioner Dueitt: I believe the engineer for the development may be able to speak on the fence and future plans.

Ercil C. Godwin, Vice President, Saltgrass Consulting LLC: Yes, sir. I'm Ercil C. Godwin with Saltgrass Consulting LLC. We are the engineering consultant for Four Star Development, which is the actual developer for this project. D.R. Horton will be the actual end user builder of the homes there. Like Matthew Barclift, Engineering Development Manager said, we have done a redesign to increase the detention pond as well as to combine what was in Phase 3, which is what we're here on today for preliminary approval. We combined that pond with the Phase 2b pond so it is a much larger footprint. A little history on the site. Phase 2 and Phase 3 already had a preliminary

approval, a site permit, and so forth, but increasing the detention pond and combining it has required us to resubmit plans and come back to you for preliminary approval. That is why the site has been cleared. The construction had started but we stopped Phase 3 so we could do this. Now we are back before you again. It is why activity has gone on in the past. As far as future plans from today when we get the site permit for the revised Phase 3, construction will start again for Phase 3. Phase 3 is what backs up to Hunters Ridge North subdivision. Everything prior to that just backed up to Hunters Ridge subdivision. That is why these residents are just seeing this and are just getting notice. As far as fences, like Matthew Barclift, Engineering Development Manager said, it is pretty typical for D.R. Horton to put privacy fences up as they build houses. I feel quite certain there will be some fences along that property line. It is highly unlikely it will happen between now and when they build a house. They are moving dirt and building padded lots, detention ponds, and streets. They would not put a privacy fence up today. There is a high chance it would get torn down as lots change and grade. I feel quite certain that at the end of the day, there will be a fence there. I am happy to answer any other questions y'all may have.

Commissioner Dueitt: Does that answer some of your questions? I apologize as I thought Hunters Ridge subdivision was one big subdivision. I will gladly come out and meet with your Homeowners Association any time you would like to meet for Hunters Ridge North subdivision to answer any questions. I can bring folks along that can answer any questions that you have.

Paula Roberts: We appreciate it.

Commissioner Dueitt: Thank you. I drive through Chapel Hill subdivision three (3) days a week to keep up with the progress and what kind of issues are still out there because we have had so much rain. That has been a big issue with Chapel Hill subdivision. Thank you for being here.

Judy C. Morris, 14530 Riva Road, Coden, Alabama 36523:
My name is Judy C. Morris. I am here today because about twelve (12) days ago, a sign appeared on our road saying the bridge would be closed. This bridge was replaced with what we thought was a very substantial bridge in 2008, when it had gone out between Hurricane Katrina and Hurricane Ivan. It was rebuilt and it cost one million dollars (\$1,000,000.00). They have to get a special crane to put down the pilings. Now I hear that my bridge is closing. I went home and said on Facebook that the County Commission is going to remove it. They want us to use Saint Michael

Road. That is on your agenda today as Item #44. It says you want to pave it, grade it, drain it, and put in a base. I don't understand how you have the money to do this, you have the money to tear it down, and you can't just repair the bridge. My biggest concern is why wasn't this bridge maintained? Why wasn't this bridge built to last? Thirteen years should not be the lifespan of a bridge. The County Commission failed us and they are failing us now. We really need that bridge. We need two (2) ways out. Saint Michael Road is heavily wooded. I would say at least a quarter of a mile. If those woods catch on fire and there is a lot of smoke, we have no way to get out. They say they are going to pave it and drain it even though I am not sure how that will help as that road floods really bad. It also has three (3) very dangerous curves on it. We have a sixteen (16) year old who is just learning how to drive and a seventeen (17) year old that has only been driving for a year. They will have to use this road. There is hardly anyone on this road. If someone breaks down, they would have to walk a long distance. There are no street lights. I want someone to explain to me how can you build a bridge, spend so much money on it, and have it last only thirteen (13) years? I did go read to see how long a bridge is supposed to last. They can stay for fifty (50) to seventy (70) to one hundred (100) years without any problems. Commissioner Dueitt said on the news on Friday night that this is for the benefit of people. This is not for the benefit of us. This might be for the benefit of two (2) individuals. I know there is one problem with someone having right-of-way by the highway and has threatened litigation against the County if they take his land. I have always heard of the County taking people's land to make an improvement on a road. I can't prove anything, but to me it seems like something is very underhanded about this. We need that bridge. We don't need Saint Michael Road. We need Riva Road Bridge. My husband's family built this road. Their last name was Riva. They settled here. They built the first bridge. Then it was a wooden bridge, then it was a covered bridge. This bridge was built to last. It is higher; the ground there is much higher than it is on Saint Michael Road. I could have filled this whole room today with people who would have come to back us up, but I didn't want to start something and be mean and angry about this. We are very angry and we are all very upset. There are plenty of us. I wish that before you consider paving this road, that someone needs to look in to why this road and why this bridge failed us. We didn't build the bridge. The County did. Thank you for your time.

Sharee Broussard, Public Affairs Director: Thank you, Ms. Morris.

Commissioner Randall Dueitt: Thank you.

James Morris, 14530 Riva Road, Coden, Alabama 36523:

First of all, I would like to thank you for letting us air out our situation. My name is James Morris. I live on Riva Road. My mother's last name was Riva. My family has been here since the mid-1800's. Of course we're very concerned about the bridge being closed because when you close a bridge, you also close the road. It sort of gives a couple of houses a public road in front of their properties for themselves. If Riva Road is closed and they have a highway in front with no traffic, a couple of places there may say it's a good thing. It's not a good thing for the general public. Our community there is pretty active. We have the school buses, garbage trucks, mail delivery, and delivery services. We also have a straight shot to the main road. Saint Michael Road is the alternative route. There are a lot of problems we have with taking that road. Not only because it's a dirt road, but even if it was paved with gold, it wouldn't compare to Riva Road. Our people have been there for a long time, but Riva Road is a public road. It's for everybody. For the period of time the road has been there, there has always been a bridge. Like my wife said, we really are concerned. When they put the cement bridge in, it was supposed to fix problems that the older bridges were having. Every now and then they had to be maintained from washouts. This bridge was supposed to fix it. The pilings were put in over sixty (60) feet deep. We're still concerned why did this bridge go to pieces or whatever has happened to it in such a short period of time. We don't want to lose our bridge. We don't want to lose our road. We don't want to lose our route. We don't want to lose Saint Michael Road because it's a second way out. We refer to Saint Michael Road as a backroad because it is a backroad. It's not our main road. I looked at a bigger picture about these things. Our government and our country is really set on spending trillions of dollars on infrastructure. It's from Washington, D.C. and is trickled down into wherever the money goes. It's a little confusing to me why our government is willing to spend trillions of dollars on infrastructure while ours is being yanked out. We don't just want the bridge, we need the bridge. We need our road opened up. I'm a commercial fisherman and I have launched my boat on the other side of Riva Road for about thirty-five (35) years. The alternative route puts me way down the other way, but I'm just one person. I understand the road should serve as many people as possible. It should it should not cut off the few, especially when something that we're concerned with what happened to the bridge. Even a wooden bridge lasts longer than that.

We're concerned about losing it for our community and because it is a public road. It's a very active and busy road. We would like to find a way to help y'all find a way to help us keep our road and bridge open. Thank y'all.

Commissioner Randall Dueitt: Thank you both for being here. I'm going to let our County Engineer address the issues with the condition of the bridge and how we got to where we are at. Then I'll address some of your other concerns.

W. Bryan Kegley II, County Engineer: Commissioner Dueitt, while listening to Judy C. Morris and James Morris, it appears they have a question about why did the bridge only last less than fifteen (15) years. Customarily whenever you're dealing with a marine environment, which Riva Road is, you would not put in bridge piling made of either wood or steel. We would not do that now. There was a decision made by the previous administration of the Engineering Department to put in steel piling, which is what we had available for us at the time. The steel piling did not last as long as what the Engineering Department had hoped. They have degraded to a point where a year or so ago, we had to start inspecting the bridge every three (3) months. It continued to deteriorate to a point where in April 2021, it was so bad a recommendation was made to close the bridge. We had the load posted at three (3) tons. It has gotten to a point where it is unsafe. We started the design process to replace the bridge a year and half (1.5) to two (2) years ago. We had a design and we were handling the right-of-way acquisition. We were met with resistance from some of the residents that we were approaching to try and acquire the right-of-way. It made us reconsider if the bridge is even needed. Quite frankly, we made a decision to take the money we were anticipating spending on the bridge and use it to pave the unpaved roads just north of the bridge to provide the citizens a better way back out up to Highway 188. We have to close the bridge regardless because of the condition of it. The decision to not replace it was a recommendation from the Engineering Department to utilize those funds to pave the road to the north.

Commissioner Dueitt: Every road and every bridge in the County has to be inspected every two (2) years per State of Alabama law. Going back two (2) years ago, this bridge was inspected. It was determined we needed to take a look at it to possibly lower the rate of tonnage for crossing the bridge; which is what we did. It was also recommended by an independent engineering firm, Volkert, Inc., who does our bridge inspection, that we begin to inspect that bridge every three (3) months instead of every two (2) years. In April 2021, it was determined the bridge really was almost unsafe to cross and needed to be closed. I had W. Bryan Kegley II, County Engineer, and Volkert, Inc. do an even closer inspection of the bridge so we could

keep it open as long as we could. That is all part of the engineering process and problems. The problem with the bridge and the decision to build a bridge with steel H pilings was a decision made before he was the County Engineer and before I was here. That's neither here nor there. When he came to me with the recommendation of the prospect of replacing the bridge or paving Saint Michael Road, I looked at several things. I talked to you both on the phone for thirty (30) or forty-five (45) minutes the other day. I wrote down every concern you brought to me, particularly the public safety concerns. For twenty-five (25) years, I was a law enforcement officer in Mobile County. I think it was part of my responsibility to make sure the people and their property were safe in Mobile County. I still take that in high regard. I think most of what the problem here is a convenience problem and not really a safety concern. The only time that I can find that Saint Michael Road has ever flooded is during a tropical storm or hurricane; at which time, Riva Road is also flooded. Saint Michael Road does not flood unless Riva Road has flooded.

Judy C. Morris: You're wrong.

Commissioner Dueitt: I can't find any recorded history. With that being said, the decision to pave Saint Michael Road versus replacing the Riva Road Bridge really comes down to fiscal responsibility on my part. I think it benefits more people in the Coden community.

Judy C. Morris: Who? Who are those people that you're referring to?

Sharee Broussard, Public Affairs Director: Ma'am, order please.

Commissioner Dueitt: I don't have specific names but I do believe there are more residents on Saint Michael Road than there are on Riva Road.

James Morris: There are more people on Riva Road.

Commissioner Dueitt: Fiscal responsibility is one of the things that I ran on. It benefits more people in that community to pave Saint Michael Road than it does to spend upward of one million dollars (\$1,000,000.00) to replace the bridge. As far as the concern of one exit, there are hundreds of roads in Mobile County and in my district alone like that. I live on such a road. The people who spoke before you, they live on such a road. There is one way in and one way out. We are not hindering people's ability to get in and out of there.

James Morris: I am not through yet though. We have a couple more questions.

Sharee Broussard: Sir, you have one (1) minute left on your time.

James Morris: Okay.

Commissioner Dueitt: Come up to the microphone, Mr. Morris.

James Morris: Saint Michael Road is lower than Riva Road. You can look at it and tell that. It has flooded before Riva Road does just for the fact that the sea level is lower. We are not giving up on our road. Something needs to be worked out. We need to find a way, even if it's a Corbett Roebling suspension bridge or something put back there because it would last a lot longer than the so-called fix-all bridge did. We feel like the County Commission let us down on that bridge for the things they sold it to us as saying that it was to fix problems that other bridges put in similar areas were having. All of a sudden, we're having it yanked out from us. It's not just an inconvenience, it's a public road. It's for everybody. People have been there for so many years. I feel like they have paid their dues throughout all of those generations and have had a bridge for all of those years. Now in 2021, we're having it yanked out from under us and it puts a pretty bitter taste in our mouths. Yes, it's an inconvenience. Of course, but it is not the only reason. Riva Road is a straight shot to the main road and it is higher than Saint Michael Road. I know. I have played in those woods many times. We used to love it when it flooded so we could play in the water. I wouldn't play in the water over the bridge on Riva Road because it wasn't over it.

Sharee Broussard: Sir, thank you. That is your five minutes.

James Morris: Thank you.

W. Bryan Kegley II: Commissioners, if I may speak. That existing bridge was built with County crews expeditiously with what materials we had available. Steel piling was placed. Steel piling does not perform well in the marine environment. I cannot speak to why that decision was made. I honestly do not know; but I can speak to the condition of Saint Michael Road. It is an unpaved road. It's heavily rocked. It should perform well in a wet and rainy type season. Whenever we pave that road, which we will start the design process this week, it should be something those citizens will be proud of. They'll be able to get out and maintain access out to Highway 188 much better than what they have now.

Commissioner Randall Dueitt: I do have a comment and I'll try to be brief because I think I have talked more today than I have in the last two (2) weeks. I have had some concerns come up in my district. I have received hundreds of emails, phone calls, Facebook messages, and letters from doctors, nurses, and health professionals in our community. I know the County Commission has no direct control over the Board of School Commissioners of Mobile County, but I do want to say this about the citizens who

live in my district. They have been outspoken about this. I did a survey also on my Facebook page. I speak for District 3 right now, not for the County Commission. Overwhelmingly, the citizens that live in District 3 are concerned about the safety of their children with going back to school this Wednesday. I would like to take this opportunity and hopefully someone from the Board of School Commissioners of Mobile County or the superintendent is listening. I intend to try to have a voice tomorrow at the Board of School Commissioners of Mobile County meeting to encourage the board and the superintendent to consider postponing starting school on Wednesday. I understand last year's statistics and from what I have received over the weekend. Women's and Children's Hospital in the last year has admitted three hundred fifty (350) children with COVID-19. Since the new Delta variant has come out, in the past week, they have admitted over one hundred (100) children. That's in one week compared to three hundred fifty (350) admitted in a year. In one week they have admitted almost a third of what they admitted for a year. I talked with someone at Mobile Infirmary. A month ago, they had eight (8) people admitted for COVID-19. As of right now, they have one hundred twenty-seven (127). A month ago, they had one (1) person on a ventilator. Right now, they have twelve (12). That's really about all I have to say about that. I know the Board of School Commissioners of Mobile County have a lot of hard decisions to make, just like we do. I do want to encourage them to consider postponing schools like how a lot of our private schools in our area have done this week. With that, that's all I have to say.

President Merceria Ludgood: While we are talking about COVID-19, I would like to use this opportunity to encourage those who have not been vaccinated to talk to your health care professionals about it. I hope you'll find it in your heart to do that. It has been proven to help in managing this COVID-19 pandemic.
