Commission President Connie Hudson: We also have a retiree from the month of February who is joining us today who was unable to make it:

Those that are here this morning, if you would please come down and join us up front.

President Hudson: First of all, on behalf of the Mobile County Commission and all of the citizens we represent, how very much we appreciate your service to the County, your dedication, and all of your years of work, service, and everything that you've done and have been a part of. You've been a part of the family. We want you to know you'll always be a part of that family. Thank you very much. We have for each of you a pin and a resolution.

Upon your retirement, the Mobile County Commission presents this certificate and wishes to express its sincere thanks and gratitude for your years of dedicated service. Your wisdom and commitment to excellence have long inspired all of us and will be remembered for many years to come. We wish you good health, happiness, and continued success in your retirement.

Let's give them all a round of applause. I don't want to put anybody on the spot, but if anybody would like to say a word or two, now is your chance. You're certainly welcome.

Chief Deputy Sheriff David Wilhelm, Mobile County Sheriff's Office: I am very honored and privileged to have been a part of the Sheriff's Office. It has been an incredible adventure. There has been growth in the Sheriff's Office, largely due to the support of the County Commission. I am thankful for that, and I'm thankful for everything.

President Hudson: Thank you very much.

Commission President Connie Hudson: Do we have any speakers this morning, Dena?

Dena Pollard, Public Affairs Manager: Good morning, Commissioners. Yes, we do. Your first speaker is Mary Elizabeth Harper from GulfQuest.

President Hudson: Okay.

Commission President Connie Hudson: Good morning, Ms. Harper.

Mary Elizabeth Harper, Executive Director, GulfQuest National Maritime Museum of the Gulf of Mexico: Good morning. I am here, first of all, to thank you all in person for helping to bring "Spirits of the Passage: The Story of the Transatlantic Slave Trade" to Mobile and to GulfQuest. Also, I want to tell you that so far, since January 4, 2023, forty-two (42) County employees have come. We're tracking specifically the County employees. So we want to encourage more people to come, and again thank you all very much for making it possible. It's being very well received.

President Hudson: Very good. What is the length of the run for the exhibit?

Mary Elizabeth Harper: It will be here at least through June 21, 2023.

President Hudson: Okay. Very good. I haven't seen it yet, but I'm certainly looking forward to it. When will the official opening be?

Mary Elizabeth Harper: Next week, on Wednesday, March 8, 2023.

President Hudson: Okay. Very good. Thank you for being here.

Mary Elizabeth Harper: Thank you.

Dena Pollard, Public Affairs Manager: The next speaker, John H. Johnson Jr., is here to address Agenda Item #41 and Item #42. **Commission President Connie Hudson:** Mr. Johnson, when you approach the microphone, would you give us your address, please?

John H. Johnson Jr., Board Member, Water Works and Sewer Board of the City of Prichard: Yes. Good morning, Commissioners. My address is 125 East Clark Street, Prichard, Alabama 36610. Commissioners, um, first of all, I would like to thank you, um, for your, um, generous proceeds of one million five hundred thousand dollars (\$1,500,000.00) to the Prichard Water Works and Sewer Board. Um, however, I am asking that Agenda Items #41 and #42 be tabled, um, because these items have not been brought to the full five (5) members of the Prichard Water Works and Sewer Board. Um, forty percent (40%) of the Board at Prichard Water Works and Sewer, um, has not been informed. I have emails to document that. I have citizens here from Districts One, Two, and Five, which you all, please stand. I have Severia Campbell-Morris from District Two, Mr. Gene Doyle from District Five, and also Mr. Jimmy King from District One, and we're, um, up here asking, um, that these agenda items be tabled due to five (5) members of the Board, who has not met nor has those items been mentioned before the five (5) members of the Board. I'm a member of the Prichard Water Works and Sewer Board. I'm glad to see Attorney Jay Ross here because he can attest to the fact that, um, forty percent (40%) of the Board members were not informed about this discussion to make major decisions for Prichard Water Works and Sewer Board. Like, um, I said I have emails to support, um, our request this morning.

Commission President Connie Hudson: Mr. Hodge, Mr. Ross, would you like to respond?

District 3 Commissioner Randall Dueitt: Let me ask you, are you on the Prichard Water Board?

John H. Johnson Jr.: Yes, I am a Board member.

County Attorney Jay Ross: Commissioners, the County Commission approved the original appropriation contract of one million five hundred thousand dollars (\$1,500,000.00).

President Hudson: Would you speak into the microphone?

County Attorney Ross: I thought I was. I'm sorry. The original appropriation contract of one million five hundred thousand dollars (\$1,500,000.00) was approved by the County Commission and the Prichard Water Board a few months ago. So, the Prichard Water Board and the County Commission approved this very similar contract back in October or November 2022. Apparently, the new operations manager had a conversation with a County Commissioner and asked that of the one million five

hundred thousand dollars (\$1,500,000.00); one million dollars (\$1,000,000.00) be allocated to lift station repair improvements and five hundred thousand dollars (\$500,000.00) be allocated to waterline pipes repairs. If the County Commission approves this contract, it has to go back to the Water Works and Sewer Board of the City of Prichard for a full vote, up or down, on the subject matter. It is not unusual for the County Commission to appropriate funds, and then the appropriation documentation would be delivered to the receiving end for that entity's approval or disapproval. This contract, much like the one passed a few months ago, requires the Water Works and Sewer Board of the City of Prichard to spend the money and show proof that repairs were made with the appropriate County standards. If it is, then the County Commission would reimburse the Water Works and Sewer Board of the City of Prichard.

President Hudson: I think the question was about notifications. Are you saying the Board is basically by virtue of the fact took a vote and were notified of the money, but just not about the revision of the change?

County Attorney Ross: Commissioner, I don't know. I heard Mr. Johnson, but I can't speak to whether the full Board was informed about the modification to the contract and if it was considered or not. The full Board would have to vote up or down on this new agreement.

President Hudson: They have the right to decide whether they accept it or not.

County Attorney Ross: If they want it or if they don't.

President Hudson: Okay.

County Attorney Ross: Or if they want it with certain changes. It was previously approved for all of it.

President Hudson: Right. Commissioner Ludgood, this falls within your District. Do you have anything to say?

District 1 Commissioner Merceria Ludgood: As I understand it, the full Board will consider this after we pass it. It'll be at that point where any problems you or anyone else has with it can be brought to the Board. We are approving our offer to provide these funds, and then in your meeting, the Board will decide whether or not to accept our offer.

John H. Johnson Jr.: Okay.

Commissioner Ludgood: You will have an opportunity at that point to make that decision.

John H. Johnson Jr.: Alright. Thank you, Commissioners, especially you, Commissioner Ludgood. You represent the area where the Water Works and Sewer Board of the City of Prichard

is located. That was Cherry Doyle's and my concern. These monies once they are brought to the Water Works and Sewer Board of the City of Prichard and are placed where they have been allocated to go and the proper repairs and improvements, the County Commission has entrusted those monetary funds that the five (5) member Board will have some type of participation, voice, and guidance on how that money will be spent.

President Hudson: There's actually a federal obligation to do that with this money.

John H. Johnson Jr: Thank you. We will be in touch.

President Hudson: Alright. Thank you, Mr. Johnson.

Commission President Connie Hudson: Do we have any more speakers?

Dena Pollard, Public Affairs Manager: The next speaker is Valenia Green. She is here to discuss transitional housing for homeless, working women.

Valenia Green, Executive Director, Azalea City Community Distribution Center (CDC): I want to thank you this morning for allowing me to come and talk to you and express the need concerning homeless women and a transitional shelter for homeless, working women. As you know, I have been homeless. Ι blew the whistle on a local apartment complex called Marigold Apartments. They evicted me because of it. I was forced to find housing, and it was very difficult. At that time, I discovered what it felt like to be homeless. I come from a family that surely wouldn't have been the case. Many of you know my mother. My family rejected my idea of the work I've been doing for the Lord with the food pantry, soup kitchen, and preaching. They kept telling me to stop doing what I was doing. I said no, this is something clearly the Lord has put in me, and I must do it. I must travel this road. Sometimes God gives you a road you don't want to travel, but it's your obligation to walk with God. Especially by me being a clergy. How can I tell you what you need to do with the Lord if I'm not I pray I'll find favor with you today. When I was doing it? displaced in housing, I stayed in hotels like the Holiday Inn across from the University of South Alabama for a month. The whole time I was working, running the food pantry, and passing out Christmas toys and food. I got COVID-19, ran out of money, and had to be put in transitional housing for an extended stay. I couldn't understand my travel until I got there and saw a lot of homeless women working. Many of you didn't know that I was homeless because I was still running the food pantry every

week, doing distributions, and coming to the City Council Meetings with a smile and a Calvin Klein dress on. I pray that God touches your heart. I thank the two (2) women who have helped me in the past with the women that come to my pantry daily in need of help, food, clothes, and toys. I pray that I can get the man's attention to join me in doing transitional housing for working, homeless women. I pray for your strength in the Lord in Jesus' Name, Amen.

Commission President Connie Hudson: Thank you, Ms. Green. Thank you for what you do in the community to help those in need.

Financial charges or taxes levied herein shall constitute a lien on the property against which they are charged a tax in case of default in the payment of such financial charge or tax. By this resolution, the Mobile County Commission does hereby provide for and ratify the levy of all such financial charges or taxes in prior years; and

BE IT RESOLVED and ORDERED by the Mobile County Commission in the State of Alabama, as follows:

ARTICLE I

DEFINITIONS, USE OF WORDS AND PHRASES, AND FINDINGS BY THE COUNTY

Section 1.1 <u>Definitions</u>. The following words and phrases and others evidently intended as the equivalent thereof, in the absence herein of clear implication otherwise, shall be given the following respective interpretations:

a. "Approving Election" means the special county election held in the County on November 6, 2018, pursuant to a call thereof by the Commission's Resolution No. 3 adopted by the Commission on August 27, 2018.

b. "Authorizing Legislation" means Amendment No. 18 to the Constitution of Alabama of 1901, as amended by the amendments to the said constitution, sometimes referred to as Amendment No. 152 and Amendment No. 363, codified as Official Recompilation of the Constitution of 1901, Local Amendments, Mobile County Section 5, and as subsequently amended and modified.

c. "Bondholder" or "holder" means the registered holder, from time to time, of any of the Bonds.

d. "Bonds", unless otherwise indicated, means the County's
\$20,000,000.00 Pay-As-You-Go Road, Bridge, and Drainage
Facilities Bonds, Series 2018C, as more particularly described

0136

in Section 2.2 hereof and issued hereunder.

e. "Commission" means the governing body of the County as from time to time constituted.

f. "County" means the political subdivision of the State of Alabama known as Mobile County as it now exists, and any political subdivision resulting from any merger or consolidation thereof with any other political subdivision. g. "Interest Payment Date" means any June 1 or December 1, commencing June 1, 2023 and continuing until payment of the Bonds.

h. "Local Newspaper" means a newspaper published in the English language and being published and having general circulation in the County.

i. "Redemption Date" means the date on which Bonds shall be called for redemption prior to their stated maturities under any of the provisions hereof.

j. "Redemption Price" means the price at which Bonds may be redeemed on a Redemption Date.

k. "Registrar" means the Treasurer of the County and each successor to the duties of his office.

1. "Special Bond Tax" means the ad valorem tax authorized under the provisions of the Authorizing Legislation to be levied annually on the assessed valuation of all taxable property in the County.

Section 1.2 <u>Use of Words and Phrases</u>. The following provisions shall be applied wherever appropriate herein:

Whenever used herein, any pronoun or pronouns shall be deemed to include both singular and plural and to cover all genders.

"Hereby", "herein", "hereinafter", "hereof ", "hereunder" and other equivalent words refer to this Resolution and Order as a whole and not solely to any particular portion thereof in which any such word is used.

The definitions set forth in Section 1.1 hereof shall be deemed applicable whether the words defined are herein used in the singular or plural.

Section 1.3 <u>Findings of Commission</u>. Having made the due and proper investigation of the matters hereinafter referred to, the Commission hereby finds and determines:

In accordance with the provisions of the Authorizing Legislation, the Commission adopted a Resolution on August 27, 2018, ordering and causing to be held in the County on November 6, 2018, a special election at which there was submitted the proposition of whether the county should issue up to \$60,000,000.00 in principal amount of the County's Road, Bridge, and Drainage Facilities Bonds and levy a tax for the payment thereof.

The said election was duly held in the County on November 6, 2018.

The certification of the results of the said election by the Board of Canvassers provided by law for the purpose of canvassing the returns and declaring the results of the said election shows that there was cast at the said election a total of 113,191 votes, of which a majority, being 83,430 votes, were cast in favor of the said proposition, and 29,761 votes were cast opposing the said proposition.

The Commission has ascertained and hereby declares that it will be necessary to sell at this time and to issue a portion of the principal amount of the Bonds authorized at the said election in order to raise funds to begin the work of constructing and improving roads, bridges and surface drainage facilities in the County that are listed by their project numbers in Resolution No. 1 adopted by the Commission on August 27, 2018.

The life of the roads, bridges, and drainage facilities proposed to be constructed and improved with the proceeds of the sale of the Bonds is estimated to be in excess of 30 years.

ARTICLE II

AUTHORIZATION, DESCRIPTION, EXECUTION, PAYMENT, AND FORM OF THE BONDS

Section 2.1 Authorization and Description of the Bonds. Pursuant to the applicable provisions of the constitution and laws of the State of Alabama, including particularly the Authorizing Legislation and the Approving Election and, to such extent as the same may be applicable, Chapter 81 of Title 11 of the Code of Alabama of 1975, as amended, and for the purpose of raising funds to proceed with construction and improvement of hard surfaced roads, hard surfaced bridges, and drainage facilities in the County that are listed by their respective project numbers in Resolution No. 1 adopted by the Commission at its meeting on August 27, 2018, and for no other purpose, there is hereby authorized to be issued by the County \$20,000,000.00 in principal amount of its Pay-As-You-Go Road, Bridge, and Drainage Facilities Bonds, Series 2018C. The Bonds shall be dated February 1, 2023, shall be numbered from 1 to 8, inclusive, shall be in fully registered form, without coupons, shall bear interest from February 1, 2023, at the rate of 4.00% per annum, payable on June 1, 2023, and thereafter on June 1 and December 1 of each year until their respective maturities, shall mature on December 1 in the following years, and shall be in the following respective principal amounts:

The Bonds shall bear interest at the rate of 4.00% per annum after their respective maturities.

Section 2.2 <u>Execution of the Bonds</u>. The Bonds shall be executed in the name of the County by the manually subscribed signatures of the then acting president of the Commission and of the County Administrator of the Commission. The seal of the Commission, as the official seal of the County, shall be impressed thereon and shall be attested by the aforementioned signature of the County Administrator of the Commission. ARTICLE III

TAXABLE GENERAL OBLIGATION AND PLEDGE OF SPECIAL BOND TAX; AND MAINTENANCE OF THE SPECIAL BOND TAX

Section 3.1 <u>General Obligation and Pledge of Special Bond Tax</u>. The said special pledge is on a parity with all other pledges of the Special Bond Tax at any time validly made for the benefit of certain other bonds of the County for payment of which the Special Bond Tax may be lawfully pledged or used, except (a) such pledge is subject to those existing pledges that have priority thereover, and (b) the obligation of the County to use any ad valorem taxes of the County for payment of the said principal and interest is subject to the requirement imposed by law that the County shall first pay from such ad valorem taxes a pro rata portion of the maturing principal and interest on obligations incurred for the reappraisal of taxable properties in the County. Subject to certain limitations and restrictions, the County has the power of pledging from time to time for payment of the principal of and interest on additional bonds of the County on a parity with the pledge of the Special Bond Tax made for the benefit of the bonds, so much of the Special Bond Tax as may be necessary to pay at their respective maturities the principal of and interest on the said additional parity bonds.

This bond may be redeemed at its face value at any time at the option of the County by giving to the registered holder of this bond, whose name appears on the registry book of the County in which this bond is registered, written notice, either by registered mail or by personal delivery, of the date, time and place of such redemption. Such redemption date may be the same date as that on which such notice is given or on any date thereafter that may be specified in such notice. No publication of such notice, and no other notice of redemption, shall be required, and no interest shall accrue on this bond after the date for redemption specified in such notice. Such redemption may be effected after the giving of such notice by making payment to the registered holder hereof of a redemption price equal to the principal amount hereof plus the interest, if any, that may have accrued on this bond and then remaining unpaid, computed to the date fixed in such notice for such redemption.

This bond is nonnegotiable and is transferable only by transfer duly executed by the person in whose name this bond is registered in the registry books of the County by the Treasurer of the County, as the registrar for the series of bonds of which this is one, at his office in the City of Mobile, Alabama, with such transfer noted hereon by the said registrar. This bond shall be payable at maturity solely to or on the order of the person in whose name this bond is at that time registered on the books of the said registrar and noted hereon by him. No transfer of this bond shall be valid unless it is presented at the office of the said registrar with written

power to transfer, properly stamped if required, in form and with such guaranty of signature as shall be satisfactory to the said registrar, and such new registration noted hereon by him. The said registrar shall not be required to register or transfer any bond during the period of fifteen days next preceding the maturity date of such bond, or if this bond shall have been duly called for redemption prior to its maturity date, the said registrar shall not be required to transfer this bond during the period preceding the date fixed for redemption hereof.

It has been ascertained and found, and it is hereby certified and recited that all conditions, actions and things required by the constitution and laws of Alabama to exist, be performed or happen precedent to or in the issuance of this bond and the creation of the indebtedness evidenced hereby exist, have been performed and have happened, and that the indebtedness evidenced by this bond, together with all other indebtedness of the County, was when incurred and is now within every debt and other limit prescribed by the constitution and laws of Alabama.

IN WITNESS WHEREOF, the County has caused this bond to be executed in its behalf by the President of the County Commission and by the Administrator and Clerk of the County Commission, both of whose signatures have been manually subscribed hereunder, has caused the seal of the said commission as the official seal of the County to be impressed hereon, and has caused this bond to be dated February 1, 2023.

ARTICLE III

TAXABLE GENERAL OBLIGATION AND PLEDGE OF SPECIAL BOND TAX; AND MAINTENANCE OF THE SPECIAL BOND TAX

Section 3.1 General Obligation and Pledge of Special Bond Tax. The indebtedness evidenced by the Bonds is and shall be a general obligation of the County and the full faith and credit of the County are hereby irrevocably pledged to the payment of the principal thereof and interest thereon. In addition, the County does hereby appropriate and agree to use, and does hereby specially and irrevocably pledge, for payment of the principal of and interest on the Bonds at the respective maturities of the said principal and interest, so much of the Special Bond Tax as may be necessary for the said purpose, including the surplus proceeds on hand-collected under the levies of the Special Bond Tax made for prior tax years of the County. The said special pledge shall be on a parity with all other valid pledges of the Special Bond Tax at any time made for the benefit of certain other bonds of the County at any time issued, subject, however, to any valid prior pledges thereof which may have priority thereover under the terms of any contract heretofore made by the County in the issuance of any other bonds of the County now outstanding.

Section 3.2 <u>Continued Levy of the Special Tax</u>. The County agrees that, so long as the principal of or interest on any of the Bonds remains unpaid, the County will annually levy and collect, in the manner and at the times provided by the constitution and laws of the State of Alabama, so much of the Special Bond Tax as may be necessary to provide for the payment of the principal of and interest on the Bonds and all other bonds at any time entitled to share in the proceeds of the Special Bond Tax, as the said principal and interest shall respectively mature.

ARTICLE IV

OPTIONAL REDEMPTION PROVISIONS

Section 4.1 Optional Redemption of the Bonds; Notice of <u>Redemption</u>. The Bonds may be redeemed in whole at the option of the County at any time by giving to the Holder thereof written notice of the County's election to exercise such option. Such notice of redemption shall contain the Redemption Date and the Redemption Price and may be effectively given by personal delivery thereof or by United States registered mail and shall be effective upon actual receipt thereof by the Holder. The Redemption Date may be the effective date of the notice of redemption or any date thereafter.

Section 4.2 Redemption Price; Procedure for Redemption. The Redemption Price for the Bonds shall be an amount equal to the principal amount of the Bonds to be so redeemed plus accrued interest thereon to the Redemption Date. Upon delivery to the Bondholder of such written notice, the Bonds called for redemption in such notice shall be payable at the Redemption Price and on the Redemption Date specified in such notice, and all interest that would otherwise have accrued on the Bonds subsequent to the Redemption Date shall cease to accrue thereafter and the Bonds so called shall no longer be entitled to the benefit of the lien of the pledge herein made but shall look solely to the funds made available to effect such The County Treasurer shall cause to be paid, on redemption. the Redemption Date, to the Holders of the Bonds so called for redemption on such date, the face amount of the Bonds so called plus accrued interest thereon to the Redemption Date, which payment shall be made upon surrender of the Bonds so called for redemption on the date specified in such notice for such redemption.

ARTICLE V

REGISTRATION OF THE BONDS

Section 5.1 Registration of the Bonds. The Bonds shall be registered as to both principal and interest. The Treasurer of the County is hereby appointed as the Registrar and transfer agent for the Bonds, and he is authorized to keep at his office in the City of Mobile, Alabama, proper registry books in which he shall register the Bonds, as to both principal and interest, noting the registry on the Bonds so presented. Such registration shall conclusively designate the Bondholder as the sole person to whom or on whose order the payment of the principal of and interest on the Bonds so registered may be made. After such registration, no transfer of a Bond so registered shall be valid unless it is presented at the said office with written power to transfer, properly stamped if required, in form and with guaranty of signature satisfactory to the Registrar, and such new registration noted thereon by the Registrar. The Registrar shall not be required to register

or transfer any Bond during the period of ten days next preceding the date of its stated maturity; and, if any Bond shall be duly called for redemption pursuant to the provisions hereof, the Registrar shall not be required to transfer such Bond thereafter prior to the date fixed for its redemption.

Section 5.2 <u>Effect of Registration</u>. The County, the Registrar, and the Paying Agent may deem and treat the person in whose name a Bond is registered on the books of the Registrar as the absolute owner thereof for all purposes; they shall not be affected by notice to the contrary; and all payments by any of them to the person in whose name a Bond is registered shall, to the extent of such payment, fully discharge all liability thereof.

ARTICLE VI

EXECUTION AND DELIVERY OF THE BONDS; USE OF PROCEEDS THEREFROM

Section 6.1 <u>Authority to Execute and Deliver the Bonds</u>. The then acting President of the Commission and the Administrator and Clerk of the Commission are hereby authorized and directed to cause the Bonds to be executed, sealed, and attested as provided herein and delivered to the purchaser thereof upon payment to the County of the sale price therefor. All actions of the Commission, the then acting President of the Commission, and the County Administrator in causing the sale of the Bonds are hereby ratified and confirmed.

Sale of Bonds. The Bonds shall be sold and Section 6.2 delivered to Regions Bank, the selected purchaser thereof, on February 27, 2023, or on such other date as may be mutually agreeable to the County and said bank, against payment to the County by the said purchaser of the purchase price for the said bonds plus the interest accrued on the Bonds from February 1, 2023, to the said date of delivery thereof. The County hereby approves the payment of an origination fee to Regions Bank in the amount of \$2,500.00, which shall be paid at or within ten days following the date of delivery of the Bonds. Contemporaneously with the delivery of the Bonds to the said purchaser and payment to the County of the purchase price, therefore, the then acting President of the Commission is authorized to cause the said bonds to be registered in the name of the said purchaser by the County Treasurer, as the registrar therefor.

Section 6.3 <u>Application of Proceeds of Sale</u>. The proceeds derived from the sale of the Bonds shall be used solely for the purpose of paying the expenses of the authorization and sale thereof and acquiring, providing, constructing, and improving the roads, bridges, and surface drainage facilities in the County that are listed in the Commission's Resolution No. 1 adopted on August 8, 2022.

ARTICLE VII

MISCELLANEOUS PROVISIONS

Section 7.1 <u>Contractual Provisions</u>. The provisions of this resolution shall constitute a contract between the County and the Bondholders. Upon payment in full of the principal of and interest on the Bonds, the obligations of the County hereunder shall cease.

Section 7.2 <u>Bonds Payable at Par</u>. Each bank at which the Bonds may at any time be payable, by acceptance of its duties as paying agent therefor, shall be construed to have agreed thereby with the Holders of the Bonds that all remittances made by it on the Bonds shall be made in bankable funds at par and without deduction for exchange, fees or expenses.

Section 7.3 <u>Severability</u>. The various provisions of this resolution and order are hereby declared to be severable. In the event any provisions hereof shall be held invalid by a court of competent jurisdiction, such invalidity shall not affect any other portion of this resolution and order.
