# PRESENT RESOLUTION/PROCLAIM JANUARY 23, 2023 AS LAW ENFORCEMENT APPRECIATION DAY

WHEREAS, we greatly appreciate the extraordinary efforts and sacrifices made by officers and their family members daily in order to protect our community and residents;

NOW, THEREFORE, LET IT BE RESOLVED that the Mobile County Commission proclaims January 23, 2023 as:

in Mobile County. We say, "Thank you" to the men and women in uniform who protect and serve our communities. Furthermore, we encourage residents to show members of law enforcement how much we value their service and protection. Be assured, "We've got your six."

**President Hudson:** We could not let today go without a special recognition for those forty-seven (47) years and everything you have done in your service to the County. We want to let you know how much we appreciate that.

PRESENT RESOLUTION/COMMENDATION FOR PROFESSIONAL ACHIEVEMENT/DECLARE JANUARY 23, 2023 AS SAM COCHRAN DAY

WHEREAS, the Mobile County Commission recognizes former Sheriff Sam Cochran for his many years of dedicated service to Mobile County. He officially retired from law enforcement on January 16, 2023, after serving as Sheriff of Mobile County for the last sixteen (16) years; and

WHEREAS, in 2006, Sam Cochran was elected Sheriff of Mobile County and re-elected to four-year terms in 2010, 2014, and 2018. He has received countless accolades and awards during the course of his career. One of his most distinctive honors was being appointed by Governor to serve as a Commissioner on the Alabama Police Officers Standards and Training Commission; and

WHEREAS, throughout his law enforcement career, Sam Cochran has performed a myriad of duties, including thirty-one (31) years of service with the Mobile Police Department (MPD). He began his career with MPD as a Police Cadet and worked his way through the ranks to become Police Chief, a position he held for ten (10) years; and

WHEREAS, Sam Cochran is a native of Mobile County. He graduated from McGill Institute and earned both a bachelor's degree and a master's degree in Criminal Justice and Public Administration from the University of South Alabama. He also has certification from the Federal Bureau of Investigation (FBI) National Academy;

NOW, THEREFORE, the premises considered, the Mobile County Commission, finding and determining that a public purpose will be served thereby, DIRECTS, that in the event of future tornados identified by the National Weather Service in Mobile County, the Public Works Department is to undertake removal of tornado debris, not to include household garbage, appliances, or hazardous waste, along county rights-of-ways, within the impacted areas identified by the National Weather Service, as expeditiously as may be possible.
