Corporal Davis volunteers to work in other areas of the Mobile County Sheriff's Office Metro Jail (Docket, Security, Barracks and Court Annex) without hesitation. His volunteering is done after he has completed his assigned duties in Transportation, as a matter of fact, when a supervisor asks for help they always request Corporal Davis. He always stays late or comes in early to complete whatever task(s) he is assigned. Corporal Davis volunteered to drive to Sacred Heart Hospital in Pensacola, Florida, to pick up kids with cancer during Camp Rap-A-Hope which was held at Camp Grace in Mobile, Alabama, and then drove the kids back to Pensacola, Florida after Camp Rap-A-Hope was completed.
