They were not able to be here today, but we will also recognize them.

MOBILE COUNTY RECOGNIZES  
AMERICANS WITH DISABILITIES ACT (ADA)  
31ST ANNIVERSARY

**WHEREAS**, the Americans with Disabilities Act (ADA) was passed on July 26, 1990, to ensure the civil rights of citizens with disabilities and establish a clear and comprehensive national mandate for the elimination of discrimination against individuals with disabilities; **AND**

**WHEREAS**, Mobile County, Alabama affirms the principles of equality and inclusion for persons with disabilities as set forth by the State of Alabama and as embodied by the Americans with Disabilities Act (ADA); **AND**

**WHEREAS**, the Americans with Disabilities Act (ADA) has expanded opportunities for Americans with disabilities by reducing barriers, changing perceptions, and increasing full participation in community life; however, the full promise of the Americans with Disabilities Act (ADA) will only be reached if we remain committed to continue our efforts to fully implement the Americans with Disabilities Act (ADA); **AND**

**WHEREAS**, numerous organizations in Mobile County work with constituents and communities to bring forth the promise of hope and freedom that is envisioned by the passage of the Americans with Disabilities Act (ADA);

**NOW THEREFORE, LET IT BE RESOLVED**, that the Mobile County Commission does hereby recognize July 26, 2021 as the thirty-first (31st) anniversary of the Americans with Disabilities Act (ADA); furthermore, we also acknowledge the progress made by reaffirming the principles of equality and inclusion and recommitting our efforts to reach full Americans with Disabilities Act (ADA) compliance.

**Jim Flora, Independent Living Center of Mobile:**

Commissioner Hudson, Commissioner President Ludgood, and Commissioner Dueitt, on behalf of the Independent Living Center of Mobile, I would like to thank you for the recognition and the opportunity to speak to you today. On July 26, 1990, the Americans with Disabilities Act (ADA) was signed into law. Today, on July 26, 2021, we celebrate the thirty-first (31st) anniversary. The Americans with Disabilities Act (ADA) provides guidelines and protections for about fifty-four million (54,000,000) people who have disabilities in the United States to be more fully included in all the activities of the community. The Americans with Disabilities Act (ADA) ensures the rights of people with disabilities in the areas of employment, public services provided by state and local governments, public accommodations, services operated by private entities, telecommunications, and other miscellaneous areas such as construction and design regulations. The Americans with Disabilities Act (ADA) has opened many doors to people with disabilities and has provided many support centers and accommodations that have made participation in community life more readily accessible. The mission of the Independent Living Center of Mobile is to foster and promote programs which empower persons with disabilities to obtain their maximum degree of independence while providing them with education, advocacy, and protection of their personal rights. We celebrate our partnership with you in fostering compliance with the Americans with Disabilities Act (ADA). We appreciate the support of both the county
