MOBILE COUNTY COMMISSION

The Mobile County Commission met in regular session in the Government Plaza Auditorium, in the City of Mobile, Alabama, on Monday, March 23, 2020 at 10:00 A. M. The following members of the Commission were present: Jerry L. Carl, President, Merceria Ludgood and Connie Hudson, Members. Also present were Glenn L. Hodge, County Administrator/Clerk of the Commission, Jay Ross, County Attorney, and W. Bryan Kegley II, County Engineer. President Carl chaired the meeting.

**President Jerry L. Carl:** Welcome to the Mobile County Commission regular meeting on March 23, 2020. We have Commissioner Merceria Ludgood who is going to open us up with a word of prayer.

INVOCATION

The invocation was given by Merceria Ludgood, Mobile County Commissioner of District 1.

**Dena Pollard, Public Relations Officer:** Good morning, Commissioners. We have an open letter from Chicken Salad Chick franchise owner, Misty Whitehead. It will be presented by Commissioner Connie Hudson.

**Commissioner Connie Hudson:** Good morning, Commissioners. Ms. Whitehead asked that I read this letter given the circumstances of trying to eliminate having a large crowd today. She has decided to send a letter of communication. It reads:

I am writing this letter to ask that you consider deferring our monthly ten percent (10%) payments. With portions of Government Plaza and downtown Mobile closing, it has cut our business to thirty percent (30%) of what it was prior to the COVID-19 outbreak. I have four (4) staff members that I would love to keep on the payroll for as long as possible. As of today, I was able to make payroll for the last two (2) weeks. I am assuming that sales will continue to decrease at our Government Plaza location. If the decrease continues, we may have to close this location down until the debilitating virus passes. Please let me know your thoughts. Thank you.

**Commissioner Hudson:** What I would request and recommend in this case, she is asking for a deferment until her restaurant operations return to normal. I would ask that we include a resolution in the form of a motion, I will make the motion on the agenda for an add-on agenda item that would defer her rental payments. This would amend the contract; the agreement we have with Chicken Salad Chick to defer payments for eight (8) weeks or until the point when restaurant services return to normal. I think it is the fair thing to do. I think these business owners are suffering all over the country and certainly here in our area as well. Even the Federal government and State of Alabama are taking steps to try to help alleviate some of the suffering with Federally backed home mortgages and deferment of payment on that. I think this is entirely appropriate as the landlord of this business.

**President Jerry L. Carl:** We have a motion on the floor.

**Commissioner Hudson:** Are we going to take it up now?

**President Carl:** Yes.

**Commissioner Hudson:** I made the motion.

**President Carl:** Commissioner Hudson, I don't think it will pass simply because I understand what Misty Whitehead, franchise owner of Chicken Salad Chick, is saying and I sympathize with that. How do we treat Chicken Salad Chick special and different from how we do the other restaurants in downtown Mobile? With Chicken Salad Chick being here, it is certainly benefiting more because I have eaten there for the last five (5) lunches. Mainly because I am tied up with phone calls and conferences. It is still an opportunity here when you look at some of the other restaurants in town, it is zero (0).

**Commissioner Hudson:** President Carl, we are not the landlord for the other restaurants. I would hope very much that whoever is the landlord or whoever they pay their rental payments to would take some sort of mercy on their current situation as well. If not, we will see many businesses close and may never reopen. Chicken Salad Chick has provided a tremendous benefit to you and others at Government Plaza right now when take-out food is all that is available. Maybe taking food home to families or if, since we still have employees that are working here, to be able to eat. Chicken Salad Chick is not asking to waive any payments. Misty Whitehead, franchise owner of Chicken Salad Chick, is asking for payments to be deferred until operations return to normal. Chicken Salad Chick is down over sixty percent (60%) of its revenue. Ms. Whitehead is trying to keep people on the job here to be able to work. I think it is very little. In terms of what Mobile County

Commission has provided, right now the Commission is waiving all rental payments to the City of Mobile and subsidizing their utilities to the rate of five hundred thousand dollars (\$500,000.00) a year. If the Mobile County Commission can do that for the City of Mobile, surely we can defer payments, not waive them, for a couple of months for Chicken Salad Chick until they can get on their feet. I am hoping the other restaurants and the other businesses are working and they will be able to survive as well. Whoever they work with or whoever their landlord is, I am hoping they will have mercy on them as well.

**President Carl:** Okay. Chicken Salad Chick's lease is based on what they sell, correct? If they sell one thousand dollars (\$1,000.00) worth of food today, they owe the Mobile County Commission one hundred dollars (\$100.00) in rent today. It is all based on sales. If Chicken Salad Chick does not sell anything, it does not owe the Mobile County Commission anything.

**Commissioner Hudson:** They still have to pay staff.

**President Carl:** I have been in enough businesses. I understand that. I got that part. They are preparing the food off-site and are bringing it in. It is a limited staff here at Government Plaza. They are down to two (2) from the last couple of times I went in there. We do not need to argue this. I am saying it is a very delicate situation and the Mobile County Commission is helping a business versus helping all of the businesses. If I had a way to affect all of the businesses, I would say this is fair and I would certainly do it. This is based not on rental, but on sales dollars. It is not a set rate Chicken Salad Chick is paying, so it is a pretty good deal.

**Commissioner Hudson:** It is a good deal for Mobile County with the revenue the County has brought in.

**President Carl:** How much has Mobile County brought in?

**Commissioner Hudson:** One month, it was over two thousand dollars (\$2,000.00). Chicken Salad Chick is down sixty percent (60%) and Misty Whitehead, franchise owner of Chicken Salad Chick, is trying to maintain staff. That is the thing. If she cannot make payroll, she will have to close the location. Regardless if it is ten percent (10%), she still has to pay her staff. She is not able to do that if this continues.

**President Carl:** I think the pushback you are getting here is it is hard to do something for one person and not do it for everyone.

**Commissioner Hudson:** Like I said before, we are not the landlord for every other business in downtown Mobile. Chicken Salad Chick is in the County's building, and the Mobile County Commission is the landlord.

**President Carl:** Okay.

**Commissioner Hudson:** Does this die for lack of a second?

**President Carl:** I would say it does. We can certainly take it up at a different time.

**Commissioner Hudson:** I am not sure Chicken Salad Chick has any more time. I think Misty Whitehead, franchise owner of Chicken Salad Chick, will have to close this location.

**President Carl:** Commissioner Hudson, everybody is in this situation. Everybody is going to take a hit. Everybody is going to suffer a little bit, including us as the County. We have to suffer. We cannot show preference to people and especially ourselves and people around us when there are people who are truly hurting.

**Commissioner Hudson:** With all due respect, I do not see it in the same light that you do.

**President Carl:** We have single mothers out there who are only working for tips and you are saying to treat Chicken Salad Chick different than them? I do not see it as that. No. I am sorry. It dies. Let's move on.

APPROVE AMENDED INFECTIOUS DISEASE/  
PANDEMIC POLICY/MAKE A DECLARATION  
THAT THE COUNTY IS AT LEVEL II

**President Jerry L. Carl:** Let's take just a minute. I know we have a lot of questions. Commissioner Hudson, thank you for coming back and adding a lot to this. Your help was tremendous. I have some issues with the pay-scale and how we have it figured out. According to this, if someone is sent home under Level II, they receive time and a half pay. Is that correct?

**Commissioner Connie Hudson:** No. At Level II, the only employees that would receive time and a half pay are those who have to continue to interact with the public. This is hazardous pay. At Level III, those who have to come into the office and interact with other employees. It's the public interaction that brings on this time and a half pay because it is hazardous pay. They're putting their health at risk, where someone who is working at home does not have the same level of risk.

**President Carl:** Okay. If we send staff home, are they automatically time and a half pay or will they stay at regular pay?

**Commissioner Hudson:** No. Everyone is regular pay unless you receive hazard pay because you are dealing with the public. That would be the first responders.

**President Carl:** This is the problem, first responders. You have people who work the switchboards, people who do not come in contact that have to be on-site. Do they fall within these parameters of time and a half pay?

**Commissioner Hudson:** No. The reason is because what we are trying to do here and what this policy does is it makes all employees financially whole at every level. Everybody is getting paid their salary for what they were hired to do.

**President Carl:** I understand.

**Commissioner Hudson:** For those who have to interface with the public with direct contact receive the hazardous pay. In Level III, when all non-essential employees are sent home, they receive their regular pay. The essential employees who are at home working, which is a benefit in itself to be able to work from home, they are working on specific tasks. Who is to say they will be working eight (8) hour days. Dispatchers and other people who are not encountering the public, they are receiving their regular pay. I think that is fair. We talk about everybody having to face this crisis situation. I think the fact that the Mobile County employees receive regular pay at all levels of these precautionary measures is a good thing. We are not having to lay off people. Everybody is receiving their pay.

**President Carl:** Nobody is arguing that. I am just trying to make a point here when it comes to the Mobile County Sheriff's Department. That is a little bit different. They have to ask people that are on the switchboards to come in. It is very important they have people there for the phone calls coming in. I think we should leave that at the Sheriff's discretion on whether to pay them time and a half pay or not. To be just for the employees who come in contact with the public, it doesn't limit us. I think it limits Sam Cochran, Mobile County Sheriff, because people can stay at home and make full pay without coming to work on those sensitive jobs and make time and a half pay.

**Commissioner Hudson:** You know, I disagree, President Carl. I think if you have the benefit of working from home, you are not put in contact with other employees and you're not in contact with the public. Even the dispatchers. A dispatcher at work is encountering other employees so that would cover the employee at Level III if you're a dispatcher. Now at Level II, I think in terms of fairness, we have administrative employees who can do payroll from home and can do other jobs from home. I do not think at a Level II, we need to pay everyone at time and a half pay.

**President Carl:** I agree.

**Commissioner Hudson:** I think what it would appear to the public is that our employees are being allowed to profit off of this situation. If you talk about wrong, I think that is wrong.

**President Carl:** I do not think anybody is arguing with you on that, Commissioner Hudson. What I am saying is there is some exceptions to the Mobile County Sheriff's Department that we have to be sensitive of. I do not think anybody is arguing with you. I thought this was very good. I think a cut-out needs to be the Mobile County Sheriff's Department. We need to leave the discretion up to Sam Cochran, Mobile County Sheriff as to how to run his department. He is an elected official. He has a right to do that. We are not out there on a daily basis. We do not know what it takes to support these people in the field, especially through this crisis. All I am saying is let's give Sam Cochran, Mobile County Sheriff, some leniency that he can work with to work with his people.

**Commissioner Hudson:** I think the Mobile County Sheriff's Department should follow the policy in the same respect the License Commission's Office, Revenue Commission's Office, and County Administration do. If you have employees who are working in the field as first responders, they are working as correctional officers, they are encountering the public, they are encountering other employees, by that token, certainly they would go into that time and a half pay category. If they have employees that can work from home just like our County Administration employees, they should receive straight salary. They are receiving what they were promised. They are not putting themselves at risk. We are not giving this latitude to any other department or any other department head. We should not make a special exception in this case.

**President Carl:** You cannot field phone calls from the public at home. That is impossible to do. We are asking these men and women to come in and man these phones.

**Commissioner Hudson:** They will receive time and a half pay for it. If they are coming into work, they receive time and a half pay. If they are working at home and do not have to come in to work, they do not have to go into the field; they are straight salary. That is the way it should work. I think the confusion here is the understanding that the people who work for the Mobile County Sheriff's Department and why we have singled them out because I know Sam Cochran, Mobile County Sheriff, has emailed and asked for all of his employees to receive time and a half pay. That does not work across the board. We cannot make a special exception when he has employees he can assign to work from home. You can answer the phone

from home in some cases. If the employees that have to be on the job and fulfilling their responsibilities and it requires for them to come in contact with other employees or the public, they would receive time and a half pay. That is hazardous pay.

**President Carl:** Commissioner Ludgood, do you have anything you want to add?

**Commissioner Merceria Ludgood:** No, I agree with Commissioner Hudson.

**President Carl:** Alright.

**Jay Ross, County Attorney:** Commissioners, does this include exempt employees too? Some employees are exempt.

**President Carl:** Who would you consider exempt?

**Jay Ross:** Directors, not me, the legal staff. I am sure there are other people too.

**Commissioner Hudson:** Unless there are reasons, we may need to look at that further. There are a lot of layers to this onion. We are trying to figure out the best way possible to move forward and to keep everybody whole. We will have to look at that. At this point in time, it is how it is written. That would include everybody. Unless we see a reason and there are things we may not quite fully understand in this process as we move forward that we may have to adjust.

**Jay Ross:** Okay.

**Don Davis, Probate Court Judge:** Commissioners, may I make a comment?

**Commissioner Hudson:** Certainly.

**President Carl:** Sure. Come down, Judge Davis, so we can all hear you.

**Don Davis:** In regards to this proposed policy, when members of the Probate Court Administration and I met with members of the County Administration this past Friday, we understood that part of our role as an Appointing Authority and Department Head, was that we needed to identify those aspects of Probate Court's operations that are essential and those aspects of the Probate Court's operations that are not essential. That is the process we have been endeavoring to do starting on Friday, March 20, 2020, and continuing to today is to determine what is essential in our operations and what is not essential. Once we do that, we understood the next process would be for us to identify what employees are capable of providing those essential

services, the ones we have identified. Once we identify, maybe more than one (1) employee can serve that essential function. In terms of staffing the essential function, we understood that you could rotate who is providing the essential function and spread it amongst those qualified to address the function. I want to make certain I am understanding or did we approach this in the incorrect way. I think where you have essential functions and essential employees, those are two different things as I see it. One is apples and one is oranges, in a sense.

**Commissioner Hudson:** Right.

**Don Davis:** I hope I am making some kind of sense to you in what I am trying to convey.

**Commissioner Hudson:** I think your approach is as far as sharing those responsibilities, I do not think there is a problem in the world with that. It is probably a very good idea. You may have to keep track of the times the employees are coming to work and receive the hazard pay as opposed to those who do not.

**Don Davis:** Of course.

**Commissioner Hudson:** It is an administrative function to keep track of.

**Don Davis:** Definitely. We understand that. To give you an example, under the Supreme Court directives, we are to remain open and deal with mental health and involuntary commitment matters and also emergency guardianship and conservatorship matters. These are essential functions in the Judicial part of the Probate Court's operation. You contrast that to adoption proceedings. Adoptions, while they are important, they are not an essential part of the Probate Court's operation right now that we have to stay open to address through the Judicial Division of the court. Those are the distinct kinds of differences I am seeing and how we are trying to approach this. I just want to make certain that we are doing it in the correct manner. I would just say that essential functions are different from essential personnel. Again, I hope something here is resonating.

**Commissioner Ludgood:** It makes sense to me. What you are explaining is what I think we all are doing or are supposed to be doing.

**Commissioner Hudson:** Right.

**Commissioner Ludgood:** That is the way I understand the formulation you just made is what I understood it to be.

**Don Davis:** Okay.

**Commissioner Hudson:** You have to know what your essential responsibilities are to know who you are going to assign to those responsibilities.

**Don Davis:** Right.

**Commissioner Hudson:** You are on the right track.

**Don Davis:** Not everybody is qualified to provide all of our essential functions.

**Commissioner Hudson:** Exactly.

**Don Davis:** We might be able to move people around to share the essential functions.

**Commissioner Hudson:** I do not see why that couldn't be allowable. That makes sense.

**Don Davis:** Okay. Thank you for letting me inquire.

**Commissioner Hudson:** Thank you, Judge Davis.

**President Carl:** Thank you.

**Commissioner Hudson:** There is one (1) amendment to the amendment I would like to make. This is the very last sentence. It says the Mobile County Commission will, I would like to add at its discretion, declare a change in precautionary status, method of employee compensation, I would like to add that because at some point, there may have to be a method change of compensation or an end to the state of emergency as it relates to the Infectious Disease Pandemic Outbreak so it adds some flexibility there. One thing I would like to add; there are a few typographical errors found. I am not going to go over each. It's replacing as with are and that sort of thing. But I would like to include those before this is released to the public. It is nothing substitutive, it is just words here and there that maybe have been left in from the previous policy.

**Glenn L Hodge, County Administrator:** We will get with you on that.

**Commissioner Hudson:** Okay.
