MOBILE COUNTY COMMISSION

The Mobile County Commission met in regular session in the Government Plaza Auditorium, in the City of Mobile, Alabama, on Monday, March 9, 2020 at 10:00 A. M. The following members of the Commission were present: Jerry L. Carl, President, Merceria Ludgood and Connie Hudson, Members. Also present were Glenn L. Hodge, County Administrator/Clerk of the Commission, Jay Ross, County Attorney, and W. Bryan Kegley II, County Engineer. President Carl chaired the meeting.

President Jerry L. Carl: Good morning, everyone. Welcome to our regular meeting on March 9, 2020. We will have a prayer by Commissioner Connie Hudson and then we will do the Pledge of Allegiance.

INVOCATION

The invocation was given by Connie Hudson, Mobile County Commissioner of District 2.

Ed Bridgman, Homestead RV Community: Good morning. You may remember that I attended a Commission Meeting a few months ago to introduce you to the most technologically advanced Recreation Vehicle (RV) community in the world when it opens. It is right here in the Fowl River, Alabama area. Homestead RV Community will open on the fourth quarter of 2020. I am here today to officially invite each of you to the groundbreaking ceremony on March 24, 2020 at 8:30 A.M. or March 25, 2020 in the event of rain. Homestead RV Community will satisfy the current trend of people who want to work where they live and live where they vacation. Homestead RV Community will provide the fastest internet access available with fiber optic cable throughout. For the protection and comfort of Homestead RV Community's guests, each site will have individual, private, hot and cold jetted tubs. They have a locking lid on top. For the protection of the environment, Homestead RV Community will be a very green community. All contracts, waivers, maps, and communications will be accomplished through an app called Homestead RV Community app. It is located just seven-tenths (7/10th) of a mile from the SaltAire Shoreline, which will allow the guests to enjoy hiking, fishing, canoeing, kayaking, biking, and bird

watching, which are all in the top ten (10) things people like to do while on vacation. I do hope you would join us on March 24, 2020 for the groundbreaking. Do you have any questions?

President Jerry L. Carl: Do you have any idea what the rate is going to be per month?

Ed Bridgman: We are going to start out at seven hundred dollars (\$700.00) per month to nine hundred dollars (\$900.00) per month, depending upon the location and the size. The smallest site that Homestead RV Community will provide is eighty-two feet long by forty feet wide (82'x40'), which is more than twice the size of your average site. The reason for this is to separate people and give them more of a front yard feeling where you will be able to play catch in your front yard.

President Carl: Will it be available to daily renters
and weekly renters?

Ed Bridgman: Absolutely yes, in order to accommodate SaltAire Shoreline.

President Carl: Okay.

Commissioner Connie Hudson: Thank you for the invitation.

President Carl: Thank you very much. Do we have a
meeting after this one?

Ed Bridgman: Yes, sir, we do.

 $\mbox{\bf President Carl:}$ Alright. You can follow me up when we leave. Thank you.

Ed Bridgman: Thank you.

Adranell Murray, O'Fallon Subdivision: I would like for you to imagine this. You buy a home worth two hundred fifty-thousand dollars (\$250,000.00). You are lying in your bed one (1) morning at 7:00 A.M., and you hear people outside cutting your fence. You started with a lot of trees on one (1) side of your lot that are now laying in piles. They are cutting the fence and then they tell you they have the right to do that. The next week, you wake up and they are out there again just like this morning at 7:00 A.M. Now there is a big hole in the lot next to you. Somebody decided they can dig and do these things; you do not know what is going on. Now you are out constantly fighting for your property line. To put it into another

conception, you are not from Alabama. You are from New Orleans, Louisiana, where they do things a little differently. You are also a military veteran, so you have your own set of issues. You have protected the rights of others and you feel helpless because these people have come to cut up the lot. I live in the O'Fallon Subdivision. It is near Bernice J. Causey Middle School. O'Fallon Subdivision is a brand new subdivision that is between Cottage Hill Road and Johnson Road. McFarland Road is the outside road. I told the representative from Turner Construction to stop this right now. I went into combat mode. I went out there, stopped them, and asked what was going on. I was told the homeowners association representative is supposed to tell you. I advised him we do not have a homeowners' association because the man that owns the land has decided he will make a profit by keeping the homeowners' association. I do not receive any messages. I am fighting for the placement of my property line. I took ropes and other gear to set the property boundary. Now I am thinking of safety because now there is a big cliff that goes down on one (1) side of my yard. They are messing with the property lines and are moving the stakes back and forth. They are saying this is the head of the retention pond, this is the top of it. This is my land.

President Jerry L. Carl: Is this another subdivision
coming in?

Adranell Murray: No, it has been there. It was built in 2017.

President Carl: What Turner Construction is working
on now is an old subdivision?

Adranell Murray: It is not old. It is a little over two (2) years old.

President Carl: I meant it already exists.

Adranell Murray: Correct.

President Carl: Tell me again where it is located?

Adranell Murray: It is between Cottage Hill Road and Johnson Road. Part of it is not too far from Cottage Hill Park. I apologize as I am not really familiar with Mobile, Alabama.

President Carl: Can you tell us where it is at?

Matthew Barclift, Engineering Development Manager: She is exactly right. I do not know how to better describe it than being on the west side of McFarland Road. Cottage Hill Park comes off of Johnson Road and it backs up to O'Fallon Subdivision.

President Carl: Okay. I just got it. Thank you.

Matthew Barclift: We will send out an inspector to put a stop work on this for right now. This is probably an expansion of the retention pond that has been proposed. Turner Construction is building a second phase of O'Fallon Subdivision and they are proposing to expand the retention pond from the first phase.

President Carl: Okay.

Adranell Murray: This is a picture of my fence and they put a stake for the property line. Next to their stake is the top of the retention pond. I do not know how someone can put the top of a retention pond on someone's property line. As you can see, the stakes are really close. I am thinking about number one, safety. Number two, I have a home I bought worth two hundred fifty-thousand dollars (\$250,000.00) which I think might now slide down into the retention pond. At any rate, no one told me anything. I think there is something wrong with that picture.

President Carl: That is what a homeowners' association is for. Did you say there is not a homeowners' association?

Adranell Murray: The man making the money off of it is over the homeowners' association. He owns the land.

President Carl: Okay. I do not hold a grudge against someone wanting to make money. There is not a problem with that.

Adranell Murray: It is a conflict though. It is a conflict if he is building and developing this land for a profit, it would not profit him to inform me of the expansion of the retention pond because then I would come here to the County Commission like I am doing now.

President Carl: Give us and our Engineering Department a chance to look at it. This is the first time I have heard of this. Have we approved of some expansion over there that anyone is aware of?

Matthew Barclift: We have reviewed a set of plans, but we have not approved them yet.

President Carl: This is the man here that approves or denies plans. If you'll give us a chance to look at them and make sure we have your contact information. This is in my district and I will get back with you.

Adranell Murray: Thank you.

President Carl: Thank you for your service.

Adranell Murray: Thank you for your support. I have a second thing, since I am here. Coming up at the Mobile Veteran Center, where I work, we are having a commemoration for Vietnam veterans on March 27, 2020. I have some flyers I will leave. This is for any veteran who served during the Vietnam era, because we know Vietnam veterans did not receive a proper welcome home. Every year we give them this welcome home. We have pins for commemoration. I work there as a psychotherapist for veterans who are battling combat issues. That is not just for those veterans. We also have a resource fair for other veterans who may have not served during combat so they can come and receive information on services that are available to them.

President Carl: Thank you. Do we have any Vietnam
veterans in here?

Adranell Murray: Thank you for your service.

President Carl: Thank you so much.
