**President Merceria Ludgood:** We have some very special guests. The Azalea City Quilters always come down around this time of year to share with us the beautiful work they do and to recognize some important people in our community. I would like to turn this aspect of our agenda to Commissioner Connie Hudson.

**Commissioner Connie Hudson:** Thank you, Madame President. I would also like to welcome today the Azalea City Quilters and their representatives who are led by Joyce Reed. This is the fourth (4th) year. It is becoming a time-honored tradition in November around Veteran's Day. We certainly want to take the opportunity to focus attention on all of the dedication, sacrifice, and service of our veterans, what they have done, and how it has made our country great. This is what we can do to help support their efforts with the Quilts of Valor by hosting this event every year and to recognize individuals who have had exemplary and distinguished service to our country. I'll invite Joyce Reed, Azalea City Quilters, to come forward. I want to also welcome our recipients and special guests who you will hear more about in just a minute. One is Retired Air Force Colonel Brian Hastings, who is a member of the Governor's cabinet as the Director of the Emergency Management Agency (EMA). We know him well as he is a friend to Mobile County and he is one who supports our efforts here in times of emergencies. We are very grateful for all he has done. Not only has he served the country as a member of the military, but he continues to serve the

public with the job he is performing now. We also have the newly elected District 6 City of Mobile Council Member, Retired Army Lieutenant Colonel Scott Jones, who is receiving a quilt today. We are very happy to have him and his leadership on the City of Mobile City Council. We look forward very much to working with him. We thank you both for your military service and for your continued service to our local community and to state government. Thank you. Joyce Reed, Azalea City Quilters, I'll let you take it from here.

**Joyce Reed, Azalea City Quilters:** Thank you for inviting us. I brought my friend, Karen Gordon. She is also a veteran who served our country for many years. She retired from the military and then moved to the civilian life as a government employee. She has given back to the country in many ways.

I'm a member of the Azalea City Quilters guild and the National Quilts of Valor Foundation. Our guild is a non-profit organization involved in many community projects. About eight (8) years ago, we decided to join the national project known as Quilts of Valor. Our local group is called Stars Over Mobile. For many of us, Quilts of Valor is our form of national service. Back in the 1970's, a woman couldn't go overseas and fight for her country. We have chosen this method to give back. We give back to those who have given so much for the freedoms we enjoy. They allow us to continue to have the freedom to assemble, the freedom of speech, the freedom of religion, the right to bear arms, and many others. Many have always thought a quilt is a way to share a warm hug with a friend or family member. Today this warm hug comes in the form of a Quilt of Valor. It's for many whose service to this country frequently went unnoticed.

To give you a short history of the project, it began in 2003 because of a dream, literally a dream. Founder Catherine Roberts' son, Nat, was deployed in Iraq. In her dream, she saw a young man sitting on the edge of his bed in the middle of the night, hunched over, and seemingly in despair. In the next scene, she saw him wrapped in a quilt. His whole demeanor had changed to one of hope and well-being. The message she received was a quilt equaled healing. She began to plan and put together a volunteer team of friends who put together their time and materials to make a quilt. Some would quilt the fabric together and some would bind. From her home in Seaford, Delaware, the movement spread across the nation and beyond through the power of word of mouth and the internet. Soon she realized this project needed to be organized. In 2005, it became a non-profit foundation with a board of directors and volunteers. Each state has a coordinator and local chapters. The mission statement of the Quilts of Valor Foundation reads:

The purpose is to cover all service members and veterans touched by war with comforting and healing Quilts of Valor.

Those who served in wartime qualify, even if they were safely assigned in the United States. They are just as necessary for the functioning of all branches of the military as those who spent their time on the beaches of Normandy, France, in Vietnam, or in the Middle East. The first quilt was awarded to a young soldier at Walter Reed Army Medical Center who was from Wisconsin. He lost his leg. Quilts of Valor have been awarded to members of every branch of service and from every conflict. The Korean War veterans and the Vietnam veterans now stand tall with honor and are respected with recognition for their service and their sacrifice. They revealed something magical and healing is emitted from the folds of these quilts. The foundation reports weekly of the number of quilts awarded. The eleven thousand (11,000) chapters reported last week:

- 2,450 awarded quilts for November 2021
- 20,918 awarded quilts since January 2021
- 286,178 awarded quilts total since 2005

With Veteran's Day being this month, we will probably break the three thousand (3,000) mark before the end of the month. We did about fifty (50) in Mobile, Alabama last year. It was much slower than usual thanks to the Coronavirus Pandemic, but we are doing more now. Occasionally, we'll send a quilt across the country to a friend or family member who has served. Most of the ones we do will stay in Mobile, Alabama or at least the State of Alabama. We choose today to recognize two (2) of our local residents.

**Joyce Reed, Azalea City Quilters:** Retired Army Lieutenant Colonel Scott Jones enlisted in the United States Army in October 1988 as an infantryman and he was assigned to the 502nd Infantry Berlin Brigade upon completion of basic training in Airborne School. In July 1992, he completed the Reserve Officers' Training Corps (ROTC) at the University of South Alabama and was commissioned into the Air Defense Artillery (ADA). Immediately upon graduation, he was assigned to Air Defense Artillery Basic Officer Leader Course (ADA BOLC). He served as Vulcan, Stinger, and Scout Platoon Leader, as well as Executive Officer before being selected to attend flight school at Fort Rucker in Alabama. Upon completion of flight school, he was assigned to Camp Humphreys in South Korea as the Company Commander. His awards and

decorations include the Bronze Star with two (2) oak leaf clusters, the Defense Meritorious Service Medal, the Meritorious Service Medal with four (4) oak leaf clusters, the Iraq Campaign Medal with four (4) campaign stars, the Afghan Campaign Medal with two (2) campaign stars, the Army Commendation Medal, the Army Achievement Medal, the Army Occupation Medal, and the NATO Service ribbon. He was recently elected to serve in the City of Mobile City Council, District 6. He has served as program manager and defense analyst since his retirement. We would like to thank Retired Army Lieutenant Colonel Scott Jones for his service to our country and welcome him home with a great, big Quilts of Valor hug.

**Retired Army Lieutenant Colonel Scott Jones:** It's an eagle; my favorite.

**Joyce Reed:** Thank you again for your service.

**Scott Jones:** Thank you so much.

**Joyce Reed:** The quilt comes with a glorified pillow case or as we call it, a presentation case. You can store the quilt in that or you can use it as a pillow case along with the quilt.

**Commissioner Connie Hudson:** We have a Certificate of Award on behalf of the County Commission to give you in recognition of your service. We want to recognize everything you have done in being here and being a part of this Quilt of Valor ceremony.

**Scott Jones:** Thank you. I appreciate it. Thank y'all so much. This is such an honor. There are so many others that deserve these that did not make it back home. They are the true heroes. They will not be forgotten as long as we're here. I will accept this honor on behalf of them. Thank y'all for recognizing veterans. What a great city and great community to be a part of. Joyce Reed, Azalea City Quilters, thank you so much for what you do. It carries a lot of meaning and I appreciate you reaching out to me and to others who also receive a quilt. Thank y'all for what y'all do. What an exciting day.

**Joyce Reed, Azalea City Quilters:** Our next recipient is Retired Air Force Colonel Brian Hastings. His passion for service led him to enter the United States Air Force Academy in 1986 and serve in the United States Air Force from 1990 until he retired as a Colonel on September 1, 2017. Prior to his retirement, he served for two (2) years as Commandant of the Air Command and Staff College at Maxwell Air Force Base and previously served as the Commander of the 47th Flying Training Wing. His awards and decorations include two (2) Legion of Merit Medals, the Bronze Star, three (3) Meritorious Service Medals, and he served as a flight instructor. He was a command pilot with more than two thousand six hundred (2,600) hours in attack and training aircraft. He held a variety of positions, including Battalion Air Liaison Officer and Chief of Standardization and Evaluation. In August 2017, Alabama Governor Kay Ivey named him as the Director of the Alabama Emergency Management Agency. Today we thank him for his service and we welcome him home.

**Retired Air Force Colonel Brian Hastings:** It's beautiful. To the ladies of the Azalea City Quilters, thank you so much. Commissioners, thank you. When Commissioner Connie Hudson called, I thought it was Federal Emergency Management Agency (FEMA) or Alabama Emergency Management Agency (EMA) related or some other disaster.
