MOBILE COUNTY COMMISSION

The Mobile County Commission met in regular session in the Government Plaza Auditorium, in the City of Mobile, Alabama on Tuesday, October 12, 2021, at 9:30 A. M. The following members of the Commission were present: Connie Hudson, Vice-President and Randall Dueitt, Members. President Merceria Ludgood was absent. Also present were Glenn L. Hodge, County Administrator/Clerk of the Commission, Jay Ross, County Attorney, and W. Bryan Kegley II, County Engineer. Commissioner Hudson chaired the meeting.

Commissioner Connie Hudson: If you would please stand for the invocation. It'll be given today by Chaplain Phillip Snodgrass from the Mobile County Sheriff's Office. If you would, please remain standing for a moment of silence afterward for silent prayer. I would like for you to please remember Paul Sousa. That's a name a lot of people will remember. **MOBILE COUNTY RECOGNIZES DOMESTIC
VIOLENCE AWARENESS MONTH
OCTOBER 2021**

WHEREAS: For too long, domestic violence was a secret
kept in families. Today, we recognize that we all play a
significant role in helping to prevent and address domestic
violence and create a culture that refuses to tolerate
abuse; and,

WHEREAS: The problems of domestic violence are not
confined to any group or groups of people, but cut across
all economic, racial, and societal barriers and are
supported by societal indifferences; domestic violence can
result in injury, psychological trauma, and even death.
The devastating consequences of domestic violence can cross
generations and last a lifetime; and,

WHEREAS: The impact of domestic violence is wide
ranging, directly affecting individuals and society as a
whole, here in this community, through the United States,
and the world; and,

WHEREAS: In our area, the Domestic Violence Task
Force is a multidisciplinary team that works together to
help bridge the gaps and enhance services for victims of
domestic violence in our community; and,

WHEREAS: As a member of the Mobile County Domestic
Violence Task Force, Penelope House provides safety,
protection, and support to victims of Domestic Violence and
their children through the provision of shelter, advocacy,
and individual and community education. Last year, 252
adults and 273 children were sheltered in Penelope House,
despite a pandemic and two (2) hurricanes; and,

WHEREAS: Ending domestic violence requires not only
the resolve and courage of survivors, but also the support
and involvement of all of us;
