MOBILE COUNTY COMMISSION

The Mobile County Commission met in regular session in the Government Plaza Auditorium, in the City of Mobile, Alabama, on Monday, January 22, 2018, at 10:00 A. M. The following members of the Commission were present: Merceria Ludgood, President, Connie Hudson and Jerry L. Carl, Members. Also present were John F. Pafenbach, County Administrator/Clerk of the Commission, Jay Ross, County Attorney, and W. Bryan Kegley II, Assistant County Engineer. President Ludgood chaired the meeting.

INVOCATION

The invocation was given by Reverend Loren D. Scott, Christian Benevolent Funeral Home, Inc., 201 Hamilton Street, Mobile, Alabama.

Engineering Manager-Development Matthew Barclift:

Good morning, Commissioners. I would like to give thanks to Eddie Kerr and Tina Sanchez of the Environmental Services Department; Katherine Eddy, Director of Public Affairs; and our entire Geographic Information System (GIS) Department. It was a team effort to ensure that the imagery and other map information displayed accurately in our Geographic Information System (GIS), and that our citizens could generate maps and perform queries. Federal Emergency Management Agency (FEMA) will have one (1) community-wide meeting, and it is scheduled March 8, 2018. Following the Federal Emergency Management Agency (FEMA) community-wide meeting, we will advertise the proposed Flood Elevation Determinations in the local newspaper twice during a ten (10) day period and that will initiate the ninety (90) day appeal and comment period. During the ninety (90) day appeal and comment period, the Federal Emergency Management Agency (FEMA) will relay all property owners who filed objections relating to changes in the Base Flood Elevation Determinations to our office. We will look at them, evaluate them and pass along the ones that have merit. The appeal resolution period is anticipated to begin in August 2018, so after the ninety (90) day period, the Federal Emergency Management Agency (FEMA) will begin looking at it and hopes to have all the appeals resolved in Winter 2019. At that time, the Federal Emergency Management Agency (FEMA) will issue a letter of the final Base Flood Elevation Determinations, and that will set the new effective date for the maps. It will also start a six (6) month community compliance period. During that six (6) month compliance period, we are expected to adopt the new flood maps, update our Flood Damage

Prevention Ordinance, and incorporate those new flood maps. The end of the community compliance period and the new Flood Insurance Rate Maps are projected to be in effect in the Summer of 2019. Our plan is to develop informational flyers and list some frequently asked questions. We will post them on our website and put them out through social media. We have created a dedicated e-mail address, floods@mobilecounty.net, for our citizens to send their queries, and we will respond to them on an individual basis. Our Information Geographic System (GIS) Department has worked very hard to identify fourteen thousand (14,000) parcels that are in the areas affected and could be impacted by the changes in the Base Flood Elevation Determinations. We intend to send out a mass mailer to those individuals inviting them to come to our community meetings. Finally, we have tentatively scheduled five (5) local community meetings between the end of Mardi Gras and before the community-wide meeting. We have targeted areas that are highly impacted such as the Town of Dauphin Island, the City of Bayou La Batre, the Fowl River area, the Hollingers Island area, the City of Saraland, the Town of Creola, and the City of Semmes. The tentative dates are February 15, 2018, February 20, 2018, February 22, 2018, February 27, 2018, and March 6, 2018. That will give our citizens a chance to talk with us before attending the Federal Emergency Management Agency (FEMA) community-wide meeting.

Commissioner Connie Hudson: Are those meetings in different locations on those dates?

Engineering-Development Manager Barclift: Yes, ma'am.
I will get you a complete list of the schedule.

Commission President Merceria Ludgood: I need to know the dates for the meetings in the City of Saraland and the Town of Creola because on some of those dates, I know I will be out of town.

Engineering-Development Manager Barclift: Yes, ma'am. I will get you that information. We are working still on locking down the locations for some of them, so those dates are tentative until we get the locations locked in. Finally, the citizens who are applying for permits and see they are going to be impacted by the flood map changes, we are going to take that opportunity to counsel them and get them an informational sheet that tells them what are the specific property changes so that they can make any appropriate changes.

Commissioner Hudson: Matthew, at the Federal Emergency Management Agency (FEMA) meeting, there was some discussion about the elevation certificates and being proactive in getting them, is that something that will be discussed at the meetings?

Engineering-Development Manager Barclift: Yes, ma'am.

Commissioner Hudson: Will people be encouraged to go ahead and do that in advance?

Engineering-Development Manager Barclift: The elevation certificates tend to be a property specific thing. If you are being mapped into the flood zone, you absolutely need to go and get an elevation certificate because that would document where you were before the map changed. If your Base Flood Elevation is not changed, there is no reason to get an elevation certificate.

Commissioner Hudson: It is just for those people who were not in the floodplain, and now are because the Base Flood Elevation changed, is that correct?

Engineering-Development Manager Barclift: It is most
critical for those who are being mapped into a flood zone
area.

Commissioner Hudson: We can identify those particular ones and target them to go ahead and do this in advance.

Engineering-Development Manager Barclift: Yes, ma'am.

Commissioner Jerry L. Carl: We all attended a meeting on this last week or the week before last. I want to make sure the media understands, we, the County have very little input. The Federal Emergency Management Agency (FEMA) is dictating this, and they are driving it. They are giving a ninety (90) day window to respond, and truly the only way you can respond is with documentation to back up what you are asking. Therefore, you are going to have to hire an engineer or someone to do those studies for you in a ninety (90) day period which is unheard of. I think, it is very unfair to our citizens, but it is what it is, and we are going to have to deal with it.

Engineering-Development Manager Barclift: They will
have to prove it scientifically or technically.

Commissioner Carl: I understand, they have raised the rates to thirteen percent (13%) per year until they get it up to what they consider to be the correct rate.

Engineering-Development Manager Barclift: We are encouraging people to speak with their insurance agents to find out specifically about the rate increase. The Biggert-Waters Flood Reform Act changed the grandfathering for properties that are mapped into a flood zone and so it is different for different parcels, but I think, the maximum increase is eighteen percent (18%) per year.

Commissioner Carl: Per year, that's the tier.

Engineering-Development Manager Barclift: Per year until you reach the appropriate actuarial rate, but we are not the insurance agents, so we are encouraging people strongly to speak with their insurance agent. They can talk to us first to get the information they need, and then speak with their insurance agent.

Commissioner Carl: Which County website will this be on?

Engineering-Development Manager Barclift: This will
be on mobilecountyal.gov.

Public Affairs Director Katherine Eddy: We will put
it on social media and also do a media blast.

Public Affairs Director Eddy: If I may reiterate, we will send mailings to those fourteen (14) thousand properties. They will get a piece of mail that will notify them of all the County meetings so if they cannot attend one in their area; maybe they can make the meeting in another area.

Commissioner Carl: Thank you.

Commissioner Hudson: Thank you, Matthew, very good.

Commission President Ludgood: Matthew, you said something that mentioned a role for us in the appeal process, can you go over that again.

Engineering-Development Manager Barclift: The Office of Water Resources, the Federal Emergency Management Agency (FEMA) and their consultants will route the appeals through us first. They want local communities officials to review the information before it is passed on to them. It does not mean citizens cannot submit their documents directly to them, but they indicated in the meeting that they are going to route them to us.

Commissioner Hudson: They have set certain criteria that we have to go by, and if it does not meet that certain criteria, then they will not consider it.

Engineering-Development Manager Barclift: Yes, ma'am.

Commissioner Carl: They are going to make us the bad guy.

Commission President Ludgood: They have interposed us as a kind of first resort for appeals.

Commissioner Hudson: It has to go through us.

Engineering-Development Manager Barclift: Yes, ma'am.

Commissioner Hudson: We have to use their criteria.

Engineering-Development Manager Barclift: We are the boots on the ground, the local enforcement authority. They have hired the consultants, and the consultants have done the research, but we have to enforce it.

Commissioner Hudson: Each municipality does its own,
we just do the unincorporated areas.

Engineering-Development Manager Barclift: Yes, we
will only be doing the unincorporated areas.

Commission President Ludgood: Do you have any idea if the smaller municipalities have the capacity to do that? Are they staffed to do that? Are we staffed to do that?

Engineering-Development Manager Barclift: We have enough staff to review them adequately. Some of the smaller municipalities may need some help. The Town of Mount Vernon and some of the other municipalities are not impacted with significant changes to their maps. The focus seems to be particularly on the coastal areas which impact us heavily, and also the City of Bayou La Batre. I am not sure if the City of Bayou La Batre has the resources or not.

Commissioner Hudson: As Commissioner Carl said, some of what they are requiring is documentation and surveyor maps. Those are the sort of things our citizens will be responsible for turning in with their appeal to have it considered.

Commissioner Carl: What will happen is that they will launch a complaint, it is going to come to us, and we are going to tell them, we cannot pass it on because it does not have proper documentation. The Federal Emergency Management Agency (FEMA) has made us the bad guy.

Commissioner Hudson: It is more likely that scenario is a problem going to happen, I'm afraid.

Commission President Ludgood: We can pass it on and say this looks like a good appeal and it will work a hardship to this affected person if they are not given a fair hearing. We may have to push back on this because that is really not fair.

Commissioner Hudson: I agree. We brought that up at the meeting, but apparently, it is the way it is. That is the way it has been designed by the Federal Emergency Management Agency (FEMA). I do not know what they will do with any kind of appeal without the proper documentation.

Commissioner Carl: How long has the Federal Emergency Management Agency (FEMA) worked on those maps?

Engineering-Development Manager Barclift: They have
worked on them for a couple of years at least.

Commissioner Carl: How long do we have to respond?

Engineering-Development Manager Barclift: Ninety (90)
days.

Commissioner Carl: That sounds fair to me, doesn't
it?

Commission President Ludgood: You know we have our Gulf States Counties and Parishes Task Force in the National Association of Counties (NACo), maybe we can see what other people are doing. There could be some kind of coordinated approach or they may have some guidance that might be useful to us.

Commissioner Carl: Good idea.

Engineering-Development Manager Barclift: That will
be greatly appreciated.

Commission President Ludgood: Okay, thank you.

Commissioner Hudson: Thank you.

Commissioner Carl: Thank you, Matthew.

Commissioner Jerry L. Carl: I would like to publicly give thanks to our Road and Bridge Department for the excellent job they did during this last little ice storm. People do not appreciate our guys and ladies in the field, so, thank you.

Commission President Merceria Ludgood: John, I talked to Council Member Manzie, and he is requesting an accommodation that will allow him in his wheelchair to be able to get up here.

County Administrator John Pafenbach: Yes, ma'am.

Commission President Ludgood: So, are we going to get one of those portable ramps?

County Administrator Pafenbach: Well, the challenge we have Commissioner, as I understand it, after talking with Tyler and Martha, is the stairway. The slope is such that it does not meet the code, and I think the same is true for this and the other stairway. However, he can go down to the basement elevator lobby, go around, all the way around and he will come out at this door just to Commissioner Hudson's left and he will only need help with those two (2) steps.

Commission President Ludgood: Okay, what we need is that portable ramp to get him up here because last week he had to stay down there and he would like to be up here.

County Administrator Pafenbach: Yes, ma'am.

Commission President Ludgood: So, I guess my question is, are we looking at doing that?

County Administrator Pafenbach: Yes, ma'am. I have to make sure there is enough space. The slope is a one-inch drop and rise every foot.

Commission President Ludgood: This is not a permanent
ramp.

County Administrator Pafenbach: No ma'am, I
understand.

Commission President Ludgood: Okay, so, we will have that by tomorrow when they meet?

County Administrator Pafenbach: I will do my best, yes, ma'am. We just found out about this on Friday, Commissioner.

Commission President Ludgood: I understand.

County Administrator Pafenbach: We will do our best to work with you.

Commission President Ludgood: Okay.

County Administrator Pafenbach: Yes, ma'am.

Commissioner Jerry L. Carl: On Saturday, we had our first meet and greet with Walmart at Bryant High School. Roughly, two thousand (2,000) plus applicants showed up, and they got to see the job opportunities, I was stunned. I went with the first group, and the starting wages were \$15.50 per hour. I think, our Sheriff's Deputies, start at \$16.40 per hour. Next weekend, we are going to be at

Theodore High School, and the weekend after that, we will be at Bishop State Main Campus. I encourage everyone to go, but not County employees. Things are really looking good, and we are very proud of that.

Commission President Merceria Ludgood: We have a clean sweep this weekend for District 1 at the Old Acordis Site beginning 7:00 A.M. Mr. Mack, we would really appreciate it if you would include that in your report on the County Commission in a prominent way. We had a really good response when we did it the last time, and some calls have been coming in, so we are hoping that we are able to have the same kind of turn out as we had last time. Thank you.
