The Mobile County Commission met in regular session in the Government Plaza Auditorium, in the City of Mobile, Alabama, on Monday, January 23, 2017, at 10:00 A. M. The following members of the Commission were present: Merceria Ludgood, President, Connie Hudson and Jerry L. Carl, Members. Also present were John F. Pafenbach, County Administrator/Clerk of the Commission, Jay Ross, County Attorney, and W. Bryan Kegley II, Assistant County Engineer. President Ludgood chaired the meeting.

PRESENT RESOLUTION/45TH YEAR ANNIVERSARY
OF SENIOR CITIZENS SERVICES, INC./VIA
HEALTH, FITNESS AND ENRICHMENT CENTER

WHEREAS, Senior Citizens Services, Inc. began operations forty-five (45) years ago in a renovated gas station on the corner of Springhill and Bay Shore Avenues; and

WHEREAS, Senior Citizens Services, Inc. was one of the first five (5) senior programs in the state funded by the Older Americans Act; and

WHEREAS, Senior Citizens Services, Inc. was founded by a diverse group of individuals, led by its first Executive Director Mary Abbie Berg, to respond to the needs of seniors, helping them to live independently, in their own neighborhoods, with access to the resources they need; and

WHEREAS, in 1990, the Ahavas Chesed Synagogue moved to a new location and provided the organization with a building to renovate to provide a Center for our senior adults; and

WHEREAS, Senior Citizens Services, Inc. currently operates the Via Health, Fitness and Enrichment Center, a 42,000 square foot multi-purpose community-based center with fitness center, gymnasium, café, auditorium, computer lab, library, card rooms, and arts and ceramics studios; and

WHEREAS, the Via Center Health, Fitness and Enrichment Center has been an integral part of this community, providing health, fitness and enrichment programs and community needs outreach services, such as an adult daycare, an emergency food pantry, Veterans' activities, Mobile Housing Board senior outreach programs, information and referral, to more than 20,000 members and users annually; and

WHEREAS, the Via Health, Fitness and Enrichment Center will continue to promote a healthy, active, independent lifestyle among older adults, advocating, teaching, and leading health and safety-related aging programs and initiatives for the surrounding community;

Commissioner Connie Hudson: We are very pleased to welcome a group of Mobile County BEST and brightest young people to our meeting this morning. When I say BEST, I mean it literally, BEST is the acronym for Boosting Engineering, Science, and Technology. We are very proud of our young people who have done exceptionally well. On your way into the Auditorium, you may have noticed a few robots outside in the Atrium; the young people wanted to show us what they have accomplished over the last several months under the direction of Robin Fenton, Hub Director.

Robin Fenton, Jubilee BEST Hub Director: Forty (40) middle and high schools from the Gulf Coast competed in Jubilee BEST Robotics Competition at the University of South Alabama Mitchell Center, and seven (7) of our schools advanced to the South's BEST Regional Championship at Auburn University to compete against schools from Alabama, Mississippi, Florida, Tennessee, and Georgia. I am proud to say that our local schools brought a lot of awards back to Mobile County. The Davidson High School was the Winning Champion of fifty-eight (58) schools in the South's BEST Regional Championship. In addition, they brought home Third Place South's BEST Video Award, Second Place South's BEST Computer Beta Design Award, Second Place South's BEST Most Robust Robot Award, and First Place South's BEST Software Design Simulink Award. Great job, Davidson High School. In 2016, Davidson High School won first place for the State of Alabama that earned them a trip to go to the White House and be recognized by the President of the United States for their accomplishments. St. Luke's

Episcopal School was awarded First Place South's BEST Exhibit Booth and Interview Award, First Place South's Best Hyundai Exhibit Booth Design and Construction Award, First Place South's BEST Webpage Award. St. Luke's Episcopal School placed Fifth Place overall the entire competition. Faith Academy brought home proudly the Second Place South's BEST Spirit and Sportsmanship Award. St. Vincent de Paul Catholic School brought home First Place South's BEST T-Shirt and Team Wear Award, and in 2013, they were the First Place South's BEST Robot Winner that earned them a spot to the White House. Finishing in the Top 20 Robots were MACH Robotics, Saraland Middle School, and Talladega Career Tech. We thank you, Commissioners, for all of your support, we could not have done all of this without your help. Jubilee BEST Robotics is a non-profit organization that is 100% volunteer driven. Jubilee BEST not only hosts the largest BEST competition in the nation but engages business, industry, higher education, and community stakeholders to become involved by serving as volunteers, mentors, judges, and sponsors. After the Commission meeting, the students and their robots will be running around the Atrium, and everyone is invited to join us.

Commissioner Hudson: Congratulations, keep up the great work.

PRESENTATION/ORGANIZATIONAL RESTRUCTURING
PROPOSAL/COMMISSIONER JERRY L. CARL-DISTRICT 3

Commission President Merceria Ludgood: At this time, the Chair recognizes Commissioner Carl for a presentation.

Commissioner Jerry L. Carl: Most of you are probably unaware that the County Commissioners cannot have these types of conversations, one on one, and we certainly cannot have them among the three of us without being in a public setting. Commissioners, thank you for giving me the opportunity to show my presentation. Some of the ideas for my organizational restructuring proposal are from discussions I have had with several County employees. The Commission has put off finding a County Engineer replacement for various reasons and because of my concern, I wanted to kick it off with my organizational restructuring proposal. We have an attitude in Mobile County that is called the Silo Mentality, which is a mindset that occurs in organizations with departments or groups of individuals who do not wish to share information and resources with other individuals or departments within the same organization. This is a fundamental problem of human nature, it is not a design choice, it is just human nature. One of the direct consequence of the Silo effect

is the shut down of communication. I have described below a few examples:

- The County Engineering Department has installed a new telephone system located in this very building that does not work with any other County telephone system outside of the Engineering Department. We, the Commissioners, are in the same building as the Engineering Department, but to call an Engineering staff member on the telephone, we must dial an outside line. Their telephone system causes an adverse effect that shuts down the direct line of communication. We should all be able to talk on the same telephone system.
- The lack of accountability is something we get hit with every day when we get a telephone call related to roads. I have a hard time getting questions answered because I do not know where to start or whom to talk to about it.
- A decrease in collaborative efforts is due to the Silo Mentality management style. County employees work in fear, so they are saying nothing. I am in the field a lot trying to talk with employees, and when I ask them about simple things, the first thing that comes out of their mouths is that they are afraid to say anything. The Silo Mentality management style make our employees feel like they cannot be heard so therefore, they are intimidated, and that shuts down the line of communication.
- A duplication of services occurs in the Engineering Department as we know it now. They have their own IT Department, their own Payroll Department, their own Human Resources, and multiple radio systems. All this is duplicated within one (1) department. It is a waste of time and resources to have multiple telephone systems, multiple IT staff in the same building working for different departments, and multiple Human Resources people working for different departments. I have spent the last two (2) years arguing over unneeded multiple radio towers.

Commissioner Carl: This is where the lack of communication really gets us down in the dirt and decreases employees' morale. The largest reason we are losing employees is because of stagnancy. They feel they cannot grow as an employee causing them not to move a notch in trying to reach a pay raise through their efforts. Therefore, they are holding themselves back, and the only way some of them see any form of advancement is through the pay raise we give them every year. The management style we have right now is four (4) departments within one (1) department: County Engineering, Public Works, Facility

Engineering and Environmental Engineering. Let us look at a more advanced management style of taking the same employees and splitting them up into five (5) segments. There would be five (5) different segments answerable to the Commission. The way it is set up now, we basically deal with two (2) to three (3) employees at the most, when in fact, we should be dealing with at least four (4) to five (5) employees. I propose the following organizational restructuring:

Today, the three (3) of us have the opportunity of a century to change this Silo Mentality. We can come up with something we all three (3) can agree on that will better serve our employees which is one of our jobs and the taxpayers which is our other job. Our job is to motivate our employees to do better to do more, to want to make more money, to be able to go home and face their families and be proud of who they are and what they do. I take pride in that. I did it in my personal businesses, and I also do it in County business, but we also have to be good managers of the County's tax dollars. I think we do the best we can do. I think the three (3) of us try very hard and if we face the facts, we could get out of this Silo Mentality.

Commission President Ludgood: All of the recommendations included in your presentation I am assuming will become part of the work our consultant is going to do along with other facts that will be gathered. I appreciate the time you put into this, and I think it is safe to say that all of us have been preaching as long as we have been on this Commission that we are one body, and may be we do not always function that way, but I know that all of us aspire to do so.
