MOBILE COUNTY COMMISSION

The Mobile County Commission met in regular session in the Government Plaza Auditorium, in the City of Mobile, Alabama, on Monday, November 27, 2017, at 10:00 o'clock, a.m., Central Time. The following members of the Commission were:

Commissioner Ludgood acted as chairman of the meeting and John Pafenbach, Administrator and Clerk of the Commission, acted as clerk of the meeting. The Chairman stated that due notice of the time, place and purpose of the meeting having been posted as required by law, and a quorum being present, the meeting was open for the transaction of business.

INVOCATION

The invocation was given by Reverend Leroy Lampkin, Pastor of Berean Baptist Church, 3709 Alba Club Road, Mobile, Alabama.

**Tuerk Schlesinger, Chief Executive Officer, AltaPointe Health Systems, Inc.:** Good morning, Commissioners. Thank you very much for the opportunity to address you about the mental health situation in our community. The AltaPointe Health Systems, Inc. is a public mental health center that represents mental health care in our community in the same way public health represents health care in our community. Today, I want to remind the Commission that AltaPointe Health Systems, Inc. is here to do two (2) things as a Mental Health Board. First, to make the Commission aware of any kind of serious problems going on in our community when it involves mental health. Second, is to let the Commission know what AltaPointe Health Systems, Inc.'s position is, and that is to try to help our community solve those kinds of issues. The Mobile Infirmary closed its general psychiatric unit last week. They closed seventeen (17) acute adults' psychiatric hospital beds; they moved nine (9) of those seventeen (17) acute adults' psychiatric hospital beds into their geriatric unit and moved the other eight (8) beds to the North Baldwin Infirmary. It left a void, and that void must be filled to ensure people who are

experiencing mental health crisis may receive care. Mobile Infirmary was the sole service acute care hospital for providing inpatient psychiatric care for adults. The AltaPointe Health Systems, Inc. and the EastPointe Hospital provide evaluation services for Probate Court and care for those who are involuntarily committed. The EastPointe Hospital has limited capacity for serving voluntary psychiatric patients, and as a freestanding psychiatric hospital, we are not allowed to bill Medicaid. Approximately one-third (1/3) of all our patients are Medicaid recipients, but federal law, the Institution for Mental Disease (IMD) Exclusion, bars federal Medicaid funds to facilities with more than sixteen (16) beds. We are concerned about the psychiatric patients who have comorbid conditions which is a patient with a psychiatric condition and a medical condition at the same time. They really need to be served in an acute care hospital. The AltaPointe Health Systems, Inc. does not have the level of medical care in its hospital as an acute care hospital. Only acute care hospitals are reimbursed by Medicaid which is one of the primary funding sources for inpatient mental health care. The AltaPointe Health Systems, Inc. has continuously been a component for adding general acute psychiatric beds in our region. We have constantly talked to other psychiatric hospital providers urging them to open new adult psychiatric beds such as Providence Hospital, Springhill Medical Center, University of South Alabama Health System, Thomas Hospital, South Baldwin Regional Medical Center, and North Baldwin Infirmary. The reimbursement of those beds is not doable for some of those hospitals because the amount of indigent care associated with mentally ill patients is very high. The AltaPointe Health Systems, Inc. is the largest mental health care provider in Alabama, and our continuous care often begins in the emergency department of one of Mobile's acute care hospitals. We have provided services to twenty-one thousand one hundred twenty (21,120) active patients in Mobile County, and Baldwin County has provided services to eight thousand one hundred ten (8,110) active patients. The AltaPointe Health Systems, Inc. has sixteen (16) local outpatient offices that serve children and adults. We have twenty-six (26) group homes, two hundred forty-five (245) beds for psychiatric adults, one hundred eighty-five (185) beds in semi-independent apartment type facilities, a 24-hour crisis response team, a special jail diversion program, a one hundred (100) bed psychiatric hospital for children called BayPointe Hospital, an eighty-two (82) bed hospital for adults called EastPointe Hospital, and a sixteen (16) bed facility called Subacute Care. The AltaPointe Health Systems, Inc. does psychiatric consultations in five (5) of the acute care hospitals in our region. For example, if a patient is in the emergency room (ER) or in the Intensive Care Unit (ICU) with an overdose situation, we have doctors there every day of the week who can do consultations with those patients to help

stabilize them and find a place for them to go for further psychiatric care. Those hospitals are Providence Hospital, Springhill Medical Center, University of South Alabama Health System, Thomas Hospital, and Washington County Hospital. The AltaPointe Health Systems, Inc. is currently working towards starting a new consultation service with the South Baldwin Regional Medical Center. The only one we do not have are Mobile Infirmary, but we have been in discussions with them since they closed their unit and North Baldwin Infirmary. The closing of the adult psychiatric unit, at Mobile Infirmary has resulted in a community crisis for hospitalization of a person in psychiatric distress. The local first responders share our concern. The AltaPointe Health Systems, Inc. anticipates psychiatric patients will be present in emergency departments throughout our community. We are prepared to partner with all area hospitals to provide psychiatric consultations in emergency departments to facilitate appropriate placement for those patients who are most in need. The AltaPointe Health Systems, Inc. is our safety net that is why we are here. We were not in the hospital business at all because we were a community mental health center. The County Commission approached me back in 1999 and 2000, and the City Council approached me at the same time. They asked us to go into the hospital business because, in the 1990s, two hundred seventy-seven (277) hospital beds for mentally ill patients were closed in Mobile and Baldwin Counties leaving only Mobile Infirmary. At that time they had thirty-four (34) beds; seventeen (17) for geriatrics and seventeen (17) for the general population. The AltaPointe Health Systems, Inc. came in and opened BayPointe Hospital and then, EastPointe Hospital. We are the safety net, and we have strategically tried to build a traditional system of care designed specifically for serving the underserved populations. An inadequate response to inpatient psychiatric needs will strain other community resources including the Metro Jail, Probate Court, emergency departments of all of our hospitals; it is a huge concern in our community. I do want to add one other thing because there has been some discussion about reopening Searcy Hospital. We need to remember Searcy Hospital did not have the kind of beds we are losing in Mobile; Searcy Hospital was only for committed patients, we are losing acute care hospital beds for patients voluntarily seeking treatment. So reopening Searcy Hospital is not the answer and I do want the community to understand that. Are there any questions I may answer?

**Commissioner Connie Hudson:** We are experiencing a crisis in psychiatric care in this community with the closing of those inpatient acute care beds. What are the options at this point, I mean what happens to these patients, the voluntary patients?

**Mr. Schlesinger:** Our current options are on a patient needs treatment. If they are already in AltaPointe system, we will work with our access-to-care department to go ahead and place them in our hospital if we have a bed available. Currently, our adult hospital is full, and it stays full. We have sixteen (16) beds in our hospital that are not open due to sheer cost. Only twenty-one percent (21%) of our patients have a paying source.

**Commissioner Jerry L. Carl:** Can you repeat that?

**Mr. Schlesinger:** Only twenty-one percent (21%) of our patients have a paying source who we are able to bill. The other seventy-nine percent (79%) are Medicaid patients whom we cannot bill or indigent care who are not able to pay or do not have insurance. Our options right now are for us to continue to use ours as much as possible or send our patients out to places like Dothan, Montgomery, mostly Birmingham that have the most acute beds, but they stay relatively full also. We know that if there was funding for this population, we would certainly be able to open up more beds for a regional approach. We currently are partners with all of the acute care hospitals. We do not have enough beds to make up for the loss of those seventeen (17) beds.

**Commissioner Hudson:** So the issue with mental health facilities like AltaPointe in being able to add additional beds, is basically the fact that only twenty-one percent (21%) of patients are able to pay and the rest are indigent.

**Mr. Schlesinger:** That is correct.

**Commissioner Hudson:** So it is cost prohibited basically for an institution other than an acute care inpatient facility because they are the ones receiving the Medicaid, correct?

**Mr. Schlesinger:** That is correct, and for us to try to open up more beds without any funding only jeopardizes our ability to stay in business.

**Commissioner Hudson:** If someone else came to town and opened a facility like AltaPointe, will it be the same situation, twenty-one percent (21%)?

**Mr. Schlesinger:** We would be splitting the twenty-one percent (21%); so we will probably have ten percent (10%), and they would have ten percent (10%). Without that twenty-one percent (21%) our hospital cannot make it either. This is a safety net issue we want to keep AltaPointe Health Systems, Inc. up and running so we can take as many patients as possible I do not want to put that hospital in any risk of having to close. The real answer

will be for one of the acute care hospitals or the majority of the acute care hospitals to open up general psychiatric beds since they are the ones who get reimbursed for it.

**Commissioner Carl:** Obviously, there is no profit.

**Mr. Schlesinger:** At EastPointe Hospital there is never a profit.

**Commissioner Carl:** I was talking about hospitals, in general, getting behind the psychiatric care business.

**Mr. Schlesinger:** Oh no, obviously, you can see this is not something people are lined up to get in.

**Commission President Merceria Ludgood:** As I listened, I didn't realize that you couldn't bill for Medicaid.

**Mr. Schlesinger:** We can bill only for the children on the hospital side, but for adults twenty-one (21) to sixty-five (65) years old we cannot bill.

**Commission President Ludgood:** So the only real source we have for funding hospitals is our Indigent Care Funds. Right now, my guess, which I don't even know if we have the latitude to decide if we could prioritize this in a way that it might be an incentive for some acute care hospitals to get back in the business. We may just have to consider looking at that as one of our options and let somebody sue us and then find out we can't do it, maybe we can work this problem out. Even with those beds, we still have a large number of people walking around and not getting the services. They are just are walking up and down the streets, in the malls, downtown Mobile and in Bienville Square. It is a growing problem, not a shrinking problem.

**Mr. Schlesinger:** The federal government and different federal lawsuits have already discussed people's right to be free of institutionalization. We are seeing people who are mentally ill that have the right to seek treatment or not to seek treatment. The more significant part of our problem is that we have a lot of patients throughout this country do not seek treatment as their choice. Our only choice for those who do not seek treatment is to file an involuntary action against them to put them into a mental care facility. We basically have three (3) segments of our population: individuals who will seek treatment when they need it, individuals who will not seek treatment, and individuals who are involuntarily put through the process. We continuously struggle with those people that we see on the streets who are not voluntarily seeking treatment.

**Commissioner Hudson:** I really see this as much bigger than a local problem. This is a problem we need our Legislature to step in and help us address. Obviously,

this is not the only community where a crisis is happening of this nature. Hospitals all across the state are finding it untenable to continue with psychiatric services. I really think this should be a major focus for our Legislature and I know we have a meeting coming up with our local delegation, we need to address them about this. There needs to be funding for this, and with our little Indigent Care Fund, we were finally able to resolve the allocations that are not enough to address the current problem of the indigent care condition in addition to psychiatric services. I think we just need help, and they need to step forward and figure out a way to help solve this problem.

**Commission President Ludgood:** Am I correct in saying, the state mental health budget continues to shrink, shrink, and shrink?

**Mr. Schlesinger:** Correct. We have seen the closure of Searcy Hospital, the downsizing of Bryce Hospital in Tuscaloosa, the closure of Greil Memorial Psychiatric Hospital in Montgomery, the closure of North Alabama Regional Hospital in Decatur, and the closure of Eufaula Hospital for Children in East Alabama. What happened was back in 2007 or 2008, thirty-five million dollars (\$35,000,000.00) to forty million dollars (\$40,000,000.00) of the mental health budget was cut out of the General Fund. That is when those closures started. Simultaneously federal lawsuits filed in Georgia and in Alabama mandating the institutionalization of inpatient stay. All of those issues are what have led to this problem. The real problem in Alabama is that we have the strictest Medicaid eligibility requirement, so we have the least people on Medicaid of any state per capita. We have a tremendous amount of indigent care, uninsured people with no insurance. Not even with the Affordable Care Act were people insured who have mental health problems.

**Commission President Ludgood:** Thank you very much.

**Commissioner Hudson:** Thank you for sharing with us, and this is a problem that we are all going to have to work together to address. We appreciate you giving us this information.

**Mr. Schlesinger:** Thank y'all for your time.

**Commissioner Connie Hudson:** Good morning, our resolution is for Dr. Jennifer Lyn Knizley, and it reads:

**WHEREAS**, Dr. Knizley who has served for the past three (3) years as the veterinarian at the Mobile County Animal Shelter was the first contract Veterinarian in a shelter in the State of Alabama. For more than a decade she has provided health services to animals in both the private and public sector. We take this moment to acknowledge and commend Dr. Knizley for her outstanding, dedication, leadership and commitment to Mobile County; and

**WHEREAS**, during her tenure with the Mobile County Animal Shelter Dr. Knizley has been instrumental in developing the plan for spay neuter procedures to be performed on all adopted animals. She has been the force behind the development and promotion of several programs to improve the quality of life for animals and residents alike in Mobile County; and

**WHEREAS**, among her several noteworthy accomplishments are assisting the Mobile County Animal Shelter in the cruelty to animals cases serving as an expert witness for multiple cases throughout the years, establishing vendor's accounts, and earning discounts for the Mobile County Animal Shelter programs. She has devoted much of her time, training, and talents to the Mobile County Animal Shelter which in turn led the Mobile County Animal Shelter to be recognized as one of the premier animal control shelters in the State of Alabama and across the Gulf Coast; and

**WHEREAS**, Dr. Knizley has earned the respect and gratitude of her colleagues and local leaders, as well as the public at large for her willingness to help others and her adherence to the highest standards of ethical conduct and her steadfast devotion to the betterment of Mobile County;

**NOW, THEREFORE, LET IT BE RESOLVED:** The Mobile County Commission wishes to commend Dr. Jennifer Knizley on her extraordinary professional achievement on the occasion of her departure as a Veterinarian of the Mobile County Animal Shelter, and by a copy of this resolution, we convey our gratitude. Furthermore, we extend our heartfelt best wishes to her and all her future endeavors.

**Dr. Jennifer Lyn Knizley:** Thank you very much and I was not prepared for a speech, but I have really enjoyed my time as being the animal shelter's veterinarian in Mobile County. It has been a pure joy to watch it grow. I actually started volunteering at the animal shelter in 2007, so I got to see the transition into the new building. It has been my pleasure. I hope to be still involved on some level as long as the Mobile County Animal Shelter is around.

**Environmental Services Director G. William Melton:** Commissioners, you asked that I give you an update on the Gulf of Mexico Energy Security Act (GOMESA) Program two (2) weeks ago. The states of Alabama, Louisiana, Mississippi and Texas will share in the royalties, rents, bonuses, leases, and the other instruments that produce these offshore oil and gas funds. There is a big risk for these coastal states, counties and parishes and there is a lot of opportunity to use this money to protect the coast. The coast is a valuable resource to Alabama and the same for these other states. There is a risk and there is a need to protect our resources in our coasts and it is evident from the number of oil rigs in the Gulf of Mexico. There are more oil rigs in the Gulf of Mexico than in any other body of water around the United States. What I want to do today is to give you a brief background of what the authorized uses are for ongoing projects, what the use of these funds are and a little bit about future planning for the program. As you may recall, the Gulf of Mexico Energy Security Act (GOMESA) funds are from the Outer Continental Shelf oil and gas revenues. These four (4) states and the coastal political subdivisions will share a cap of three hundred seventy-five million dollars (\$375,000,000.00) per year. This federal rule is public law and is published in the Federal Register, it is not the Code of Federal Regulation, but a federal rule. Revenues are administered and collected by the Office of Natural Resources Revenue and the monies that are received on Phase II started in FY17, and we are told by the federal administrators that we may not reach that cap. However, those revenues should come to the County around April 2018. About a year ago, a

federal administrator came and gave us a presentation, and at that presentation, they shared these numbers with us. We saw if the three hundred seventy-five million dollar (\$375,000,000.00) cap was met, the State of Alabama would receive around forty-five million dollars (\$45,000,000.00), Mobile County around six million dollars (\$6,000,000.00), and Baldwin County around five million dollars (\$5,000,000.00), if the cap was met. These numbers are from the Office of Revenue. The authorized uses of these funds are just like the Coastal Impact Assistance Program (CIAP) with a slight deviation. The authorized uses include coastal protection in terms of conservation, restoration and hurricane protection. We appreciate what Commissioner Hudson has done in trying to get some clarification on what hurricane protection means. So many problems are bigger than us, and we need some help from the Legislature to keep this money here in Mobile. Another authorized use is mitigation of damage to fish, wildlife, or natural resources and implementation of a federally-approved marine, coastal, or conservation management plan such as the plan of the National Estuary Program (NEP) and watershed management plans that we did in Mobile County. Lastly, there is the mitigation of effect from the Outer Continental Shelf (OCS) activities through the funding of onshore infrastructure projects such as the many things that accommodate the oil rigs out in the gulf. Some of the ongoing projects that the Commission has already approved for the use of these funds include the conservation land management of two hundred forty thousand dollars (\$240,000.00) per year related to the conservation goals on properties that were purchased through the Coastal Impact Assistance Program (CIAP). Those goals include doing prescribed burns to control invasive vegetative species, and some other issues surrounding security of the property. The storm surge monitors that we watched closely during Hurricane Nate, we are receiving funding from the National Oceanic and Atmospheric Administration (NOAA), seventy thousand dollars (\$70,000.00) for the next five (5) years to maintain and operate these storm surge monitors. What is the future plan that we intend with the use of Gulf of Mexico Energy Security Act (GOMESA) funds? Well the first thing we want to do is, the staff will recommend to the Commission a plan to guide the use of the funds. We know we need to be consistent with Coastal Impact Assistance Program (CIAP) that authorized uses are consistent with that program, and we must administer it the same way. We will maintain compliance with the Federal Procurement Rule, 2 CFR 200. There are some recommended environmental priorities that we know the Commission has and one of which is stormwater. The quality of all the rain we see every year is definitely a priority and since we are a coastal county, the protection of the coast is a priority, so we will recommend those types of projects that will protect the coast, habitat, and fishery associated with it. There is an unlimited opportunity for

environmental restoration projects that we will recommend as a priority. So these will be some of the things that will guide the planning process and address those priorities of the Commission. Commissioners, if y'all want me to address any questions, I have Eddie Kerr and Tina Sanchez with me today to help me answer them.

**Commission President Merceria Ludgood:** In the Coastal Impact Assistance Program (CIAP) we had to go to the state for approval on our projects is that still an interim step or can we decide?

**Environmental Services Director Melton:** We will not have to go through that process with the state this time. We will administer and develop the plan at the County level, and that is as far as any permission we will need to seek.

**Commission President Ludgood:** It looks like thirty-four million dollars (\$34,000,000.00) will go to the state, is the state going to spend it in the affected areas, like Mobile and Baldwin Counties?

**Environmental Services Director Melton:** My impression is that it is, however, that is debatable, and it is up to the state.

**Commissioner Jerry L. Carl:** So everyone understands, what is the federal government trying to do now with this money?

**Environmental Services Director Melton:** We have a number of attempts by the President to terminate this fund.

**Commissioner Carl:** Right, and this fund is going to go toward paying the national debt if they get their way.

**Environmental Services Director Melton:** Yes, sir, if the President gets his way we will see this program disappear and used to offset other programs. The risk in the gulf is great, and the needs are great. The fight to keep this funding source locally to assist the coast is also great. We appreciate any effort the Commission does to help us keep this funding locally.

**Commissioner Carl:** Thank you, Bill.

**Commission President Ludgood:** Thank you.

**Commissioner Connie Hudson:** Recently, on the trip that I made to Washington, D.C. to meet with some of the agencies to try to keep this initiative in the forefront with keeping the Gulf of Mexico Energy Security Act (GOMESA) funds coming to the coastal areas; it was my impression in meeting with the Department of Interior, the

Department of Treasury, the Office of Management and Budget that this was not a done deal as far as swooping in and taking this money and putting back into the federal General Fund. I think there is a lot of hope, at least from the conversations I had, we are going to see that money reinstated in the budget or at least a portion of it. I think it is important at this point to keep that conversation open with our Legislature. I know Congressman Byrne has spearheaded an effort on the House side to introduce an amendment that would disallow the funding being taken out of the Gulf of Mexico Energy Security Act (GOMESA) funds and put back into the federal General Budget. I know on the Senate side, our Senator Shelby is working along those same lines. It is not a done deal yet as far as taking that money.

**Commissioner Carl:** Good.

**Commissioner Hudson:** I have good hope and confidence that in April we are going to see some funding. Now it may not meet the cap that Bill was talking about because right now there is not a lot of confidence among these oil companies and the reliability of those leases. I know during the previous Presidential administration some of those leases were voided so until they have confidence there is going to be a long-term lease agreement that they can work out, some of them are hesitant to enter into leases, so I think they are also working along those lines to make those leases permanent. Have you heard any more on that Bill?

**Environmental Services Director Melton:** Yes, Commissioner, we are following Louisiana who is out in front with some of those issues with the Gulf of Mexico Energy Security Act (GOMESA) funds, and they are anticipating about half of the revenue.

**Commissioner Hudson:** Half of what was projected?

**Environmental Services Director Melton:** That is right.

**Commissioner Hudson:** If that is true for us, if Mobile County was projected to receive six million dollars (\$6,000,000.00) then it will be along the line of three million dollars (\$3,000,000.00) in April.

**Environmental Services Director Melton:** Yes, ma'am.

**Commissioner Hudson:** Okay, thank you very much.

**Environmental Services Director Melton:** Thank you.

**Commission President Ludgood:** I hope you are right, Commissioner.

**Commissioner Hudson:** I hope so too, we need it. It is critical to our area; we have the most rainfall of any of the lower forty-eight (48) states in our area. We can get 67 inches to 81 inches per year of rainfall and then the number of storms we get, the tropical storms, hurricanes and how it affects our area. That money is critical to help us to be able to plan and be prepared for hurricanes and stormwater management. It would be a terrible shame if we were to lose that money and not be able to continue with the planning we have done so far.

**Commissioner President Ludgood:** Thank you Bill and your staff.

In the event she determines that it is desirable to do so in order to obtain favorable interest rates with respect to the Warrants, the President of the County Commission is hereby authorized to execute a Warrant Purchase Agreement between the County and Raymond James & Associates, Inc. and Piper Jaffray & Co. with respect to the sale of the Warrants, which Warrant Purchase Agreement shall be expressly made subject, however, to final approval by the Commission of an Authorizing Resolution with respect to the Warrants approving the principal maturity amounts, interest rates and other terms thereof.
