### MOBILE COUNTY COMMUNICATIONS DISTRICT

Act 84-369 of the Alabama Legislature, Regular Session approved May 17, 1984

#### Established:

Act 84-369 of the Alabama Legislature authorizes the County Commission of each county to create a countywide emergency management communication district. Mobile County Commission adopted a resolution to create a communications district at its meeting on July 9, 1984.

## Purpose:

The Board of Commissioners of the Communications District shall, when appointed by the Mobile County Commission, have all authority and powers set out in the said Act 84-369, including but not limited to the powers to sue and be sued, to incur and issue bonds when so authorized by vote of the majority of the persons voting within the district in accordance with the law, levy an emergency telephone service charge, appoint its officers, employ employees, experts and consultants, and to do all things necessary or incident thereto. (Ordinance adopted July 9, 1984)

#### Members:

The Mobile County Commission reserves the right to appoint members of the communications district. Seven members serve on the Board of Commissioners.

#### Term:

Four (4) years.
