Main Frame: All welded heavy structural steel.

Overall Width for Transport: 85-100 inches.

Inside Turning Radius: Under 13.5 feet.

Brakes: Hydraulic Brakes on all four wheels with front disc brakes

Mid Mounted Broom:

Broom shall have a water spray system with 150 gallon water poly water tank
