All bidders shall furnish a five percent (5%) bid bond on any contract exceeding \$30,000: provided that bonding is available for services, equipment or materials. Bid bond will be accepted in the form of a certified check, cashier's check, postal money order, etc.

Out-of-state corporations shall furnish a Certificate of Authority to transact business in the State of Alabama. Out-of-state limited liability companies shall furnish proof of registration to transact business in this state. Alabama law requires that a successful bidder, if it has employees in the State of Alabama, provide proof of enrollment in E-Verify prior to the award of a contract. (See enclosed notice which must be completed, signed and returned with your bid.)

If applicable to a contract resulting from this invitation, the successful bidder must comply with the Contractor Felony Investigation Policy, available in the Purchasing Department or at mobilecountyal.gov.

This inquiry is to establish a price and a source of supply for the above-listed items by the Mobile County Commission and the incorporated areas therein. Purchases by political subdivisions are optional with those agencies.

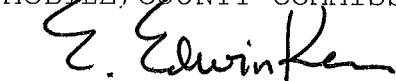

1. GENERAL

Materials shall conform to Section 825 of the *Alabama Department of Transportation Standard Specifications for Highway Construction, 2026 Edition*.

ALDOT 825-B, ASTM C1557 MAX DRY DENSITY NOT TO EXCEED 132 LBS/CF

All fine and coarse aggregate furnished shall come from an approved producer who is participating in and meeting the requirements of BMTP-249, Procedure for Acceptance of Coarse and Fine Aggregates. The producer's name shall be listed in the Alabama Department of Transportation's *Materials, Sources, and Devices with Special Acceptance Requirements Manual*, List I-1. The Alabama Department of Transportation has established a list of qualified producers of fine and coarse aggregates. Refer to Sub article 106.01(f) and BMTP-355 concerning this list in the Alabama Department of Transportation Standard Specifications for Highway Construction, 2026 Edition, and the Alabama Department of Transportation Testing Manual, *respectively*.

Prices to remain firm from the date of award through September 30, 2027.

2. PAYMENT

Payment will be made monthly. Invoices shall be submitted to the Mobile County Road and Bridge Department, 7511 Howell's Ferry Rd., Mobile, AL 36618.

A separate invoice will be submitted for each type of material supplied to the County.

Each invoice shall indicate the inclusive dates of the period covered by the invoice and shall include the following attachments:

1. Signed dray tickets for each load of material supplied, arranged in chronological order, and
2. Certification of Conformity with *Alabama Department of Transportation Standard Specifications for Highway Construction, 2022 Edition*.

3. RESPONSIBLE PARTY AS REPRESENTATIVE OF SUPPLIER

Upon notice of award, each supplier shall provide written notice to the County Engineer of the party responsible and at least one alternate as the person to contact for placement of orders and for settlement of disputes.
