Sealed Bids for the construction of the **Northwest Satsuma Water and Sewer Project** will be received by **Mobile County** at their offices located on the 8<sup>th</sup> Floor of the South Tower at **205 Government Street, Mobile, AL 36644**, until 10:00 AM CDT on Wednesday, May 31, 2023, at which time the Bids received will be **publicly** opened and read. The One Hundred Eighty (180) calendar day Project consists of Water and Sewer Expansion work that includes:

- 1. Two (2) Interstate 65 crossings for a 10" watermain and a 6" sewer force main,
- 2. Approximately 11,000 feet of 8" and 6" water main, 22 fire hydrants and all appurtenances for the water system expansion
- 3. Two (2) wastewater pumping stations,
- 4. Approximately 4,500 feet of 8" gravity sewer, 14 manholes, 2,500 feet of 6" and 4" force main, laterals and all appurtenances for the sewer system expansion.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis as indicated in the Bid Form.
