Title 33 NAVIGATION AND WATERCOURSES

Established (Section 33-1-1)

The State of Alabama may engage in, through the agency of the Alabama State Port Authority provided and designated by law, works of internal improvement and promoting, developing, constructing, maintaining, and operating all harbors, seaports, or riverports within the state or its jurisdiction. (Acts 1955, No. 367, p. 887; Acts 1971, 1st Executive Session No. 57, p. 95)

Purpose (Section 33-1-1)

The port authority shall promote, supervise, control, manage, and direct the state docks and all other lands included within the jurisdiction. The port authority shall be constituted, and maintain and operate all the improvements and facilities. (Acts 1955, No. 103, p 345, Section 1; Act 2000-598, p. 1199, Section 2)

Board of Directors (Section 33-1-8)

The port authority is governed by a board of directors consisting of eight (8) appointed members and one (1) ex officio members. The Governor appoints eight (8) members who are subject to confirmation by the Senate.

The eight (8) members appointed by the Governor terms are for five (5) years.

Ex officio member: the President of the County Commission and City of Mobile Mayor serve one (1) year, rotating annually.
