All bidders shall furnish a five percent (5%) bid bond on any contract exceeding \$15,000.00: provided that bonding is available for services, equipment or materials. Bid bond will be accepted in the form of a certified check, cashier's check, or postal money order, etc.

Out of State Corporations shall furnish a Certificate of Authority to transact business in the State of Alabama. Out of State limited liability companies shall furnish proof of registration to transact business in this state. Alabama law requires that a successful bidder, if it has employees in the State of Alabama, provide proof of enrollment in E-Verify prior to the award of a contract. (See enclosed notice which must be completed, signed and returned with your bid.)

SECURITY GUARD SPECIFICATIONS  
GENERAL REQUIREMENTS**

1. Successful bidder must furnish proof of Liability Insurance in the amount of one hundred thousand dollars (\$100,000.00), (one (1) certificate) to cover all locations and name Mobile County Commission as an additionally insured party. The successful bidder hereby agrees, by accepting this contract, to indemnify and hold harmless the Mobile County Commission, and its employees from liability, damage, claims, suits or actions of every name and description and any expenses incurred in connection herewith for or on account of any injuries damages to persons or property arising from or growing out of Service's operations under this agreement. Service shall further be liable to the County for any damage to property of the County arising from acts or omissions on the part of Service, its officers, agents, servants or employees.
2. Successful bidder must furnish proof of Workmen's Compensation Insurance.
3. Background check and drug test results should be available by the awarded bidder for Mobile County to review for each guard that is working at the various Mobile County Park locations upon request.
4. The guard will make hourly rounds of the facility to include but not limited to the parking lot (front, back, side), areas where employees and customers are parked and submit daily written reports to the facility supervisor. (Report form supplied by Guard Service can be either emailed to facility supervisor or a hard copy can be given).
5. Successful bidder will have a supervisor or owner make frequent inspections of the guard(s) on duty and meet quarterly with the facility supervisor or when requested by the department if a problem exist. **A written summation of the quarterly meeting with the department is to be emailed to the designated department head or representative within 48 hours of each meeting.**
6. An electronic tour system capable of real time tracking of guards while on duty shall be utilized and tour reports emailed to department heads at the end of each shift. **(system supplied by guard service)**. Incident reports shall be submitted to the park department head via email within 24 hours of occurrence.

7. All security guards shall be in uniform and shall utilize a car marked "Security" with security lighting.
8. **Chickasabogue Park, 760 Aldock Road**-Guard service will be provided from 7:00 p.m. to 7:00 a.m., seven days/week and on all County holidays. Guards will NOT HANDLE MONEY. **Guards must make rounds but are not allowed to drive County Vehicles. This site is temporarily closed for renovations.**
9. **West Mobile County Park, 2275 Leroy Stevens Road**-Guard service will be provided from 4:00 p.m. until 6:00 a.m. Monday-Friday, 24 hour coverage on Saturday and Sunday, and on all County holidays as requested. **Guards must make rounds but are not allowed to drive County Vehicles.**
10. **River Delta - 2350 Dead Lake Marina Road, Creola, AL** -Guard service will be provided from 4:00 p.m. until 6:00 a.m., seven days/week and on all County holidays. Guards will NOT HANDLE MONEY. **Guards must make rounds but are not allowed to drive County Vehicles.**
11. **Bay Front Park, Dauphin Island** -Guard service will be provided from 7:00 p.m. until 7:00 a.m., seven days a week and on all County holidays. **Guards must make rounds but are not allowed to drive County Vehicles.**
12. **Escatawpa Hollow 15551 Moffett Road Wilmer, Al** - Guard service will be provided from 5:30 p.m. until 7:30 a.m., seven days a week and on all County holidays. **Guards must make rounds but are not allowed to drive County Vehicles.**
13. **Cedar Point 18250 Dauphin Island Pkwy** - Guard service will be provided from 5:00 p.m. until 7:0 a.m., seven days a week and on all County holidays. **Guards must make rounds but are not allowed to drive County Vehicles.**
14. Mobile County can add and delete sites, and number of guards as needed @ bid price, with written notice.
15. Guard (s) should not leave premises during appointed shift unless properly relieved and notice provided to Mobile County Parks location supervisor.
16. Successful bidder will be notified in writing of any problems pertaining to the performance of the guard service specifications. This notification will be written by the person in charge of the location specified in the contract. (All written notifications must be copied to Mobile County Purchasing Department). Corrections are to be made by the successful bidder within two weeks.
17. **If at any time the awarded bidder fails to fulfill or abide by any of the specifications or conditions herein specified, Mobile County Commission reserves the right to cancel its' agreement.**
