All bidders shall furnish a five percent (5%) bid bond on any contract exceeding \$30,000.00: provided that bonding is available for services, equipment or materials. Bid bond will be accepted in the form of a certified check, cashier's check, or postal money order, etc.

Out of State Corporations shall furnish a Certificate of Authority to transact business in the State of Alabama. Out of State limited liability companies shall furnish proof of registration to transact business in this state. Alabama law requires that a successful bidder, if it has employees in the State of Alabama, provide proof of enrollment in E-Verify prior to the award of a contract. ## Specification for Solar Powered LED Flashing Beacon Warning Systems and Related Components

### General Overview:

The following are specifications for pre-assembled solar powered, flashing LED beacon systems.

- A. Assembly 1 - should consist of an 8 foot pole, a control box, a solar panel, all mounting bracket(s) and an LED light system. The intent of this specification is for a complete unit including all elements required for an operational installation and ready to be installed. The assembly shall be augmented to protect it from vandalism or theft.
- B. Assembly 2 - shall consist of a unitized control box, solar panel, single 12" RED LED light system with mounting brackets for attachment to U-channel pole. The intent is for a complete unit including all elements required for an operational installation and ready to be installed on existing traffic sign U-channel pole. The assembly shall be augmented to protect it from vandalism or theft.

All items on the bid must meet The Manual on Uniform Traffic Control Devices (MUTCD) minimum requirements and ITE lumen output.

### This is an all or none bid.

#### Solar Panel Module and battery power assembly:

This power assembly shall be sized for

Mobile, Alabama,

12V, LED beacons, flashing 50/60 per minute

Solid-state charge/flasher controller continuously operating, with temperature compensation,

Battery back-up capable of operating continuously for 5 days without any sun light,

Load demands shall be either full time with 1 or 2X12" LED beacons or school schedule ( 2 hours, 2X day, 5 days on & 2 days off) w/ 2- 8" LED beacons as listed below in the itemized list. Auto dimming feature is to be built-in to reduce power usage during overcast conditions and nighttime usage.

Battery shall be equipped with low voltage auto-disconnect, be spill proof, maintenance free, and long life deep-cycle.

The panel shall be mounted to the top of the pole in such a manner to allow the direction of the solar panel to be adjusted, 0-90 vertical and 0-360 horizontal. The panel shall be warranted for a minimum of 10 years.

A sizing report must accompany bid certifying capacity to meet the criteria and purpose of this bid for each different configuration listed.

**LED Flasher Assembly:**

The LED flasher assembly shall consist of a solid state electronic flasher unit capable of 50/60 flashes per minute and 1 or 2 - 12 or 8 inch LED lights in either red or amber as listed. The LED light shall also be supplied with a lens cap visor.

**Controls:**

Varying configurations included in this bid shall be capable of being controlled manually,

Manual Operation: Capable of continuous operation by simply hooking up all the components of the system and turning on with an on/off switch

Controls shall be protected with a lightening arrester sized for 18,000 amps for 10 milliseconds and a circuit breaker.

**Wiring:**

All exterior wiring shall be encased in flexible conduit. School zone - double 8" ambers- assembly shall allow for 48 inch sign between beacons. (Signs will not be included in bid but will be provided by Mobile County Commission/owner)

**Enclosure:**

Controls, batteries, and other electronics shall be enclosed in as compact as possible box sized as necessary, be of mill finished aluminum construction with police lock, screened, Vent door stop, integral pole mounts and pre-wired with a color coded wiring harness for no hassle installation. In addition for Assembly 1- "School Zone" flashing beacons warning system, be NEMA 4 certified.

**Pole:**

Hot dipped galvanized U-Channel, 2 lbs. /ft. X 8 ft. section, permanently fitted for adjustable mounting bracket; allowing for adjustment of separation between box/beacon and beacon to accommodate sign placement and addition of channel for raising total assembly.

**Pricing:**

Pricing of the complete units or separate replacement parts shall be firm for the life of the contract. The contract term shall be from October 1, 2025 through September 30, 2026.
