ADVERTISEMENT FOR BIDS

Sealed bids will be received by the County Commission, in the Mobile Government Plaza, Alabama, Eighth Floor South Tower, Mobile, AL, until **10:00 A.M. on Wednesday, the <u>12th</u> of <u>July</u>, 2023**, and then publicly opened for furnishing all labor and materials, and performing all work required by Mobile County and described as follows:

Project: <u>Bayfront Park Restoration and Improvements: Building and Site</u>

Project No.: NRDA-17-004A

Project Summary: Mobile County engaged Mott MacDonald to develop final construction plans and provide construction oversight for the renovations and improvements to Bayfront Park in Coden, AL. The project entails the construction of a 3,100 SF office facility, a 800 SF bayfront observation pavilion, playground equipment, raised walkways and ramps, concrete sidewalks, gravel parking, and asphalt paving. Utilities and other minor improvements will also be included to support this development, including site lighting, multiple shade structures, and landscaping. The new building shall be per 2018 IBC and the 2010 ADA Standards for Accessible Design, and the building systems (HVAC, Plumbing and Electrical) shall meet the 2017 NEC/NFPA 70 Energy code standards. Site work shall be performed in accordance with ALDOT Standard Specifications for Highway Construction, current edition, non-metric.

Three hundred and sixty (365) calendar days are allowed for the construction of the project.

All bids must be on blank forms provided in the Specifications and submitted in its entirety. A cashier's check drawn on an Alabama bank or a Bidder's Bond, payable to Mobile County, Alabama, for an amount not less than five percent (5%) of the amount bid, but no more than ten thousand dollars (\$10,000), shall be filed with the proposal, the Bidder's Bond being prepared on the form specified and signed by a bonding company authorized to do business in the State of Alabama.

A Performance Bond in the form and terms approved by the County in an amount not less than the contract price will be required at the signing of the contract. A labor and materials bond in form and terms approved by the County in an amount not less than the contract price, insuring payment for all labor and materials, shall also be required at the signing of the contract. In addition, the Contractor must furnish to the County at the time of the signing of the contract a certificate of insurance coverage as provided in the specifications. The right is reserved to reject any and/or all bids and to waive informalities and to furnish any item of material or work to change the amount of said Contract.

Liquidated damages for non-completion of the work within the time limit agreed upon will be assessed in accordance with the terms of the Contract.

Specifications are on file and may be seen at the office of the Facilities Design and Construction Engineering, 7th Floor West, South Tower, Government Plaza, 205 Government Street, Mobile Alabama and at the offices of **Mott MacDonald Architects, Inc.**, 107 Saint Francis Street, Suite 2900, Mobile, Alabama 36602. Specifications may be obtained at the office of Mott MacDonald Architects Inc. by depositing **One Hundred (\$100.00)** dollars for each set. This deposit shall be refunded in full to each prime Contractor Bidder upon return of the

documents in reusable condition within ten (10) days after Bid Opening for up to two (2) sets. The cost of and return of additional sets of Specifications shall be in accordance with Section 39-2-3 in the code of Alabama 1975. No specifications will be issued to contractors later than twenty-four (24) hours prior to the time indicated above for receiving bids.

All prospective bidders shall have a representative present at a <u>mandatory</u> Pre-bid Conference that will be held **on Tuesday, the 27th of June 2023 at 9:00 a.m.**, on site, at15961 Dauphin Island Pkwy, Coden, AL 36523. All contractors not having a representative at this meeting will be disqualified from bidding on this project.

No bids will be considered unless the bidder, whether resident or non-resident of Alabama, is properly licensed and qualified to submit a proposal for this construction in accordance with all applicable laws of the State of Alabama. This shall include evidence of holding a current license from the State Licensing Board for General Contractors, Montgomery, Alabama, as required by Chapter 8 of Title 34, of the Code of Alabama, 1975. In addition, non-residents of the State, if a corporation, shall show evidence of having qualified with the Secretary of State to do business in the State of Alabama.

Prior to the award of a competitively bid contract to a contractor having one or more employees in the state of Alabama, Alabama law requires that the contractor provide the county proof of enrollment in E-Verify (see www.uscis.gov/everify).

If applicable to a contract resulting from this bid invitation, the successful bidder must comply with the Mobile County Contractor Felony Investigation, available in the Engineering Department, or online at www.mobilecountypublicworks.net.

No bid shall be withdrawn for a period of thirty (30) days subsequent to the opening of bids without the consent of the County Commission of Mobile County,
