## **MOBILE COUNTY PUBLIC WORKS**

Information required for obtaining a building permit in Mobile County:

- **1.** One set of Code compliant building plans.
- **2.** Diagram of property to show: existing structure(s), addition(s), where will be on property. Distance approximated from structure(s) and property lines.
- **3**. If building a new structure or dwelling which will be on septic tank system, an approval from the Mobile County Health Department (251-634-9801) (perk number or proof of installation). If connecting to a public system, a lateral number from Mobile County Health Department is required.
- **4.** If adding bedrooms or RVs and the dwelling is on a septic tank system, an approval from Mobile County Health Department (251-634-9801) is required.
- 5. An information sheet required at the time of plan submittal to include the following:
  - a. Name of owner, mailing address, phone number, cell phone number, and email address,
- **b.** Name of Contractor: please provide the same information as noted above but add copy of General Contractor's License/County Business License/Homebuilders License/Electrical License/Plumbing License/Mechanical License.
- **c.** Designer/Preparer/Professional in responsible charge-Architect/Engineer: please provide the same information as above.
- **6.** Please provide a Deed of property if address cannot be verified.
- **7.** If property is found to be in a Flood Zone, please provide a current Flood Elevation Certificate or a Waiver by the Mobile County Flood Plain Administrator.
- **8.** Please allow 5-10 working days for plan review of both Residential and Commercial projects.
- 9. All commercial plan reviews require a \$100.00 plan review fee due at time of submittal.
- **10.** Com-Checks are required for all commercial projects and must be signed and sealed by the "professional in responsible charge": Electrical: for interior and exterior lighting. Mechanical: for building envelope and energy.
- 11. Plans under review will be permitted after approval of plans.
- **12.** Permit fees are "All Inclusive" for new structures (building, electrical, energy, mechanical, plumbing), and are based on the total contract cost (materials & labor). Only when a certain particular craft is to perform work will permit be given for that craft only, for example: a HVAC change out or Electrical repair.
