

**MOBILE COUNTY BOARD OF HUMAN RESOURCES**

Section 38-2-7 of the Public Welfare Laws  
of the State of Alabama, Code of Alabama 1975

**Purpose**

The primary purpose of the Mobile County Board of Human Resources is to serve as a bridge among the county director of human resources, the community, and the state department of human resources, specifically:

- Identifying unmet needs: They meet with the county director to pinpoint areas where the community requires additional support in human services and welfare programs.
- Advising on economic conditions: They offer insight into how economic conditions in the county may affect the welfare program and its delivery.
- Informing the public: They help raise awareness among county citizens about the various public welfare programs available to them.
- Promoting community collaboration: They work with other agencies, individuals, and organizations to develop facilities and programs that benefit the community and enhance human betterment.
- Recommending improvements: They provide recommendations for enhancing the effectiveness and efficiency of the county's public welfare program.

**Membership**

- Seven members, with at least two being women.
- Members are selected by the county commission as a whole governing body (the board sends each county commissioner its recommendation, along with the candidate's certified eligibility statement).
- In counties with cities that have a population of 60,000 or more, the city governing body has equal authority with the county commission in selecting members
- Certain individuals are prohibited from serving, including those holding or running for elective public office, employees of the county department of human resources, and their close relatives.
