**Established:**

The Mobile County Commission adopted a resolution at its meeting on March 27, 2000, that granted permission and authority for the Mobile County Industrial Development Authority to reincorporate the corporation.

**Purpose:**

Section 11-20-30, et. seq., Code of Alabama 1975, provides for the creation of a public corporation to acquire, enlarge, improve, replace, own, lease, and dispose of property to the end that such corporations may be able to promote the industry, develop trade and further the use of the agricultural products and natural and human resources of the State of Alabama, and the County of Mobile, and to the development and preservation of said resources, and to vest such public corporations with all powers that may be necessary to enable them to accomplish such purpose.

**Board Members:**

Three (3) directors shall serve on the Board. Members must be qualified electors, taxpayers, and residents of Mobile County, Alabama, and shall be appointed by the Commission. No director shall be an officer or employee of Mobile County.

**Length of Term:**

Each director shall be appointed for a term of six (6) years or until his successor is appointed. The members' terms are staggered.
