Bylaws of September 14, 2020

**Established:**

The Mobile County Commission adopted a resolution at its September 25, 2023, meeting to change the name to Mobile County Sportsplex Advisory Council.

The Mobile County Commission adopted a resolution at its September 14, 2020, meeting establishing the Mobile County Soccer Complex Advisory Council.

**Purpose:**

The Advisory Council advises and guides the Mobile County Commission regarding the use, maintenance, and continued development of the Mobile County Soccer Complex, located at 3701 Halls Mill Road in Mobile, Alabama.

**Board Appointments:**

Membership of the Advisory Council shall consist of seven (7) members selected from the electors of Mobile County, Alabama, until an amendment changes such number to the Bylaws. The Executive Director of the Mobile Sports Authority, Inc. serves as an ex officio member of the Advisory Council.

Members are selected to provide a broadly representative cross-section of community and sporting activity within Mobile County, with preference placed on individuals having connections to the sport of soccer. New members may be recommended to fill vacancies by any Mobile County resident. Each member, or a slate of members, shall be appointed by a majority vote of the Mobile County Commission.

**Term:**

Members of the Advisory Council shall serve for a term of two (2) years and may be reappointed for additional terms.
